# Government-Emergence of Masterism in Governance; PL Origin; Citizen Separation Emergence of Master-Slave Governance

Note: This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system in the world'. Any explanation in this 'coinciding with any working Government system' shall be an unintentional coincidence only.

National surveillance of resources- NSRP; VENAM-Vanity exploiting nation's money; MGGO-MGG in authority mode; MGGM-MGG in master's mode; PL1-Public leader; PLOF-Government, predominantly political leader and MGGO alliance; SSC-Selfish and stronger Citizen group; MADD-Master's designed democracy;

## This chapter would help to understand that:

- 1. Government required for optimal use of Nation's resources, minimizing wastage, keeping harmony amongst various fragmented groups of people and planning to keep a balance between the resources and the people
- 2. There are two different and opposite behaviors of a government, to be a 'Master' (making the citizen slave) or 'serving citizen' (becoming slave of citizen)
- 3. The Government is entity representing the decisions and desires of Government people, thus these are same
- 4. Government should
  - i. Have higher level of thinking thus intelligence, enabling them to 'plan and visualize'
    - ii. Evidence that they are honest, just, transparent and impartial
  - iii. Not attach themselves to nation's resources for own benefits
- 5. MGG provides citizen interface. MGG has two faces thus, One is to provide services to the citizen and other one is exercising Government's powers to make them 'super and special'. Both faces are just in contrast, opposite and contrary. So MGG outlook is most important
- 6. Any human is selfish, thus MGG shall be in 'authority mode' if not specifically controlled by 'government's will' to transform it into 'service mode'.
- 7. The term MGG would signify a pro-citizen mode and 'officer-MGGO' in 'non-citizen mode'
- 8. HOG/MOG, PON and MGG are three important constituents of 'governance'.
- If the government does not concentrate to strengthen, unify and make it flawless, the communication between government and the people may be scattered, multidirectional and not result oriented
- 10. There should be 'direct and effective' communication between Government and Citizen and the nature of communication should be direct, mutual, uniform/continuous, both ways with uniform conductance. Deficient communication is significant factor to transform the government into a 'Master'
- 11. PL1 are Public Leaders emerges because of weak Government-citizen communication and becomes another actor in governance. If PL1 is continuing, there is weak communication between Government and citizen and also MGG is in authority mode.
- 12. The government 'data base'/public domain for citizen communication must be open and accessible by citizen without any obstruction. The procedures and processing stages defined against time-line should also be accessible as above
- 13. Existence of, 'political party and political people' have strong incentive to 'break' the Government-Citizen direct and effective communication, may transforms government into a 'Master'
- 14. this communication between MGG/officers and PL1 would become prominent decision channel and the people gradually are bypassed once the PL1 gets installed

- 15. The behavior of MGG group in Government 'solely' decides if the Government would be 'serving citizen' or a 'Master' as they provide citizen interface
- 16. The 'strength of monitoring' status of ICE would decide to a great extent if the democracy is genuine.
- 17. The factors supporting Democracy producing masters are:
  - (i) Weak direct communication between government and citizen
  - (ii) Weak Rules and procedures
  - (iii) Government not notifying rules and procedures on public domain making freely available and known
  - (iv) Keeping discretionary powers in rules and procedures
  - (v) Low citizen CEAK and government enhancing it
  - (vi) Low government intelligence level

A country is a large group of millions of people and with enormous land resources. Land is made to house the people and to provide them the livelihood through its resources. The dependence of people on the nation's resources creates a situation where the whole lot of people gets fragmented for the choice of resources as per their needs and if the resources are less than the people's need, they would develop inclination to grab the resources.

If the resources are enough for the people, then the tendency to grab individually is not prominent however, the deficiency of resources for each individual makes it a prominent behavior causing citizen unrest. <u>Let we call it 'citizen unrest factor'</u>. But their ability to grab the resources is decided by the other body viz. 'Government'.

### Why Government required:

The Government is entity representing the decisions and desires of Government people, thus these are same. To streamline the use of nations resources for the people with a discipline of optimization of use, minimizing wastage, keeping harmony amongst various fragmented groups of people and planning to keep a balance between the resources and the people to keep citizen unrest factor low, a separate group of people is needed which should have influence and control over the masses of people and an higher level of thinking (refer to government intelligence model and decision making profile model) to optimize balance between the two. However, the most important is that the Government have:

- 1. they have trust of the people
- 2. they have much higher level of thinking thus intelligence, enabling them to 'plan and visualize'
- 3. they are honest, just, transparent and impartial
- 4. they do not attach themselves to nation's resources for own benefits
- 5. represent to the people/ citizen as the most genuine caretaker of nation's resources and maintain the balance between citizen's size and availability of resources
- 6. Their decisions are 'uniform and impartial'.

These criteria therefore, are the prerequisites for a government (GPP) and are essential for people of the nation to go with GPP's decisions and these two work in harmony. \_

So the Government would provide surveillance over nation's resources from citizen side. Let we call **Government group in this mode as 'National surveillance of resources' NSRP for people.** 'Since surveillance provides authority also, which can be misused, the punishment should be more aggressive for Government people for misuse and misappropriation for their own benefit.

In order to both constituents of Governance 'GPP and Citizen' work in harmony, similar prerequisites for the citizen/ people group would be:

(i) they have uniform thinking and opinion

- (ii) they use the resources judicially and efficiently
- (iii) keep vigil on Government actions

# Government and Citizen Harmony; GPP, MGG, Citizen Groups

The most important point for true performance of this system is the belief of the people of the Nation (PON) that the Government people' are 'nation's representative' to them and not another citizen mastering over them. It is very important to note that NSRP is the origin of this belief and therefore, the behavior of Government people would enable the citizen to have such belief. Ideally these two groups, if in perfect harmony can manage well. In kingdoms, the NSRP represented by one man and in other democratic systems this is a large group consisting of government and administration who are named as 'Managers of Government's governance (MGG).

The Government systems have been working for many many years in this world. These have evolved after experiencing the working of Governments over centuries. The nation therefore, has a Government and Citizen. However, Citizen group is much larger and scattered over a large land area. The Government is a small group comparatively. Thus to interface with the citizen, the Government would need a support group, larger to the Government itself but smaller than the citizen group. This group would interface with citizen on behalf of the government, thus termed as 'Manager's of Government's Governance MGG'. These are called 'Administrative officers' in many countries. The term 'officer' designate them a special and higher status than citizen as they carry the government powers. Thus they are the 'authorities' to dissipate Government powers.

The MGG has two faces thus. One is to provide services to the citizen and other one is exercising Government's powers to make them 'super and special'. Both faces are just in contrast, opposite and contrary. It is thus very important to evaluate that the MGG are in 'service mode' or 'authority mode'. This has been detailed in other chapter. As in natural course, any human is selfish, thus MGG shall be in 'authority mode' if not specifically controlled by 'government's will' to transform it into 'service mode'.

Also a system has also evolved during this long period that Government consists of people elected from the people of the nation through a procedure normally called 'Election'.

The Government would consist of primarily the 'politicians' designated as 'Government' and the 'Administrative Officers' MGG governing 'direct administration' on citizens on behalf of the 'government'. However, the term 'officer' is most commonly used representing them as a group exercising administration in a country which would elaborate the fact that they are separate and away from the people, contrary to the term 'MGG'. Thus the term MGG would signify a pro-citizen mode and 'officer' in 'non-citizen mode' The use of the term 'administrative' also would assign a status signifying them as 'independent' and having provided an authority to control the people, as per regulations but normally the way they want if monitoring slacken. The MGG would function as 'Manager'. Under harmonious conditions, when the resources are in plenty and there is no tendency amongst citizen to 'grab' others share, monitoring the citizen on behalf of government. However, if the resources are less, the citizen may show unrest to grab the share of others to sustain their lives. Under such conditions, the MGG would use 'government authority' to control such citizen and such tendency.

The Government has people, thus termed as 'Members of Government-MOG'

Therefore, MOG, PON and MGG are three important constituents of 'governance'.

Let we define different forms of MGG group from Citizen point of view as below:

(i) MGG: Working in the interest of nation and citizen with correct guidance to government (MOG) and ensuring growth and good quality of life to PON

- (ii) MGGO-In administrative authority mode exercising primarily authority. Working in isolation from citizen, getting attached to the nation's resources for self benefit with self driven guidance to MOG. For uniformity with term MGG, let it be termed as MGGO (MGG turned as Administrator-Officer)
- (iii)MGGM- In Master Slave governance model, they join government people in Master mode, deliberately ignoring the progress and happiness of citizen. For uniformity with term MGG, let it be termed as MGGM (MGG turned as Master)

Citizen group is comparatively a much larger group with disparities in nature in respect of mutual behavior, practices, psychologies, perceptions, approaches interests and thus need to be guided and moved by the Government. The Government has to manage control and utilization of nation's resources for optimal results and keeping harmony and satisfaction amongst the citizen. They should manage the utilization of resources by people for the nation keeping themselves only for the managerial function. For this they charge tax from public to sustain themselves. The tax is not the cost of resources being put at the disposal of the people but a recovery for sustaining the 'government functions'. However, if the people are further selling the nation's resources in any form for earnings, another tax may be applicable on the people to return the cost of nations resources. People can return these taxes only if they are earning by selling nation's resources. This analogy has been presented not to explain the economy of a nation, but to understand and develop a model of nation's governance.

#### **Government-Citizen Communication model**

However, the real situation in many countries presents that the public being a very heterogeneous mass widely varying in nature, economics, interests etc. (as explained in social model) is often fragmented because of varying level of mutual trust and understanding on these accounts and varying trust levels for one another under different circumstances. These different groups would tend to exercise pressure on the government for their benefits, irrespective of whether other group is equally benefited or less. The government would be dealing with large sections of people, widely varying in their attributes. Therefore, if the government does not concentrate to strengthen, unify and make it flawless, the communication between government and the people may be scattered, multidirectional and not result oriented. If such a situation would prevail, it would be the choice of both government and the people PON to pick representatives to represent a particular group and assign the responsibilities for working on behalf of the group as an attempt to fill up the communication gap. This would result formation of another group, the Public leaders (PL1), representative of these groups, try to influence the decisions being taken for use of nations resources for the benefit of their group. PL1 are basically the people from citizen group. As PL1 individually represents a particular group, this would tend to benefit its group only. This at once exhibits the selfish behavior of PL1. (let we call it PL1 rule 1). Thus the people group when become heterogeneous, unstable with difference in opinions and interests, results creation of another group PL1. This brings out that more homogeneous the people group is, more disabled the PL1 group will be. (let we call this PL rule-2).

So a PL1, Public leader shall be selfish in behavior and its own strength shall depend upon the strength and unanimity of the corresponding group

More heterogeneous the people groups are, more heterogeneous and unstable the PL1 group is. So PL1 group becomes fourth actor (its not constitutional group so not called constituent of governance) in governance, becoming prominent when the communication between government and citizen lacks. Incidentally the MGG group would also turn into MGGO group under such conditions. As now its not only officers (administrative officers) in the nation's administration but also PL1 group comes into picture. The administrative model may look like Fig.-1




Fig-GN1- Emergence of PL Group

As the communication with the people/ citizen is through the MGG, the 'MGG' shall effectively represent 'Government' in above description.

It is important to note that PL1 is positioned outside the people group as within people's group its identity will get lost and communication with MGG/officers would be through the people resulting it to be distorted and ineffective because of distortions in the people's group. As mentioned above, In such scenario, MGG is separated from citizen and would have acquired the form of Officers MGGO if the communication is weak. PL1, therefore, placed outside the space of people's group but in the same plane for streamlined communication with people.

It is depicted in Fig-GN1 (1a) that Government/ MGG group is much smaller and the public group is much larger, thus surrounding MGG group and the channel of communications is within the public group domain between public and the Government. This should be direct communication and the nature of communication should be direct, mutual, uniform/continuous, both ways with uniform and homogeneous groups of people and Government/MGG. However, with fragmented people group, different groups places 'PL1' above their space and the channel of communication becomes between PL1 and Government/MGG bypassing the people space. This direct communication between PL and Government/MGG bypassing people eventually creates a different plane in the space than the plane of direct communication between people and Government/MGG. Since it suits both to Public Leader (PL1) and the Government/MGG and both being at positions encompassing powers and empowered to take decisions, this communication between MGG/officers and PL1 would become the most prominent decision channel and the people gradually are bypassed once the PL1 has been appointed and fully authorized by people to act on behalf of them.

There are four very important derivatives from the above discussions:

- 1. That PL1 exhibits selfish behavior for its existence
- 2. PL1 will always desire that a direct communication between Government, MGGO as Officers, and the citizen does not exists
- 3. The MGG changes their face from 'citizen service' to 'officers' (authority) mode

4. For its survival and existence, PL1 shall wish that the citizen always has problems which eventually would become the reason for continuing communication with MGGO and thus the survival of PL1

Looking from the other side, it can be understood that if PL1 is existing and continuing, there is weak communication between Government and citizen and also the MGG is in authority mode.

### **Emergence of Political party**

And this eventually becomes basis for the emergence of a 'political party'. The PL1 group subsequently emerges as a 'political party'. In democratic arrangements the people from political party, PL-Political leaders becomes 'the Government'.

So government is basically formed by those who were 'public leaders' PL1. And they got created because of 'inadequate communication' between government and the 'citizen'. So a 'political party' will not establish 'strong and flawless' communication between 'government and citizen' and in democracy the government made of PL therefore will not establish such 'strong and flawless' communication. Whereas, this is basic requirements of democracy. So this happens to be 'most vital' contradiction to be 'addressed and attended' by 'Political party based Government'.

A healthy citizen oriented governance would therefore need (i) people groups to be homogeneous to the extent possible (ii) Government/MGG group has direct continuous communication with people/citizen (iii) a common plane of communication amongst these three constituents (if PL1 exists) with unified interest of citizen welfare.

This model now gradually fades out the identity of nation amongst these three. Different opinion may emerge regarding representation of nation in these three constituents but **horrified** fact may be that neither of these three may now represent 'nation'. Let we understand with elaborations.

\_If 'people' is the nation, then there is no need of other two. If PL is the nation then it would use 'MGGO' to their own interest, whereas 'MGGO' should be dutiful to the people and not to PL. And if MGG/MGGO are the nation, then both public and PL loses existence as they are empowered to take all the decisions. Therefore, it becomes necessary to understand that 'nation' would be defined as an entity sustaining because of the balanced and harmonious efforts of all three constituents.

This shall be discussed separately.

It is important to understand here that PL1, public leader, at a lower level direct interfacing with the people/citizen, is one of them at this level. However, many Government systems at government level approve a decision on consensus basis, that majority of government representatives/ members are in support of it. For realizing this activity it becomes necessary that PL1s together forms a group based upon some common goals. These PL1s would be from different regions, different cultures but joining hands to form a group so that decision making at governments level can be accomplished. Thus the groups so called political party/parties would emerge. And the public leader at this level would become 'Political leader'. A PL1 therefore would be a 'Political Leader' as well. Or PL would normally be a person elevated from PL1 group.

It is also important to note that many Government systems are based upon electing government representatives from the public and these PL1 or PL becomes the first choice for the citizen to elect and get elevated to the 'Member of Government'.

STAGE-2 (GN2):

Let PL1 has been placed by P1 group of people and PL1 will have a direct communication with MGG/officers, because if a direct dialogue between people and MGG/officers was in existence, the need of PL1 would not have arisen. PL1 is placed outside the P1 group of people because (i) if it is in the 'people group' its authority to communicate with 'officer group' will be lost (ii) It would be pulled by each individual people sub-group, to make it questionable, disputed and less powerful. The major change which appears is that PL1 plane of communication with officers is different and would maintain least contact with the people as keeping equal contact with whole PI group people is also cumbersome and painstaking for PL.



Also as the **link between officers and the people now disappear**, people do not know what officers would be doing. **PL1 also would encourage this link to be missing as this would further consolidate its position and its hold onto people**. Even beyond PL1 may like to have a state where people would feel officers as their enemy and their action being against them, a state which would emerge lately.

#### **Emergence of PL-Officer business tie-up:**

Analyzing working of these constituents in terms of democratic values the following description is helpful:

The initial stage is where the government and people both feel responsible to nation's resources. The government (MGG) would work for the people (Joint custodian of nation's resources) and get the benefits only to the extent of their services rendered to the people. The two way dialogue possible between government and people and optimal use of nation resource is possible at minimum cost. In this model the PL1/PL is nonexistent for the people and for government/MGG as its existence is associated with people unrest and disharmony only, when in the previous model, the subgroups in PL1 group have different interests. This also brings out an interesting analogy that once PL1 (becomes PL-Political leader later) comes to an existence, it would not like and permit harmony and unity in the people group. So PL1 interest would be to break the link between the people and government/MGG.

Going further, gradually the officer would realize being at the place of benefit compared to people as they are close to the nation's resources. If they only do the public service, the benefit of resources goes to public which would provide an incentive not to do the 'public service' and not to distribute benefits to the people.

A hierarchy of laws and regulations would therefore be envisaged to discourage this. However, if the laws are made, those would be kept loose ended to reduce their effectiveness to nab them when they selfishly use nation's resources for their own benefit.

The most important happening in this course is the communication between citizen and government/MGG/. Let we define this also. A citizen would approach MGG/Officer regarding some issue or help or decision regarding government procedures, norms etc. The citizens application would go to the data base for processing. The citizen have right to know about it. The application of citizen shall be processed against a time line till decision. The decision shall be communicated by MGG/Officer in standard format. It must be ensured and transpired, certified by MGGO that similar decision has been taken in all similar cases. Thus the government 'data base'/public domain must be open and accessible by citizen without any obstruction. The procedures and processing stages defined against time-line should also be accessible as above.

However, government/MGG would keep option not to fulfill the requirements of this essential course of communication. Therefore, this would never be realized if the procedures do not contain action on MGG/Officer affecting their service prospects in case of an ignorance or defiance by them. Thus the procedures made available to citizen must contain 'action on MGG/Officer affecting their service prospects in case of defiance of the rules, norms, time limits and uniform and consistent decisions in all similar cases.

By optimal use of the resources, the benefit would go direct to people and the people domain would be larger, stronger and potent than PL1/PL domain. This situation would leave PL1 gradually becoming weaker relatively, a state which would not be welcomed by PL1/PL group. They cannot prevent people to use the nation's resources in normal course as, people forms a much-much bigger group. And also the existence of PL group is depends on people group being distorted and weak.

There is great incentive both for PL and MGG/Officer now to slacken citizen-government communication and join hands to selfishly use the nations resources for their benefit. It must be noted that MGG/Officer would also give inconsistent decisions, different for different people, for the similar cases, depending upon the self-benefit realized, but this would also be only due to deriving some benefit selfishly for themselves.

So PL and MGG/officers together (PLOF), would introduce criteria to be followed by citizen/ people for their entitlement for using nation's resources. These criteria will only be applicable to people but decided by the PLOF group which forms an important deviation from the democratic norms. This may be stated as 'administrative rules or norms'. **They would make the procedures tedious and put a cost also**. To give an impression that all are equal in the reign, the norms and procedures would be developed, to be followed equally by all people. It's a part of discipline and necessary to an extent for uniform behavior from the people.

When Officers and PL group would come closer, soon they would realize that they are the custodian of the nation's resources, much closer to it, under the excuse of managing the same, and people are far away. If the benefits generating from 'nation's resources' are shared with people directly, it becomes ineffective especially if the 'people group' is larger in numbers. On the other hand if the benefits are not distributed with people, these provide significant benefits to PLOF as they are still much less compared to people group.

### STAGE-3 (GN3):


The next stage would emerge from PL and the MGGO coming further close, in the form of a group with self orientation and 'benefiting self' approach. The MGGO would tend to make the procedures complex, less transparent and unmanageable, so that people cannot have access to their dues

without coming to the them. On the other hand those who are stronger in the people group would make officers to manipulate these rules and procedures by paying the 'cost of such manipulation'. The rules shall be kept loose and open ended by MGG/Officer to ease out such manipulations. The scope of existence of 'discretionary powers' shall directly imply this. And when this concept consolidates, the PLOF would have people from the citizen group to become a via-media for practicing it. Let we call this group as 'selfish and stronger citizen group' SSC. These are the people who are in contact with PL and officer and are common to both the planes. They are from PON but aligned to PL and government/MGGO for deriving benefits out of this relation. The democracy provides convenience to officers, PL and 'SSC groups to exercise this without getting known to the people, whereas the PON 'weaker people groups' would just get preaching that what is against the procedures and rules is something they should not do.

The PLOF would also need a medium to convert the nation's resources into 'benefits' in the form they need, therefore the buyers of the nation's resources would become a part of this cycle, although they may not necessarily have any direct intention to put the PON on disadvantage. These would be the business/ buyers group. This has also been explained in the 'Vicious circle of undemocracy'. This would distance the people from officer. Consequently the use of resources would get limited to officers, PL and business group alliance and would consequently become representative / agent of the nation's resources.

This results a vicious circle in which the benefits of 'nation's resources' gets cycled to buyers group through PL, officers and selfish citizen group and is explained in chapter 'Vicious circle of undemocracy'.

We have seen that due to fragmented people's groups, the people places PL/PL1 to represent them to government/MGGO and also that PL/PL1 has a different plane, say vertical as depicted in the diagram, of direct dialogue with the officer bypassing the communication plane of the people. This vertical plane has only limited contact with the people and these are the selfish citizen of the people group. This model prevails when most of the people are poor, illiterate, unaware and these people just become nonexistent and the decision regarding **selling/utilization of resources** gets limited to officers, PL and the SSC:



The

continuance of this stage would gradually make the citizen group weaker, leaving sight on what PLOF are doing because of struggling with day-to-day problems for their survival.

This state of Nation's management system (Governance) is most critical as from here the NMS/governance becomes only one way process, the benefit to the PLOF alliance and complete ignorance of people. When the people gets to such a miserable state that they live fighting for their survival makes them to disassociate from PL and officers as they are no more looking up because of losing every hope of their being in a different state than hunger, helplessness, destitute and accept the state as their destiny. This is what PLOF would be looking for.

PLOF would incubate the belief in PON that they are only responsible for their miseries. Some religions, life philosophies are put up to the citizen which supports this.

.....The PL would only use the public for their benefits and MGGO would develop rules to facilitate it to keep people away from the benefits of nation's resources. .

### STAGE4 (GN4):

This becomes the most important turning point in the process of governance and nation's administration/ management. There are now only two groups, PL and MGGO, very powerful and resourceful, having grabbed the rights to exploit 'nation's resources' for their own gains, directly or indirectly, visibly or invisibly, and the other group 'people', pitiful, hungry, fighting for their survival. And this situation though may be classified as 'democracy' just becomes identical to 'Monarch' and the system of 'Master and Slaves'.

And the democratic system coming into this form may be termed as 'Democracy producing Masters' DPM.

These two groups now be called PITI (Poor, illiterate, troubled, ignorant) people, and WAAL (worst alliance of administration and leaders). In a government model which is quite common over the globe, the PL is selected by the people as an one time activity, for a long period, through a process of 'elections' is also a constitutional entity, but human being with common attributes, and represents the government with officers as their associates. If the PITI condition prevails in a country, the above condition and the government would be equivalent to WAAL. It is interesting to note here that PL becoming a constitutional entity would either behave like a 'master' or a 'service provider' depending upon the rules which can prevent its option to become a 'master'. If this firewall is not strong and effective enough, the WAAL would become even more worst as this has all the constitutional powers not only to keep the citizen at bay but also to protect themselves.

Since WAAL is an alliance with government as a constituent, this government may be termed as 'Anti-citizen government'.

The WAAL (emerged from PLOF) would make all means to believe PITI that they are in that state only because of their destiny. Once they are able to program it in PITI's brain, its an easy course for them to exploit 'nation's resources' for their benefits. Anything which influences the human brain superstition, religion, threat, fear, fear for future, no-looking up, mental subordination to someone, etc would be WAAL's tools to keep PITI indifferent from what WAAL does.

The acceptance of this state by people PITI that their destiny being responsible for what they are, makes PLOF/WAAL to be indifferent from them and now move this alliance vertically up in the vertical plane, leaving rest of the people down on the horizontal plane, away and separated without resources, physically close to resources but prevented by rules and regulations by PLOF alliance. Thus becoming more and more poor.

At the next stage of this process, PLOF alliance has moved sufficiently up vertically and away from the horizontal plane of the people.




The alliance now gets connected to the people through narrow shaft containing the people, PLOF agents, providing connection to the PITI masses. PITI becomes far away from resources and just keep looking up for something to fall down to them, without any expectation, so whatever falls down makes them happy. The PLOF alliance game becomes an easy one. **PLOF would propagate some beneficial scheme for the PITI which would spread very fast amongst them, creating fresh hope for better tomorrow, the only factor making them to live, hope of better tomorrow.** 

With common interests the PL slowly comes closer and closer to MGGO and up vertically Subsequent to this, the further changes occur automatically as the PITI are now totally cut off from the process of governance and lose hope of any revival to its hopeless state which it would have accepted as its destiny.

The MGG/officer and PL changes their face from 'citizen welfare' to 'citizen distress'. This would be the changing face of government which is 'anti-citizen government'.

Once the miserable state has been accepted by the people as their destiny, the further transformation would occur in the people group as a chain reaction

After formation of WAAL as explained previously, the changes in the status of PITI further takes place deteriorating their condition as under:



Stages 4A- is that WAAL alliance is formed and the alliance shifts vertically up leaving citizens on the horizontal plane.

Stage 4B: Occurs because of ignorance of the WAAL government/ to citizens who have outlived their purpose and usefulness to the WAAL Alliance, pushed away and only limited people falls under the government now. This stage may reverse temporarily intermittently as the changing face Government would again care for those citizens for a time when they want to make use to them like one such event is election, which however, can be manipulated in many ways if there is a PITI base created already by 'Democracy producing Masters'. The DPM does not mean a political party, but it depicts a system's behavior irrespective of a party. This situation for WAAL government is not bad but not ideal either. The WAAL does not have any incentive to care for these people from whom they have moved away and, therefore, ignore them further making them more helpless, poor and at a state where 'death is better than living', where they only hope for a mercy from WAAL government.

The depiction of this is stage 4C-, when these masses have moved sufficiently away from WAAL Government. The most interesting and noticeable happening here is that the one end of the society is moving up towards the 'anti-citizen government' and as the PITI people moves away down ward, this set of people, 'selfish-strong citizen group', moves up close to the anti-citizen government'. As they become close to the anti-citizen government' and finally establish link with it becomes the prime means of communication between this and PITI. As the selfish- strong people group are from the same society but now becoming a lot deriving benefits from anticitizen government' and becoming the main conduit to transfer any benefit the anti-citizen government' may decide to pass on the PITI people. These are driven with self interests, moving more towards anti-citizen government' and moving away from rest of society, deriving benefits and sharing benefits with anti-citizen government'. This obviously is a behavior which is not prosociety or pro-citizen as the natural intention of this group would be that anti-citizen government' gets more and more away from the citizen and would push the citizens away even forcibly. This lot therefore, gradually would get into an anti-social mindset and for deriving their benefits they would not mind going and becoming more and more anti-citizen. And they are a part of 'anti-citizen government'/WAAL/ MGG/Officer. This is an horrified outcome of 'Master-slave democracy' that once getting into the mindset of a 'master', a government becomes closer to 'anti-socials'/criminals using them as a tool to terrify PITI to work as 'slave-mindset'. Or anti-social/criminals starts getting into the government and governance.

This model would now be the representation of 'Master Slave Governance' as the master higher from horizontal plane-goes up and up and the people on' horizontal plane 'only have option to look up to fall some benefit from the Masters. In this model, the Masters only think about themselves and exploit the slaves. They intend to keep slave as slaves as long as it is possible. This may be an unexpected and unbelievable model of democracy but where majority masses are poor, illiterate, helpless,(low CEAK) this form of democracy automatically gets embodied. The masters action would be to launch more and more schemes, but <u>POP</u> (separately explained), in the name of slaves to see their hopes never die, but also that it does not work for enabling them. The benefits on the other hand dissipates in PLOF .The master will sustain relations with PITI by arising sentiments and the approach can be named as 'game of sentiments' GOS.

This model does not reflect the form of democracy for which the democracy word has been designed and made. This phenomenon therefore should be named 'Master's designed democracy' (MADD) as this is a democracy system designed by the Master and 'For the Master' and does not serve any purpose to the 'Citizen'.

### **Causing permanent separation**

In a master's designed democracy, the powers are exercised through a medium of people who are close to master and dissipate master's ambition and objectives into the people to help the master for achieving its objectives of selfishness without getting noticed by the people. They work as a cover to safeguard image of the master even for the deeds which would do not favour the people. These people are termed as the 'master's friends' TMF, the master's friends, for the discussions. This group would have people from the society, selfish and exacting (termed as Public disabling agents DIA). Such people would have criminal mindset. In fact the changing face leader who would look to support the citizen but working for self-gain in reality, though are operating in master mode, but can not publicly exhibit it, because of international image and pressure and to get favour from the people in elections. And the preference would obviously be to deal with citizens through TMF and DIA only. Thus this TMF+DIA group is given all the powers to control the PITI and rest of the society and gets into the worst mode of masterism to achieve and maximize its gains. This masterism is worst as its actions are hidden and is free from the fear of bad name or bad image, thus act in shameless manner. This lot would be the most unethical, antisocial and free of not even impersonating for being good people. Not being in the Government they behave more openly as being anti-people with no fear or shame if the investigating agencies and justice system are under their control.

The DIA play an important role who are from the PITI people but in contact of the WAAL/PLOF alliance and their important job is to spread hope amongst PITI regarding an action or scheme of the PL or the government. The alliance floats scheme for the PITI to show their existence meaningful and purposeful and making them to live further in hope of better tomorrow, however, if its an scheme of enabling them, like education or bringing equality in the society, like uniformity of civil rights etc. it would evaporate in its journey down from WAAL to the PITI, so that it would never benefit the people. Most of such schemes would be POPO as explained separately. The mischievous schemes like providing loan to poor people for miscellaneous reasons, is propagated as schemes supporting the people. Looking from the other side, these schemes are the disabling schemes.

Providing financial assistance to people, knowing well that the amount is grossly inadequate to permanently uplift their status, even nominally, would have the only purpose of reviving hope in them to live for WAAL. And later on the pay back by the people is waived off to gain popularity the second time. This phenomenon may be called VENAM (Vanity exploiting nation/government money) as the WAAL would normally adopt this approach for gaining popularity amongst PITI. This provides

repeated benefits, first popularity at the time of giving loans and again at the time of waiving off repayment.

Thus the WAAL would create a 'beggar mindset' in people who would lose their confidence gradually to behave like a capable person.
