## **Citizen Forum (CFOR)**

The government of a country shall be working for the common men of the country in general. The government people are normal and common human with all such deficiencies in the behavior and attributes as may be existing with other people, and selfish behavior is most prominent. Though the GPP may be, under all presumptions, working sincerely and honestly with all diligence towards the average citizen of the country, still getting this unique opportunity in whole lifetime with uncertainty of being consistently occupying the position and the powers, would create great incentive for a GPP to behave selfish.

This has also been explained in the section of GPP behavior so not being discussed in details.

Because of various reasons, there are probability that the GPP may behave selfish and distract their approach and actions to fulfill their self-aspirations and objectives rather than doing good to the average citizen. It would necessitate that a powerful and cent percent transparent forum is established by the government, **under the laws**, where the citizen would present their queries, doubts, problems, questions, ask for information and the government would respond.

The government shall take the actions as below:

- a) Install a forum, we name it Citizen Forum now, under the framework of laws
- b) Make it mandatory for MOG, OIG, MGG and PL to attend on an advise
- c) The ICE or accredited representative shall be the 'coordinating monitor' with the functions of 'monitoring the proceedings', advising concerned MOG, OIG, GPP, MGG, PL to attend the 'forum proceedings'
- d) Makes mandatory for anyone advised about the planning of forum, to attend and participate
- e) Makes every television channel responsible for scheduling a 'forum proceedings' and ICE to ensure at least one proceeding of any 'minister' and 'ministry' once in three months
- f) The ICE or accredited representative to summarize whole discussions in at least 'four decisions' and notify to people and the government
- g) Make laws and rules that no one can present false and untrue data, figures, statistics

The proceedings shall be held at a 'government official office' with adequate accommodation and discussions shall be held absolutely NOT in the form of 'argument' or 'counter argument' but only questions, doubts shall be presented by the participants to GPP or GPPL in few words and the reply made by government representative, GPP, GPPL shall be recorded treating

the same as 'official statement of the government, GPP, MOG, OIG, MGG, PL'. It would not be a place to debate but rather be a means to realize government's commitment towards 'upward communication' free and spontaneous.

Anyone shall be permitted to attend. However, the experts and highly qualified professionals, scholars shall be, in general, under open notification and invitation, welcomed to participate. The government would furnish the objectives of a decision, plan or GOSIP and highlight advantages in DAVM form only. Non DAVM presentation by government shall be considered as a MUBI act and concerned GPP, GPPL shall be warned officially for 'being casual' and 'unconcerned'. The government would clarify all doubts, worries, questions of the participants with 'wholesome' responsibility of 'evidencing' that its decisions are in the favour of 'average citizen'

It must be understood that the objective and purpose of 'citizen forum' is not to launch a 'platform for debate' to prove 'right or wrong', but it would be a 'channel of communication' of information. The government being owner of a GOSIP would have all the details which they might not have fully shared with the citizen because of many reasons. The 'citizen forum' would be the place where 'people' would ask for the 'details', seek clarification of their doubts and 'Government' would be responsible to furnish. The 'government' may decline to disclose all the details for matters pertaining to international policies and/or nation's security and/or secrets under law etc but would have to furnish reasons for not furnishing the details.

'Citizen forum' would have at least 100 knowledgeable people, experts, scholars, media persons representing the 'citizen'. The government would always prefer to control nomination of such participants, directly or indirectly, and procedures must be designed to eliminate any such possibility. The procedure of 'selecting one out of many' SOOMA' would be applied to realize this.

There will be a CFOR for each 'ministry' at National/State level and 'DH' of each district. The CFOR would consist of people from 'scholars from universities', media people, knowledgeable of laws, experts of the particular field of discussions, analysist having done statistical analysis in the relevant field, people from business domain and social activist. For matters pertaining to a particular section of people or particular region or land area, the social activists and senior people from that section of people or region shall constitute at least 30% of the total forum.

There will be advance notification for the CFOR by Co-ordinator. The procedure SOMA shall be applied. There will be independent web domain on internet, on which willing participants shall have to apply. The participants shall fill up personal details, expertise in terms of qualification in relevant fields /working experience and four points which they intend to discuss. The computer programme itself shall scrutinize the application, only in respect of 'fields of expertise' qualification and experience and declare the applicant valid or otherwise. The screening shall be done against pre-programmed minimum qualification of 'post graduation' in relevant fields and the relevant experience of 15 years. This shall be exempted in the case of 'social/regional activists'.

Such registration shall be open till one week before the CFOR and a computer programme shall randomly run and select 100 participants out of whole lot of applicants. Government shall keep a policy in place to provide preference for 'air ticket' 'railways reservation', bus tickets etc for travel.

These 100 participants shall attend the CFOR as 'active members'. However, there would not be any restriction that others, who had applied and accepted by the computer software as 'eligible', can also attend and have the opportunity to put up their questions, at the end, if the 'active members' have not covered their points.

The most important part to understand by everyone there, is that they must talk about statistics, data, analysis, facts in DAVM terms to understand objectives, achievable, goals on time line, advantages/disadvantages and MUST NOT use slogans, emotional statements, poems, dialogues of some actor of movie, speech, statements of other leaders etc.

The Coordinator or ICE representative would summarize and place the decisions of the forum in respect of the following:

- 1. If objectives stated by Government are likely to be achieved
- 2. If goals on timeline, maximum six month period, are likely to be achieved
- 3. If GOSIP is going to benefit the average citizen and in what manner
- 4. If GOSIP is going to cause disadvantages to any part of nation or any section of citizen

Note: This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system in the world'. Any explanation in this 'coinciding with any working Government system' shall be an unintentional coincidence only.
