

Government: Head of the family model

Note: This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system in the world'. Any explanation in this 'coinciding with any working Government system' shall be an unintentional coincidence only.

1. **Government has the responsibilities of providing food, shelter, good/healthy living conditions, security, and means/ opportunities to progress to the incumbents/citizen of the nation and present good reputation of the nation to outside world**
2. **The government/GPP get entitlement for governance of the nation for being intelligent, farsighted, planning, executor, role model for honesty and responsibility. These are 'Conditions of government's governance-COGG'**
3. **Government is assumed to be a 'service provider' and citizen as 'legitimate user' of the services.**
4. **The government must use nation's resources to upgrade the livelihood, standards of living, CEAK index of the citizen and provide continuous opportunities to citizen to enhance intelligence level.**
5. **The government is like 'Head of family-HOF' and citizen as 'family' members. Three important attributes of HOF would be responsibility, care (upbringing) and protection.**
6. **The term 'responsibility' would cover spontaneous will for development, support and guiding.**
7. **The term 'care' would cover non-selfish bonds, togetherness.**
8. **The term 'protection' would cover safety from any inflicting entity, SNF, intention or approach**
9. **TFA model-government in this model would look after the citizen (Family) taking their welfare and development as its responsibility, care for harmony and equality and protect society from SNF, associating its own image, existence and status with that of the citizen and feel morally responsible for it.**
10. **WIW model-government unconcerned with the state of the citizen(family), live in isolated manner. Government would show unreal zeal, in words, statements, poetic expressions, slogans, speech etc, concern about the pathetic state of the people, but ensure not to get these transformed into 'solid actions' yielding results and improvements.**
11. **FMP Model; the government would use the citizens for its benefits without returning much to sustain their livelihood and their existence**

The government is a set of people at apex level in a country. At apex level they must meet the prerequisites for making them eligible for 'ruling over' the nation and its people. The government people must possess certain attributes which would keep them in alignment with the 'citizen welfare' and 'nation's prosperity' and integrity. **At apex level they get entitlement for governance of the nation for being intelligent, farsighted, planning, executor, role model for honesty and responsibility. These qualify a government (set of people) for**

governance and termed as (Conditions of government's governance-COGG)

The above aspects COGG making the government qualifying for 'governance', enable them to possess required attributes becoming **intelligent, visionary, planner, executor, administrator, role model for honesty/responsibility and accountability for maintaining high level of citizen's life.**

The **COGG** would specify the responsibility and accountability of government towards citizen of the country which entitles the government and government people GPP for holding the apex level of 'authority' and 'denomination' in a country, but using all 'powers' and resources' responsibly for the welfare of citizen **ONLY** keeping self-gains at bay.

Let us start from the basic question of 'what would be the basic responsibilities of a government for its citizens'. **A government has the responsibilities of providing food, shelter, good healthy living conditions, security to the people and means/opportunities to progress to the incumbents of the nation. The responsibilities towards the outside world would be to present good reputation of the nation** which would be reflected in the acceptability of the people of the country by outside world at par with the citizens of that country and their explicit statements pertaining to the reputation. The same is to be carried through by the government irrespective of its form, structure, the manner in which it gets installed, the individuals in the government and any other attribute related to it. These may be taken as the basic criteria for the performance of a government under this model. The above analogy becomes evident if the **government is assumed to be a service provider and citizen as legitimate user of the services.** The government shall be able to provide its services both to its citizen and other consumers outside the nation, if the above criteria happens to be the 'core thinking' of the government.

A nation in the form of living human masses is a group with various sub groups and different group of people with identified functions. The function of a government is to hold the nation in the existing physical form, providing the perquisites to the people as above. **The government must use nation's resources to upgrade the livelihood, standards of living, CEAK index of the citizen and provide continuous opportunities to citizen to enhance intelligence level.** The citizens are responsible to upgrade their vision correlating their self with the nation, mutual empathy and thinking, to support the development and progress envisaged and planned and put up to the people by the government. The **citizen must grow and upgrade utilizing the resources and opportunities provided by the government.**

Looking at the explanation minutely, it seems to be like a structure of a family where government play role of 'head of the family' and the citizen are the 'family members'. The working of these two factions can be easily analyzed now as a family is a very common entity available over the globe. We shall only discuss about the social and administrative attributes of a family and not the emotional and sentimental as this normally may be missing in government and citizen because of not being continuous and life long relation. And further, the emotions are the reaction to the circumstances and environment and may vary significantly in a large group like a country.

In a family there is a 'Head of family (HOF) and the members. The HOF may have different approaches for its family and for simple analysis, three philosophies of the HOF

are considered. The HOF would possess the attribute of 'taking the family ahead (TFA), a representation of responsibility, care and protection. Thus the **three important attributes of HOF would be responsibility, care (upbringing) and protection.**

The term 'responsibility' would cover spontaneous will for development, support and guiding.

The term 'care' would cover non-selfish bonds, togetherness.

The term 'protection' would cover safety from any inflicting entity, intention or approach

The assessment of the government against these parameters can be assessed and the government approach may be classified into various categories. These may be termed as **'taking family ahead' TFA** for the best. The other approach may be termed as **'why I worry' for family (WIW)**, for the average rating, which would represent HOF being self centered and caring least for other members i.e. the citizen. And the third approach can be termed as **'family for my pleasure (FMP)'**, in which the HOF is like master with selfish terrible attributes and uses the members to benefit the itself anyway.

In the **TFA model**, the HOF would work for the welfare and development of the family as the assigned and delegated responsibilities, self enlightened wisdom, and pride of heading an outstanding family. The HOF or the **government in this model would look after the citizen (Family) taking their welfare and development as its responsibility, care for harmony and equality and protect society from SNF associating its own image, existence and status with that of the citizen (family) and feel morally responsible for it.**

The **WIW model** represents an indifferent government which would represent a **government unconcerned with the state of the citizen(family), live in isolated manner with respect to the citizen (family), neither worrying about their problems, nor trying for a solution** even if comes to know about it and not feeling responsible and accountable for the people (family). This may look like a contradiction, as in fact no government would survive by presenting itself in WIW model as it would be a sure way to exit. So the **government in this model would show zeal, in words, statements, poetic expressions, slogans, speech etc, their concern about the pathetic state of the people, but ensure not to get these transformed into 'solid actions' yielding results and improvements.**

There is further one stage more which normally may be difficult to conceive. **It may be a great shock to see the children, even 4 -5 yrs. old, begging at road crossings.** This is the reason to include further one more model of the government working i.e. FMP model. The HOF in above example has been sending children for begging. This presents an HOF who has no emotions for the family, permit producing children without owning responsibility, do not feel responsibility and accountability for their development, but with a strong unreasonable thinking of using them to what ever way they can benefit the HOF. There have been cases reported that the poor people sold their children for money. This news would have two prominent views.

One, the person, an individual would be so badly pressed with adverse circumstances, disappointed and desperate, decided to sell the child. Yes, the question as to why anybody would like to have child for this purpose, may be reasonable but it strongly put forth the other views, hidden and unraised. And it is, **how a government would have continuously ignored the people for leaving them in the state of destitute and hunger without foreseeing the result which emerged as above.** No government with the attributes of responsibility for the citizen would ever fail to foresee and speculate

such consequences. Thus this must be a deliberate attempt on part of the government substantiating deliberate creation of the Master Slave set up.

The government in FMP model would behave in the same manner not only apathetic to these problems of the citizen, **the government would use the citizens for its benefits without returning much to sustain their livelihood and their existence.** In the above example also, **the government would aim to exploit the people for elections but then forgetting its responsibility, leaving them to their own, multiplying doing anything for the survival but be available to vote for the government, causing the pleasure to them.** No matter if they beg the whole of their lives. A government (HOF) in this FMP model/would be inclined to make itself strong, thus would make laws for the people, would like not to be questioned for the indifferentness, thus would create a passive media (slave) and ineffective judiciary.
