

Note: This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection of 'any particular government system in the world'. Any explanation in this 'coinciding with any working Government system' shall be an unintentional coincidence only.

Why Government (GPP) must be sincere

1. **Government people must work in selfless manner, carry out actions which would uplift the lives of citizen and establish the nation as 'outstanding performer' over the globe.**
2. **Not statements but it is the action and ultimately the 'visible end results', DAVM, which would prove the government (government people) being sincere or not**
3. **There must be pre-notified defined fields of action for the government to exhibit their being working 'sincerely' and pre-notified 'measurement techniques' and 'procedure' to validate their being sincere.**
4. **Establishing a fully transparent channel of 'self evaluation' with procedures and rules, becomes the first requirement and the step for the government to prove its 'genuine and honest and responsible' gesture towards the nation and its citizen.**
5. **'Most important' requirement is that the details regarding fields of evaluation, rules and procedure to measure the same, are openly available to any common citizen and everyone else**
6. **The government and GPP must feel dutiful to notify all their decisions mentioning 'decision value' to people of the nation bringing out the objectives, loss/benefit etc as brought out in other chapter.**
7. **All time awakened, intelligent, knowledge and absolutely independent Media shall be essential, not only in existence but functioning as true representative of the citizen.**
8. **Government has to frame rules, exclusive for self first. most significant aspects are separate much 'severe and stringent' laws for Government people with well defined procedures to earmark their limits and fast course of 'investigation and trial'**
9. **The procedures exhibiting sincerity, PES must contain the defined fields**
10. **'Government' MUST act through the 'identity of the Government persons' by disclosing and associating the concerned 'Government people/persons', the HOG, MOG, MGG of top two levels minimum, 'in person' and as 'individuals'.**
11. **It would be agreed that 'government people' would also have 'personal aspirations' but this is what should be 'open, transparent and visible' to the whole world.**
12. **100% transparency remains the only alternative for 'keeping' government people 'fair responsible and honest'.**

13. **if the government people go for 'self publicity' and 'self projection', it is a straight derivation of 'selfish orientation' preferring 'falsified self praise' than the real benefits, DAVM notified' visibly experienced by the citizen**
14. **it would hatch unwarranted desire in government people to go 'more for publicity' and 'less for action' which shall make them self-centred, selfish and corrupt.**

The government in a nation is the most powerful entity. It has control over all power centers, the army, military, police force, nation's treasure etc. It has all the resources under its control the money, wealth, land and everything. But the government is made up with the normal human being, who have the positive and negative attributes as any other person may have. And every human is selfish in nature as explained elsewhere.

What would happen is the government people would only fulfill their personal aspirations and look after their personal gains using nation's resources and they use the government forces to suppress any voice being raised against their actions. There are examples that many countries, being led by such people could not earn a good name and could not become a country of repute.

The sincerity of the government people therefore, is 'most important'. **The government people must work in selfless manner, carry out actions which would uplift the lives of citizen and establish the nation as 'outstanding performer' over the globe.** If it is only the matter of issuing a statement by government people that they are fair, sincere and outstanding, they may issue ten times in a day. **But it is the action and ultimately the 'end results', DAVM, which would prove the government (government people) being sincere or not. There must be pre-notified defined fields of action for the government to exhibit their being working 'sincerely' and pre-notified 'measurement techniques' and 'procedure' to validate their being sincere.**

However the most important point which comes up is 'who would make government to get exposed to such methodologies and procedures' to assess government's and GPP's 'sincerity and truthfulness level'? And the answer is 'government itself'. Therefore, **establishing a fully transparent channel of 'self evaluation' with procedures and rules, becomes the first requirement and the step for the government to prove its 'genuine and honest and responsible' gesture towards the nation and its citizen.**

Once again the 'procedures and rules' would be of no use if these are confined to the government people only. If so, their behavior shall be assessed by them only and the 'pass or fail', 'good or bad', success or failure' would be in the discretion of the 'government people only. So the result and evaluation shall be worthless. Thus **'most important' requirement is that the details regarding fields of evaluation, rules and procedure to measure the same, are openly available to any common citizen and everyone else** so that 'government people have no incentive and no chance to maneuver the facts and the assessed results. **The most preferred way**

shall be 'public domain' and 'notifications' by the government in black and white and announcements in public from 'designated' official platform.

It has been brought out that government must have direct communication with the citizen treating them as government's patron. **The government and GPP must feel dutiful to notify all their decisions with 'decision value' to people of the nation bringing out the objectives, loss/benefit etc as brought out in other chapter.** This shall be an important parameter to ascertain the sincerity of government.

The media/madiak sources have direct continuous uninterrupted communication with the citizen and such mechanism should not be under any influence of the government, direct or indirect. **All time awakened, intelligent, knowledge and absolutely independent Media shall be essential, not only in existence but functioning as true representative of the citizen.**

If government/GPP has to structure the rules for their evaluation by the citizen, perhaps the first rule would be that 'government's performance can not be evaluated by citizen and made public. Therefore, **government has to frame rules for self first. The separate rules for the government people must be far more stringent, precise, punitive compared to the rules made for the common citizen and rules must be complete in all respect.**

Going ahead with this analogy, we come to the outcome that Government should frame and establish 'Laws and Rules' for themselves first. This implies that Government should develop laws separate from the laws for the common person. And if Government is the most powerful entity in the nation, the laws and rules applicable to the Government and Government people **MUST BE** much more stringent and severe as compared to the common citizen. The laws should carry a 'threat' to the Government people that (1) It would not be possible for anyone of them to get away after doing a misdeed (2) No misdemeanor shall be tolerated for misuse and unintended use of government authority (3) If any Government person would violate laws and/or rules, misconduct and/or breach the specified limits, it would be subject to a test procedure which would complete in six months maximum and punishment shall be rendered.

The most significant aspects are separate much 'severe and stringent' laws for Government people with well defined procedures to earmark their limits and fast course of 'investigation and trial' adjudicate to render decision/judgement within the 'period' the incident is not wiped out from the memory of media and the people.

A government not complying to this would be 'grossly insincere'.

For fulfilling (1) and (2) Government must institute procedures, complete in all respect. The **procedures exhibiting sincerity PES, must contain:**

- a) Agreement of at least two same level of MGG/GPP from and amongst top three levels, jointly and equally responsible, for spending government money including the money coming from national/international funding/loan etc
- b) Who would initiate proposal and who will support and who will approve; with approving person and position becoming owner of the decision
- c) Invariably the proposal shall be based upon DAVM facts and figures

- d) Invariably the objectives of initiating the proposal shall be brought out in DAVM terms
- e) Invariably the goals and achievable shall be brought out in the proposal in DAVM terms and on time line
- f) Processing of proposal shall associate the comments and observations of experts, professionals in the relevant field,
- g) After approval the proposal becomes a decision and **MUST BE** presented on public domain of the government alongwith (d) and (e) and (f), objectives and achievable on time line
- h) The proposal for spending government money and resources must be approved by a GPP not less than the top three levels
- i) Without approval of the designated GPP, the spending of government money and resources shall be a 'misdeed' and 'misconduct'
- j) The procedures for public dealings, for public interface government units and people, the forms/application formats, their processing with stages and on timeline, with names/positions of GPP at different stages and the duration for final approval or rejection with reasons shall be notified by DOUEE on public domain
- k) Non-compliance of procedures by GPP shall be misconduct and punishable
- l) The maximum period of reviews by GPP, on citizen plea to reconsider the approval or rejection by GPP, shall be one month, review done by different GPP invariably
- m) No 'suspension' of services but only 'termination' of services, if GPP is at fault

GPP mindset:

The Government term signifies only the people who are in possession of the government powers and authority. It has been explained above that the use of 'term' 'government wants'/'in interest of government/government desired' etc by the 'Government incumbent persons' (Government people) HOG, MOG, OIG, MGG, as the creator or owner of any decision, is deliberate action to 'mislead the citizen and everyone around', to shed away the 'responsibilities' the 'Government people' must carry regarding all 'government decisions' realizing that the 'decisions are taken by them'. This would be a 'normal' approach by the 'government people' HOG, MOG, OIG, MGG so that they are not questioned directly by the citizen about their decisions under the fear of being 'questioning THE GOVERNMENT' the most powerful in the country'. The **'government' MUST act through the 'identity of the Government persons' by disclosing and associating the concerned 'Government people/persons', the HOG, MOG, MGG of top two levels minimum, 'in person' and as 'individuals'.**

The 'government people' have all the 'government authority' and 'nation's resources' at their disposal. They are the controller of the 'government treasure' and all 'happenings in the country' falls under their jurisdiction and authority. What ever they do, influences every citizen in the country. Their actions and decisions must be directly visible in the lives and behaviour of the 'citizen', if they are behaving as 'one' with the 'citizen'. However, this does not happen in reality, basically because **the 'government people' would like to keep their identity as 'separate and superior, rather 'much superior' to satisfy their 'human Ego' that they are 'super' compared to 'citizen'.**

When this happens, the government people behave like 'multiface /2Face people' with the intention of 'keeping their actions hidden' partly or fully, for fulfilling their 'personal aspirations and goals'. It may be argued that the 'government people' like any other person, would have personal aspirations and why there would be anything wrong about it. And if someone says like this, this makes the whole difference, the difference of 'ignorance' and 'misunderstanding' the position they hold.

Though in principle, **it would be agreed that 'government people' would also have 'personal aspirations' but this is what should be 'open, transparent and visible' to the whole world.** Their personal aspirations, if based upon their personal qualities, personal qualifications and personal abilities, they would for sure, not hesitate in disclosing the same to the whole world because this would 'enhance their reputation' as a capable 'individual' also. However, with all the nation's resources at their disposal, **the personal aspirations would also 'incubate' their 'natural selfishness' of deriving and attaining their 'selfish objectives and goals' from the 'government and nation's resources'.** So the most important aspect would be that 'they have no options of utilizing nation's resources' for their personal benefits. And **100% transparency remains the only alternative for 'keeping' government people 'fair responsible and honest'.**

With 100% transparency by the 'government people' with the 'citizen' and 'open world', their actions and decisions are at once, gets reflected in the lives and behaviour of the citizen. With 100% transparency and 'complete direct communication' with citizen from public domains, public notifications etc and notifying DAVM objectives and goals and achievements of all GOSIP on time line, **government complying to all these, there would not be any place for any 'self publicity' and/or 'self projections' about good deeds of a 'government person'.**

If the 'self publicity' and 'self projections' are considered permissible, the government people would have all incentive to do 'much more publicity' than the 'real achievements' as getting photos printed in newspapers or shown in television or getting posters printed in 'self praise' and pasted on walls is 'much simple and much easy' job than executing the GOSIP and realizing its benefits to the people, which does not need any 'self publicity'.

Still if the government people go for 'self publicity' and 'self projection', it is a straight derivation of 'selfish orientation' preferring 'falsified self praise' than the real benefits, DAVM notified' visibly experienced by the citizen. Not only this but if continues, it would hatch unwarranted desire in government people to go 'more for publicity' and 'less for action' which shall make them selfish and corrupt.

Social Face of Government:

IN a country, usually a government is elected and selected through the process of polling, in which the common citizen would cast vote to elect a person to become a part of parliament and/or part of the government. And there is no review regarding their performance for next 4-5 years when again the election takes place which in fact happens to be a process of few days

only. This extends a freedom to the elected person (OIG/MOG) to turn their face around for 4-5 years and forgets what they are dutiful to the citizen.

Citizen has no way to evaluate and rate their performance during these years.

In a multi-party political system, the formation of government, managing number of OIG, allotment of portfolios/ministries, responding and addressing the demands of other rival parties etc becomes the priority for the government. And over everything, the insecurity and the emergence of selfish attribute for survival, would prevail to turn their faces away from the citizen.

There is one more fact which has never been thought of. The HOG, MOG, OIG are just the ordinary people. A day before, they were common person and day later, have become powerful, rather the most powerful. But they still remain at the same level of qualification, intelligence and prudence, the level of a common person. So, it can be presumed that they are not 'very intelligent' and 'not knowledgeable' (knowledge of fields and attributes which are taking the world forward). And this would be the basic reason of the 'government people becoming selfish'. How?

So the **government, consisting of the people from the group of common people/citizen, with low esteem, confidence, wisdom but high authoritative, cadre configuration, selfishness, egoism would have inclination not to do anything which would enhance the 'intelligence' level of the people as higher intelligence shall 'induce' more 'urge to question' GPP.**

Such inclination of the government people if existing, shall be visible in the form of:

- i. Ensuring quality of education to be low in schools especially the government schools
- ii. Making the education environment in government schools dismal by shabby buildings, inadequate space in classrooms, broken furniture
- iii. Making the education environment in government schools pathetic by providing shabby toilets, stinking, non-functional water fittings, dark and fouled
- iv. Making the education environment in government schools miserable with noisy environment, bare earth floors, water logging, water seepage, unreliable electrical supply, loose electrical wiring and open switch boards, leaking roof/ceiling
- v. Making the education environment pathetic by having open ground unfit for sports and extra-curricular etc with wild grass, water logging, uneven, stone chips
- vi. Making the education environment by deputing teachers low qualified, deputing teachers low in knowledge, deputing teachers with depleted urge to gain new knowledge taking world forward, discouraging high qualifications getting in, appointing teachers looking passive and downcast
- vii. Making Good quality of education expensive costing more than 10% of the earning of individual on education.
- viii. Framing policies to develop good schools with good building, classrooms, good furniture and teaching aids, cleanliness, good and fully functional toilets, extra-curricular facilities in non-government sector but not complying to the government schools

- ix. Making the availability of education/schools, access, reach, grasp more feasible than government schools
- x. Keeping common people at 'low CEAK level' by misusing religion, culture for keeping people living with stories and non-existent facts
- xi. Keeping criteria for selection of GPP, MGG below the best education level of people in the society and in nation
- xii. Keeping criteria for selection of GPP, MGG below the best education fields/discipline in nation
- xiii. Keeping criteria for selection of GPP, MGG below the best intelligence level of people in the society and in nation
- xiv. Keeping selection criteria of OIG, MOG, OIG2(at district and village level) below the best intelligence, professionals, education
- xv. Keeping direct communication between government and citizen non-existent
- xvi. Self publicity and self praise of government and presenting 'others as fools'
- xvii. Configuring MADIISM (Master's dude ignorant inapt selfish media) Media for presenting cooked up image of government, repress or twist facts, using ambiguous imperfect language, directionless, citizen unfriendly, government puppy media for praising the government and cursing those on the other side
- xviii. Keeping common people under ignorance of the progress, development, research occurring over the globe
- xix. Not making official confession as to what is due to the citizen from the government
- xx. High master-slave governance
- xxi. Rallies by political leaders (instead of direct official communication) attended by people in thousands
- xxii. Intelligent highly qualified people leaving the country for permanent settlement

As above the government being most powerful entity, if not sincere, can create GPP which are non-transparent, non-committed to separate punitive laws and rules, self-publicity and self-gain' oriented and ultimately making the citizen more helpless and deprived.

Thus evaluation of 'sincerity' of a government is 'most warranted'.
