

My words; from my Desk:

Before you may proceed going through this compilation of documents, I would clarify that

"This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system or any person in the world'. Any explanation in this compilation of documents coinciding with any working Government system or a person" shall be an unintentional coincidence only.

Basic People's Verification Code of Governance, is a comprehensive document, made first time in this manner on the globe and contains not only 'narrations' in the form of 'reasoning' but an 'evaluation sheet' with which any attribute can be measured in terms of 'mathematical number/score' as
1. 'Mathematical calculations and figures' ultimately signify the 'absolute status'

2. Mathematical figures provides an instantaneous assessment with 'extent and magnitude'

3. The mathematical figures depict the 'trend and pattern', if the changes are compared relatively

In line with this a term DAVM is used in this which signifies the 'real and meaningful existence' against Non-DAVM which shall represent 'ambiguous, slogan formed, unaccounted words and statements, words not transformable into actions thus inclination of possible cheating'.

Different chapters have been structured as conceived relevant. Still, as this is first attempt ever to structure a 'Code of Governance for Governance by the Government, which ultimately is a set of people' derived by common attributes of a person. Therefore, it is not 'complete' document. It is only a beginning based upon which 'lot more' can be done, and surely to happen. However, this is my original work and creation, made over a period of years, thus I keep 'copyright' of my work. Subsequent use of 'hypothesis, methodology, evaluation procedures' etc contained in my work, for any use, would need my approval.

The chapters have been structured based upon 'modelling' in which the documents are built step by step, with derivations of new logics/reasoning and making up further. Like a doctor doesn't 'peep into' the body of a patient to see the 'infecting bacteria' physically and the treat, the doctor 'looks at the symptoms' which the infection has resulted and then 'makes out' the 'identity of infection' and treat. Thus a doctor 'models' the disease which is hidden and invisible, based upon the symptoms which are 'visible' and 'observable'. This 'phenomenon' is being applied and proven over last few centuries. Thus relied upon. This has been followed as the 'core principle'. The 'governance of a government' would create 'symptoms' all over, in the environment, citizen behaviour social-communal, behaviour of government people, and result symptoms in the form of 'citizen wellness, social harmony, equality, development, citizen and nation's growth, protection and safety of citizen', government people behaviour', etc and just true, sincere and critical study of these symptoms can 'accurately' brings out the 'intentions, capabilities, accomplishments (**rather real achievements, verifiable and measurable**)' of the government and 'such modelling/models' and analysis based upon reasoning and logic can therefore, be rightly adopted as the 'methodology' to assess 'government's performance'. I have only tried to create 'models' based upon what is visible, existing (or should be existing) or missing evidently etc.

My documents have 'watermark' of 'Bhanoo P Verma' and mention of web site '<http://bpverma.com/>'

This world is full of people who have great inclination to find out 'deficiencies'. In fact 'finding out deficiencies' is the easiest job. It is the simplest attribute for those who have 'urge to be intelligent' but 'do not have skill, eligibility, qualification and confidence' to project themselves, thus go for this 'easy course' of finding 'deficiencies'. Since my work is the 'first ever attempt' for configuring the 'Code of Governance' with 'methodology to assess and measure', there is lot of scope for 'finding deficiencies'. In fact the marks/score allotted against each single item can be 'argued' further for being +100 or +150 or +200 or similarly for minus marks etc. If I have assigned +100 anyone may like it to be +50 or someone else may like it to be +150. I have presented score based upon my 'perception' of applicability of that particular item to the 'governance value' and this may vary with different 'governance systems' and 'governance and government's environment'. Some 'government may decide to put more 'weights' on the corruption whereas some government, which is fair and honest, may decide to put less 'weight'. My work is an initiative which paves a 'direction and approach' to address the important dimensions of 'governance of a nation' and can surely be build up further, like any other thing/phenomenon/article in this world.

There are numerous happenings in this world which correlates to my 'models' and visible all around. Some have been included in my work but obviously, more to be added.

My work is compiled into two type of 'documents'. One is 'word file'.....doc.R0 and other one is 'excel file'.....excel.R0. The R0 is the 'Revision-zero' and it would upgrade with the revisions subsequently. The ...doc.R0... consists of the narration part with explanations, reasoning, derivations etc and ...excel.R0.. consists of various items and symptoms which are visible with marks assigned to each item, + and (-): plus and minus. The methodology of evaluation based upon the same is covered in 'preface' document. The score calculated on ...excel.R0.. sheet shall be the MUBI score against that item. The term MUBI is also explained in 'preface' document.

Please note that there may be more than one ...excel.R0... documents related to one ...doc.R0... document or there may be aexcel.R0... document which does not correspond 'one to one' basis to adoc.R0.... document.

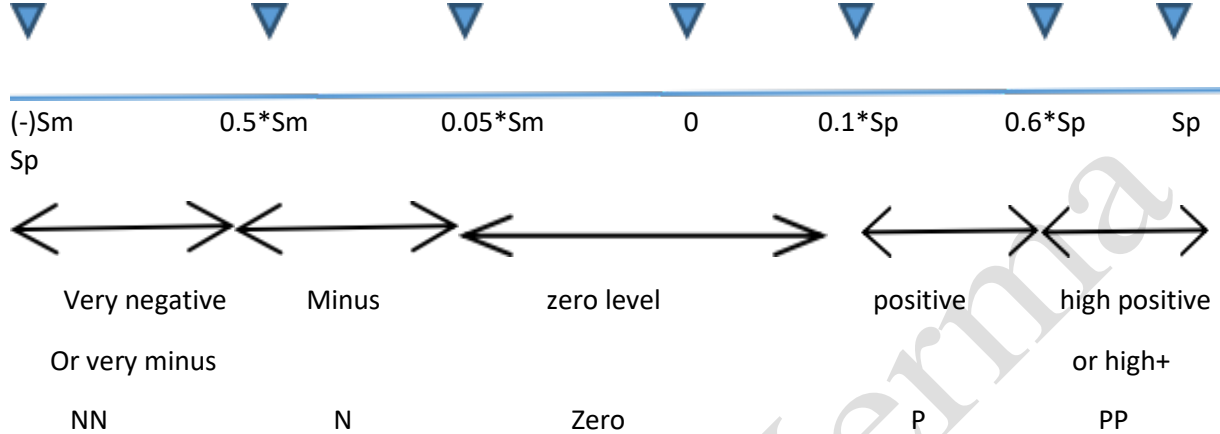

Preface and Tips. doc.R0

1. There are governments ruling over every country. These are different in nature, philosophy, application. These governments are embodied into 'Government people' (those who are in the government) and they 'finish up' concluding and deciding 'what Government people do' is what 'government should do'. And this is wrong.
2. There are 'Government working over the globe for centuries and in the same country, different government's work differently exhibiting differences in their 'governance philosophies' and 'perceptions of governance'. One may be 'superior', other may be 'inferior'. Government people 'come and go' but 'citizen remains and loses'.
3. The 'government people' in normal course shall not define their 'responsibilities and accountability' as it would 'hamper' their actions and intentions especially the actions normally 'justified' under the cover of 'politics'.
4. The citizen are not directly associated in the 'decisions' and 'actions' of the government (or government people) and government people almost decide 'independently'. So the suitability of decision remains 'uncertain' almost always.
5. This document 'comprehensively' state the 'responsibility and accountability' aspects of a government, as this only 'brings them up' for 'public service'.
6. This compilation has many chapters prepared over a period of years. The title of the chapter has been kept close to the 'contents within'. The chapters pertains to 'many different aspects of governance and elements, actors, players of governance' thus not lined up in any particular manner. Though each chapter pertains to independent 'activity and topic' but happens to be 'orbiting' the subject of 'government's governance'
7. It is evident that the decisions of the government (or government people) yields direct impact on the citizen/people of the nation. Every decision thus affects their lives, attitude and behaviour. Though it is not possible to 'measure' the performance of a government, as no parameters, measurement techniques and standards available, the facts which are visible in the form of 'government services' and 'citizen amenities and citizen behaviour' can be directly used to signify the 'success or failure' of a government. This methodology has been adopted to present and signify the performance of governments.
8. There are two type of documents. 'doc' and 'excel'. The 'doc' documents contains the 'explanations, reasoning, arguments' for 'structuring the documents' in that fashion and the 'explanation' about the contents contained in it. These are 'narrative' and 'academic'.
9. The other document 'excel' contains the 'facts, realities, happenings' which are physically 'visible' or 'missing' and a (+) and (-) score is assigned to each fact/happening. For that particular 'head' there may be a number of facts/happening with score assigned. The real life is to be examined regarding the position about each fact/happening and marks to be allotted as noted therein. The 'allotted marks' of items (facts/happenings), total shall represent the 'score obtained'.
10. The total (+) scores of individual items are added and say comes to 'Sp'. The total (-) scores of individual items are added and say comes to 'Sm'. The rating of the 'head' representing 'system, fact, happening...' shall be as below:

- (a) The total of positive score of all items added, is say Sp
 (b) The total of negative/minus score of all items added is say Sm
 (c) The scale shall look like
 (d)



The 'score obtained' to be checked and placed on above scale and the corresponding category, NN or N or Z/0 or P or PP, is the result obtained. As the category has a wide range, it is important to state the 'score obtained' also.

11. The following illustrations is presented to clarify the doubts:

Now $0.5*Sm = 0.5 \times (-)750 = (-)375$ corresponds to boundary of NN/N

$0.05 \times S_m = 0.05 \times (-)750 = (-)37.5$ corresponds to boundary of N/Z
(-)250 the obtained score is in 'category-N'.

So the Topic-1 Score=(-)250 and category-N.

Basic principles:

Some basic derivations are as below:

1. Every 'bad' occurrence is the result of 'Murkhta (Stupidity) and /or 'beimani (corruption) and/or Impotence (incapability), may be one at a time or together. Thus for every 'bad' happening 'MUBI' assessment must be done.
2. There are two faces of everything, every decision, every happening, 'Good and bad'. Therefore every aspect need to be analysed to understand both faces
3. Every 'good' thing loses its worth after a limit and if continues further, it turns into 'bad'
4. There are two reasons for a 'political leader' to climb up to the 'government level', first is the urge of 'social service' and if not, then it is 'selfish interest of self-gains'.
5. The Newton's third law represents that anything continues in the same state unless an external force is applied to change the course. Thus the 'MUBI governance system' would continue in the same state unless external force is applied, and this external force would be 'intelligence'.
6. Emotions and logic/rational are contradictory. There are no 'real emotions' in this world except 'compassion'. All other 'emotions' love, anger, hatred etc are associated with 'selfishness' and 'do not qualify' for a standalone 'honest and sincere expression' of encompassed welfare.
7. Thus the governance 'must be' based upon rational and intelligence and not emotions.

Methodology:

The methodology adopted is first to explain and describe the 'subject matter' and the 'logic, reasoning' for its 'existence' are appended. The 'appropriate form' is conceived serving its 'existence' and presented. These are .doc files.

However, the most important 'constituent is the 'application' which normally is 'missing' almost always, intentionally or unintentionally because of 'Mubidity', which creates most significant 'handicap' to 'verify and measure' the failures and/or accomplishments. So everything becomes 'absurd'.

'Application' of the 'reasoning' are contained in the 'associated' 'excel' document in which number of items associated with 'application' appear, containing the score/marks against each. If an item occurs supporting the 'cause of existence' and 'good reasoning', it is assigned (+) marks and if it is opposite, it is assigned (-) minus marks.

The 'quantum/size of marks' earmarked against an item may vary slightly 'subject to' the considerations given by an individual 'governance system', however, the nature (+) or (-) would not vary normally.

This procedure has been elaborated in the para 8, 9, 10 above to find **the overall topic score** of a particular head/main topic which is summed in para 10. This is 'MUBI' score of that topic/happening. The more (-) minus score represents high 'mubidity' and thus higher 'inappropriateness/unsuitability'. Minus(-)100 shall be more minus than (-)50, thus (-)100 shall be more 'undesirable'.

In case of positive (+) topic score this is reversed, and 100 (+100) shall be more desirable than 50(+50).

Thus the 'Governance suitability score (Index) of any government can be assessed by any person/citizen and can be assessed by the 'governments' to verify the 'purposefulness and suitability' of their existence.

So, with this document any common person can evaluate the 'worthiness and suitability' of a country's 'governance system', therefore, it is named as 'Basic People's Verification code of Governance'.
