

Evolution of 'Unwanted Culture'

Culture: a practice, norm or perception

First of all let us define culture. A culture is an activity, practice, tradition which is adopted and practiced by large number of people based upon some belief, presumption or perception, however, the reason why it is being done may be or may not be known to them.

Whatever we see around us has an origin, where it started from. If this origin would have the characteristics of containing it in itself, perhaps every human would have been different in every aspect of life. When we see a number of people speaking same language or doing similar jobs or eating same stuff or following same social norms etc, it becomes evident that every human is highly influenced by the environment. Someone started a social practice or eating something or wearing an attire because someone else was doing it, is quite common. These are the norms which support society, support life and carried through to different phases of life and we may, just to say, call them 'positive practices.'

Let us look at some other interesting examples. Have you seen motor bikers overtaking cars by changing their lanes (putting their lives at great risk). Vehicles blowing horn, just unwanted, knowing very well that the vehicle driver in the front is not going to 'camp' at the middle of the road and would move when space in front of it is available, parking of vehicles causing obstruction to movement of vehicles on road, staff not working efficiently in an office, corruption and bribe becoming general and universal norm etc. It becomes fascinating to observe that such activities are not desirable even for any individual to adopt, or a society to absorb by so many people, still what makes these to continue and grow. One would come across people abusing in public not only to outsiders, but to family members, people cheat others not as an individual but as a profession and so on. And if you go into inside of a person talking to its conscious, everyone would reveal that such practices are not good for any cause. But still they practice it. Why?

Why undesirable continue:

Here **we would try to model and analyze the spread of such practices which even the holders and practitioners do not accept to be correct, and consider not good to develop a rational and healthy society. How such undesirables propagate?** At any time, one person would have abused in public, how come this got started to be practiced by so many? At any time one vehicle driver would have blown horn standing in a jam or Red signal foolishly presuming that his horn would push the vehicle in front of it, forward, but how come all vehicle drivers would start blowing horn standing in traffic jam or on a red signal. As there is always some vehicle standing in front of him, its presumption that the vehicle in front would park in the middle of road if he doesn't blow horn shows lack of meaningfulness behaviour? **How come such 'unwanted' becomes a 'culture'?**

Let us get back to origin. An action which is **not 'wanted' and 'undesirable'**, was started by an individual. If it was not happening earlier what could be the incentives for the other person to adopt it. The first derivation is that it would have been initiated because of its selfish interest and also to gain something which was not coming to the individual in normal course. Therefore, **it came out of selfishness to gain something undue.** An attribute which is contrary to the alignment of the society, thus causing disadvantage and damage to the society and environment. To the person acting on it, it's a short-cut to achieving something which otherwise is illusive. After first such action, the person would at once be guilty conscious and would wait for the reaction from the environment and the controlling forces designed to control such unwanted action. It is where the 'point of no return' is set by default.

The term 'environment' other than society mainly pertains to Government systems represented by 'designated controlling forces' which are normally under the control of the Government, say 'Regulatory forces of Government'-RFG.

The society or other people would not react at once because firstly, the 'regulatory forces' are 'established for containing' such 'abnormal action' by a citizen and 'other citizen' would look up for an 'appropriate effective' action by the 'government'. Secondly, reaction of other citizen for preventing 'such abnormal' act by someone, would contradict the provisions of 'laws and rules'. So evidently the action by 'Government's regulatory forces' to restrain 'abnormal act' by the person, shall be the only 'effective action'. But if the 'regulatory forces' do not do so.

Low or inadequate reaction from environment and society and the designated controlling forces provide encouragement, not only to come out of its guiltiness but getting add on in the shape of shameless appearance and reason for repeating it. Thus the 'initiation' is selfish and unsocial but controlling environment and society is careless, disassociated and unconcerned about what is happening. It does not react therefore

These are three factors promoting this happening:

- (i) Selfish orientation of some elements of the society. This will always be there and cannot be ruled out.
- (ii) Apathy of the society and does not react.
- (iii) Apathy of the Environment, the Government regulating forces

Thus as the selfishness from a human can never be removed, and **society would always wait for the Government support to restrict such undesirable acts, the role of 'Government controlling forces' or 'Government intention' remains the decisive factor.** The acumen, sharp monitoring, ability to foresee are essentially the basic tools here which the Government controlling forces RFG, must possess to take note of such minor happening and expanding dimensions right at the time coherent with the happening and take corrective action. If such action, 'unwanted and undesirable' expands and get installed into a 'culture' it is only because of 'lack of proper action by Government controlling forces and also related organs of the government being at a very high MBI level.

But what converts the 'single abnormal happening' into the culture. The **low level of 'vigil and determination' by government to restrict, becomes most important catalyst, however, the dimension which brings in such 'transformation' into the culture happens with 'time'.** Those who are the followers of 'correct' and 'harmonious' actions, while witnessing such 'abnormal happenings' and also witnessing that the people exercising such option getting benefitted because of 'indifferent' RFG, seeing it again and much again, would start believing that such acts are not 'incorrect' and instead are the 'way of life'. Any they would also start practicing and emulating.

This transforms the single happening into a 'culture'. So after the apathy of RFG, the most important parameter is 'time' as to how long such abnormality has been occurring.

Let we proceed further. Because of high MBI index of the government organs, the action of this individual gets through unchecked. The Government either would fail to take note of it (Murkhta) or would ignore it after taking note of it (Murkhta, Beimani, Impotency all accountable). It is not to be forgotten that this was initiated for an undue gain. Even though knowing fully well that the individual is getting undue advantage out of his act, the other members of the society remains passive because of passive reaction of the 'Government control forces'. The society would look upon the Government to take initiative to curb such unwanted initiatives as to ensure safety and harmony in the society is Government's responsibility. **And with inadequate attention from the government, may be**

deliberate, the members of the society would start 'colliding' with the claim that 'someone is correct' and 'other one is incorrect'.

The **passive Government would certainly result a passive society.**

The passive Government's posture indicates the following:

- (i) Whatever reasoning Government would have, its ultimate aim is to create turbulence in the society so that there are clashes and collisions amongst members and society does not remain united
- (ii) It has already been explained in the Master Slave Governance chapter that this would happen when Government would aim to become Master and convert the society into Slave.
- (iii) Indirectly government wants to promote such elements so that they start terrifying the society and when it happens, Government uses them to control the society for their (occupant persons of the government) vested interests. This is an action of a Master, thus Government would intend to start treating citizen as slaves.
- (iv) Government (represented by occupant persons of the government-GPP) would use these elements against the bargain of not punishing them and they keep society scared.

Thus **continuance of an unwanted social action, social evil or practice in public is always because Government would have supported it, directly or indirectly. Showing helplessness by the Government on any excuse or setting society's apathy accountable for getting it spread, are the normal reasons a Government may put forth which itself would indicate distorted inclination of the government and high MUBI index as Government has the responsibility not only to act first but also to act adequately.**

Now this action of one person is watched by many others. There are selfish elements everywhere in all society set ups and social environment. Everyone desires to be a self acclaimed superman. The behaviour based on harmony, equality, sharing opportunities, sharing resources, sharing services available, leaving way to others, support others to stand with one self, have long time line and low possibility of undue benefits. It now provides incentives to adopt the shortcuts to fulfil their undue too.

After the society gets into this shape, what would the controlling forces of the Government do? Nothing obviously because they have already decided to be a Master and continuance of this menace is essential for converting society fragmented into slaves.

And **that is the beginning of a new chapter of slave society.** Most important to understand is that this would expand not simply in addition progression but it would be in multiplication progression 1,2,4,8,.....or may be 1,4,10,20,50..... **In addition to Government's ignorance, the multiplication progression shall depend upon number of people around, average education level and heterogeneity as one individual would influence/ infect the people around it in all directions.**

So the following factors would directly contribute to the formation of a 'culture':

- (i) Harmony or heterogeneity of the society
- (ii) Education level providing high or low vision and low education level will enhance it.
- (iii) Opportunities (mainly for earnings) to sustain self and family. Less opportunities would enhance.
- (iv) Population. More population would result more people around, more witnesses to such undesirable acts and faster spread of 'social negative factor' (SNF)
- (v) Passive Government regulations will enhance.

Let us, as a thumb rule, say one of the above support factor provides a multiplication factor of one, then if all four are present, the progression shall be 1,5,25,625.... and this is how such undesirable acts would become a culture.

Once a 'social negative factor' (SNF) becomes a culture, the society becomes immune to have the feel that SNF is anything which is wrong, undesirable or unwanted. At this stage, it is immaterial for them to analyze if there is any gain in doing so (they were already not having that level of intelligence) and they would do it as a part of their show off, since they see others doing it. **Thus, instead of feeling that it is something undesirable, they would do it and presume for having done something great. No wonder.**

The SNF would start prevailing in society and SPF (social positive factor) would go to the back seat. As explained in MS governance, the 'Regulating forces of government' would get close to SNF and use them to control the society for fulfilling their wishes of a 'Master' treating citizen as slave.

The most important aspect to understand is that the 'abnormal acts' are not 'major crimes' which are staged to harm others, but these are 'just distorted common happenings' which provides undue benefits to those who would practice it. **And the MS Government just causes 'divisions' and 'rifts' amongst citizen for which the GPP would hold 'ONLY CITIZEN RESPONSIBLE' ultimately showing its 'insincere innocence'.**
