Note: This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system in the world'. Any explanation in this 'coinciding with any working Government system' shall be an unintentional coincidence only.

## Vanity exploiting nation's money (resources)-VENAM

It is elaborated in various chapters that:

- 1. The GPP,HOG,MOG,OIG,MGG are human and would be driven by 'attributes of human nature' including 'insecurity' and the aiming 'selfish self-gains'
- 2. The GPP, HOG,MOG,MGG and OIG a(s any OIG can become MOG) are common person but carrying responsibilities of 'super-person', so would have significant probability of failures
- 3. The GPP, HOG,MOG,OIG,MGG would, to cover up deficiencies and failures, would tend to 'infold' the citizen in 'low rating GOSIP', 'good words, promises, and missing verification and measurements of 'goals achieved' in REALITY.
- 4. The GPP, HOG,MOG,OIG,MGG would tend to project self as an individuals as 'outstanding performer' using 'Government and Nation's' enormous resources

The fact that GPP (HOG,MOG,OIG,MGG) are just common person but need to possess capabilities of a super-person, is something 'hypothetical' and 'unreal'. However, they have to take decisions for the nation, whole group of citizen, making policies effecting national and international trade/business, such decisions which changes direction of the whole nation, millions of people, effecting not only present but future of entire civilization. The intents, idea, scheme, GOSIP therefore, likely to bear deficiencies and shortcomings. It is elaborated in other chapter as to how 'rating/index/score' of a GOSIP is to be assessed which would evidence the 'low rating (NN, N, Z).

The GPP either would display earnestness by enhancing the 'intelligence level' in 'government's decisions' by associating eminent people, experts, highly qualified people relevant to decisions, analytical intelligence attributes and people, vector intelligence attributes and people to configure the decisions to be 'accurate, purposeful, meaningful'. However, this would depreciate the 'importance of the GPP' and make them less important and less prominent. In a political party based government system, the GPP-HOG,MOG,OIG would be under compulsion to keep themselves 'highly prominent and renowned' as they would again go to the people for their return.

The GPP are common people but 'taking decisions which require very high level of intelligence' but need 'high prominence and popularity' thus present 'complex and contradictory' situation. The GPP thus would have to create an 'artificial environment' amplifying its actions and presentations multifold, to remain in 'prominence' irrespective of the 'accuracy of 'government/GPP decisions and actions' and 'achieved DAVM goals against DAVM objectives. The GPP has control over all the resources, nation's treasure, money, means and decision making authority, and these would be sufficient for the GPP to create such artificial environment. The GPP shall create this artificial environment using the following with sole objective of 'unreasonable made up and unreal self promotion'. This will therefore, be termed as 'Vanity exploiting nation's money-VENAM'. The following shall represent the existence of VENAM:

- 1. Use of 'government's treasure and nation's resources' for 'advertisements, publicity' of an individual HOG, MOG, OIG or selected few GPP
- Use of 'government's treasure and nation's resources' for 'advertisements, publicity' of an individual PL or selected PL or political party
- Criticism of other political party or other political party leaders using 'government's/nation's' treasure or using such means of 'government' and its 'assets'

The use of 'government's/nation's treasure, money, resources for political party or a PL shall be most 'un-called for' and 'high level of VENAM.

These shall be examples of Venam which is direct. The Venam shall be in indirect visible form also. Presentations of GPP as individual or unsubstantiated non-DAVM, slogan/literary proposals, idea, words, photos etc by the 'government establishments' presenting the GPP as 'proprietor of its success/achievements' would obviously be the examples of 'Venam'. Even the presentation by non-government establishments; presenting GPP as individual by name, photo, government position and 'glorification' by stating as 'godfather, architect, founder, patron ........' Without providing DAVM facts, data, benefits to the people/citizen etc substantiating association/participation of GPP, would constitute also 'Venam'. It would be a form of Venam because of two reasons (i) the non-government establishment shall not promote and glorify GPP without laying and accruing 'selfish interests' (ii) the GPP would invariably have provided benefits to such establishment using its 'government powers'.

The 'Venam' is totally unwanted and undesirable attribute because of following:

- 1. It encourages the GPP 'to act false' by creating 'hazy' and 'muddled' environs, driving them away from 'truth and reality' and adopting the course towards 'cheating' and 'deceiving'
- 2. It encourages 'masterism' in GPP
- 3. It encourages misuse of government/nation's treasure for selfish use
- 4. It establishes 'Venam' as a culture and once in practice, each GPP, HOG, MOG, OIG, MGG shall tend to go the same way, promoting unsolicited values in government people.
- 5. Once becomes a culture, it is not looked upon as 'undesirable' and thus begins 'culture of Mubidity'
