

Note: This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system in the world'. Any explanation in this 'coinciding with any working Government system' shall be an unintentional coincidence only.

Emergence of 2Face Leader

2FL=2Face Leader; NAAK/Low-CEAK=Low-capability, Low-empowerment, Low-awareness and Low-knowledge; PITI=Poor-ignorant-troubled-ignored;

This chapter makes us to understand:

1. Every person, sincere to self and the world (environment), would have only one gesture, one face, its being absolute truthful and natural. Its 'single face' characteristics/attribute shall confirm sincerity and truthfulness to everyone in the interfacing environment
2. The single face character shall signify 'a true person' not aligned to 'selfish self-gains' and not believing in 'mischievous behaviour'. Single face person, would not carry an 'unfriendly, selfish and mischievous' gesture.
3. A HOG, MOG, OIG, Political Leader-PL, MGG must be 'single face' character and person and must invariably be in 'public service' mode
4. In 'political party based government system', the PL becomes GPP carrying the same 'mindset' of 'selfishness' and '2Face character' into the government
5. A Leader; HOG, MOG, OIG, PL would be 2Face when good results DAVM, are not accrued to the people whereas leader may be pretending to be accomplishing.
6. A leader would be two face when not behaving in 'selfless manner' but pretending to be doing so
7. Low CEAK (NN/N)(NAAK) and negative PITI (NN/N) citizen states would severely enhance transformation of PL into a 'Master' and to strengthen itself, it would craft citizens as 'slaves'.
8. This leads to the creation of 2Face leader because the PL gets into the form of a 'master' but need to present itself as 'common person' one out of other citizen, to gain their favour and trust.
9. 'Evolution of negative mentality' explains that permitting 'deterioration' in 'day-to-day' happenings visible to the people causes emergence of 'negative mentality' in the people which results 'disintegration' and 'mutual rifts'
10. 2FL Governance would wait till the people, who are not doing it, accept this as a way of life, stops reacting and complaining about it. The, government's apathy for corrective action, in 2FL character, would suppress the desire of any further complaints
11. The 2FL would however, present such deteriorations under the cover of good words, under cover of religion, traditions, culture, citizen fallacious dignity, motherland honor, patriotism etc to embed these indefinitely.
12. In political party based government system, the PL subsequently become HOG, MOG, OIG and a 2Face PL would launch the 2Face character in government and governance.
13. 2FL would invariably make the 'government education services' worthless compared to 'non-government sector' as such action would be necessary

to create 'low-CEAK/NAAK' citizen masses. Low-CEAK would turn the people to 'mind set of a slave'.

15. PL (and transformed into HOG, MOG, OIG) shall have incentives to make citizen more PITI, once it turns into a 'Master'. So it will be a vicious circle, Citizen becoming more PITI and government showing all sympathy and good words, do not create substantial 'verifiable and measurable' evidence.

16. Masterism starts not because someone is 'master' but with someone behaving and accepting being a slave

Every person, sincere to self and the world (environment), would have only one gesture, one face, its being absolute truthful and natural. Its 'single face' characteristics/attribute shall confirm sincerity and truthfulness to everyone in the interfacing environment. The single face character shall signify 'a true person' not aligned to 'selfish self-gains' and not believing in 'mischievous behaviour'. Single face person, would not carry an 'unfriendly, selfish and mischievous' gesture

A HOG, MOG, OIG, Political Leader-PL, MGG must be 'single face' character and person and must invariably be in 'public service' mode.

We studied and analyzed in other chapter that a Public Leader/ political leader PL emerges and displaces its plane from the plane of the citizen and gets disassociated from citizen plane. This characteristics brings out their selfish behavior and causes the signs of 'Masterism' to emerge in their behavior. **PL becoming 'master' is almost sure to happen if the citizen is at low-CEAK (NAAK) level** (Low-capability, Low-empowerment, Low-awareness and Low-knowledge) and PITI state. As explained in other chapter, the low level of 'direct communication between Government and Citizen transforms the PL to get closure to the GPP and IGPI, deriving their self-interests but presenting themselves as the representatives of the citizen. At this stage, **the PL gains orientation of 'self-gains' and would therefore, wish that citizen always remain entrapped in problems.** The survival of PL gets linked to the 'problems' the citizen have. **So they would never try to 'END' the problem.**

This leads to the creation of 2Face leader (2FL) because the PL on one hand turn into a 'master' but presents itself, on the other hand, as 'sympathizer' of 'common citizen' pretending one out of them, to gain their favour and trust. So 2Face character is presentation of "selfish self-gains, masterism, disassociation from selfless public service-orientation".

And in 'political party based government system', the PL becomes GPP carrying the same 'mindset' of 'selfishness' and '2Face character' into the government. And they would keep 'Low quality' of 'direct communication' and intend to implant 'low-CEAK/NAAK'.

It has also been elaborated in other chapters that 'Master' always needs 'slaves' for its 'existence as Master', therefore, **leaders in 'Master' mode would craft citizens as 'slaves' resulting NAAK and PITI state of citizen and this state of citizens would further aggravate the aspirations of PL to remain 'master' forever. PL in 2FL state would present and project to the world that it is doing best for the citizen but ensure that**

citizen, at the ground level, remains NAAK and PITI. So the leader would have two faces, one false visible to the world and other one 'real' but disguised completely. **This signifies that the PL subsequently transformed into HOG, MOG, OIG as applicable, would implant the 'selfish' mode and 2Face character in government.**

A Leader; HOG,MOG,OIG,PL would be 2Face when good results DAVM, are not accrued to the people whereas leader may be pretending to be accomplishing.

The only motive of a two face leader would become to remain in power and for winning elections. So many short cuts would crop up. **Instead of doing well to the people, the thinking may emerge not to waste resources for the people and let them grow of their own overcoming all constraints themselves.** The first trap was to permit them to multiply. With this the people would be more poor, more helpless, cursing their own self and struggling to live. They had little time to look upon the government on every day basis and the link between government-public breaks down causing Government public/people disconnection (GPD). This causes emergence of PL group. **The two face leadership also had to build image to construct their supremacy, and not the public interest** which was the cause previously.

There may be incentives for leadership to become 2FL and keeping the people poor and helpless state to make their own benefits through without any check or revolt from the public.

Under development shall cause migration of people from undeveloped areas to the developed big cities. Permitting migration from backward areas to metropolitan city is a strategy which kills many preys with one arrow. The 2FL is free of the responsibility of developing the backward areas. The 2FL also get poor's appreciation for providing undefined right to migrate to better places for better prospects, including the people can earn more even by 'begging' in metropolitan city. **The 2FL strategy may be to make a 'beggar' in a metropolitan city earning more than a common person in small towns/villages.**

However, 2FL achieve the most important of its intended result, by infecting the thinking and psychology of the metropolitan city dwellers who are intelligent, aware of happenings, educated, demanding, with the prominence of the much deteriorated life practices of poor masses. May be, it's also a view of people going to open fields with water in early morning to ease themselves. **The true statistics** regarding availability of toilets to poor people may bring out this. The environment would be spoiled. **People urinating in open, spitting, garbage around, animals in public spoiling environment, abusive and obscene language, mutual disrespect, roads with ditches, disobedience of common rules, begging, open drains, human waste in drains, loud presentations, agitations, social evils, low-CEAK, road rage, delayed decisions settling small road accidents, incomplete inadequate laws, road obstructions, water logging on roads/parks, overflowing drains/sewer etc would also be other visible scenes evidencing 'deteriorated living conditions' DLC . But at no time 2FL government would try to take adequate measures to discontinue it.** 2FL government would make its roots deeper by showing apathy and let it to become a culture. It is explained in the chapter 'Evolution of negative mentality' that permitting such 'deterioration' in 'day-to-day' happenings visible to the people, a number of such factors-numerous, causes emergence of 'negative mentality' in the people which results 'disintegration' and 'mutual rifts' which would make the 2FL stronger.

2FL shall overlook the elimination of such factors and happenings which would cause formation of 'negative mentality' in the people.

How fast negativity spreads and become a culture, has been explained in other chapter. 2FL government would wait till the people, who are not doing it, **have accepted this as a way of life, stops reacting and complaining about it.** Even if it is reported as a complaint, the, government's apathy, in 2FL character, would suppress the desire of any further complaints. Thus the people who could have kept an eye on the government working and questioned them, would also feel helpless and distressed under the forced acceptance of unacceptable norms and gets busy in preventing these to become their way of lives. Thus they feel indebted to the government even if they get even the low level of amenities, **even though much higher level were due to them as their rights.** They would not agitate even to the open drains, human waste in drains, unsafe rough roads with ditches, garbage on the streets and roads or in parks, unsafe drinking water, unreliable electrical supply, narrow streets and small houses with government standards missing, flooded streets and roads in rainy season, obstructions/parking on the roads etc and glimpse of these, even in the metropolitan cities directly notify the presence of 2FL. **The 2FL would not notify the standards to which the 'public services' would conform to, ignore the examples of better managed 'government public services' in any other country, and would not bring out facts in the form of CMOGE maps. 2FL would invariably make the 'government education services' worthless compared to 'non-government sector' as such action would be necessary to create 'low-CEAK/NAAK' citizen masses.**

The 2FL would however, present such deteriorations under the cover of good words, under cover of religion, traditions, culture, citizen fallacious dignity, motherland honor, patriotism, citizen rights etc to embed these indefinitely.

The uneven distribution of development mainly allocating large sums of government resources to 'big cities' would depreciate the extent of development in 'rural and under-developed' areas. This would cause people migrating from 'rural areas' to 'metropolitan cities'. This is explained in other chapter defining 'center of developments'.

Low-CEAK would turn the people to 'mind set of a slave'. The people who are the victims, would accept DLC as way of life. **This exhibits the transformation of the citizen into 'slave mindset'.** So the constituents of the society balances out amongst themselves and government is free of all botherations. Thus, in this process the 2FL generate an acceptability amongst those who can put forth their protest to the government and demand for an action, to accept the practices of the masses who are undemanding and gradually turns those **who could have questioned the leadership for their actions, indifferent and passive surrounded by problems artificially created by 2FL to restrict their attention and thinking to protect themselves and attempting to struggle out their every day happenings.**

This would sharply deteriorate the social values and quality of life for every body. It is obvious that the migrants from outside region to metropolitan cities would construct temporary shelter, temporary houses and structure, which would convert to colonies, **but without even the basic public amenities like toilets, drainage, open clean environment, hygienic water supply, electricity, garbage removal, cleanliness, underground sewage system etc.** This is an intentional and deliberate permission by overlooking such 'growing up' by the 2FL. **This relieves 2FL from providing the basic**

amenities by the government before the colony comes up which is government obligation.

The 2Face governance shall not prepare the standards for different public services viz. drainage, treated safe drinking water supply, sewage, garbage disposal/collection, education, health services, disease control, cleanliness, public transport etc and notify. The 'standard development index' for different services will not be announced. **Even if the standards have been made, the GPP shall not notify the same on public domain for easy access by everybody and the confirmation for the standards being at par with the best in the world,** shall not be endorsed and notified by GPP, in the shape of 2FL. The CMOGE maps would invariably be displayed and notified for each public services for the region, if the governance is not operational in 2Face mode.

For long the colony may be kept unapproved pretending that government is not aware of such developments. The government presents its high MUBI by presenting its apathy. The benefit to the government by doing so is obvious. **The people who do not have sufficient reasoning powers are normally driven by sentiments, obligations and the direction they are given.** Thus they would be the most certain voters for those who have permitted them to move into the higher ambience and they are 'the 2FL'.

In addition to disturbing the normal life pattern of AAK dwellers, who had the capability to question the government, it takes away their attention from government (2FL) as explained previously. In between the government may generate fear of not approving it amongst the occupants of migrant colonies to keep control on their votes.

Approval of such places by government becomes a big bargain which benefits the 2FL in many ways. **2FL not only get away without providing public amenities to the people but gets monetary benefit due to property escalation** by holding direct or indirect hold on property in bulk in the area. **It may be evidenced that in metropolitan cities even, the colonies are still deprived from the efficiently working amenities which the government has to provide or has provided. Still the public is happy and do not demand for this which itself is an evidence of their NAAK/Negative-CEAK state.** Such practices would not change even in years as long the NAAK dwellers remain in the same state. Either the sewage system is not provided and open drains smelling foul even with the human waste discharged into it, causes potentially unhygienic conditions or the sewage if provided are choked/overflow as the same provided **without any acumen of planning and design to cater for requirements of future population.**

The ineffective 'garbage disposal system' shall also present the presence of 2FL as the views of garbage and dirty surroundings generates 'negative mentality'. **The garbage collection points may be open and exposed, located at places where people reside and pass every movement, like roads, with no effective system of garbage disposal by the government.** The open drainage are cleaned and the muck from the drain is not taken away and piled up in front of houses/on the roads, exhibiting publicly how unimportant the government consider public hygiene is. **Such practices, ugly and shameful, would continue for ages for common public to make them more and more desperate and indifferent from such unacceptable conditions by keeping the people close to pathetic and pitiful conditions for long.** If continuing still in this age of development, awareness, consciousness, the **2FL gets reward for keeping the people perplexed, problem stricken, helpless as they do not demand a change having accepted 'slave mindset' as their destiny.**

In spite of having all the resources at disposal, a **2FL government may avoid to provide even the most essential necessity like treated drinking water to the people** even after having ruled for long. The government would support the inhumane masters

of the community to enable them **to keep their people as slaves in invisible binding, make the people irrational and senseless by playing religion and caste, dividing and making different communities to clash heads on**, to destroy their strength which they might have earned on account of their own efforts. One of the most important principle of this type of rule 'negative person in master (mode)' is that 'slaves' must remain 'slaves' for any time to come and they must increase multifold.

The 2FL would keep the people in pathetic conditions, but use good words; declare them as 'king', royal, master etc to create illusion of being the sympathizer of the people. The 2FL shall be living a very high quality life compared to the common citizen, but on occasions and for intentional derivations, it would exhibit to be in 'brotherly' relations with the citizen by sharing food, living space, embracing arms, honoring them as if they are the master, associating in their personal or religious occasions etc but for short period show off.

The 2FL would have performed in such undesirable anti citizen manner not only to pass time. **2FL would have created massive treasure by launching unreal public welfare and unreal public amenities schemes**, for roads, sewage system, water supply, garbage disposal, drainage etc and **selling its government powers, discretion and authority to mold decisions in favour of those who pays to 2FL for it**.

The master slave model of a government gradually convert the leading people into masters when **they would start diverting nations resources to their own benefit and to any extent and deliberately keep the people short of basic necessities to keep them busy in just fighting for their survival**.

Corruption is not any phenomenon which would ever be on the agenda of any leadership, yet it happens and that too, predominantly. The two face leadership would practice it. The reason is obvious. Because they are working for their selfish-gains as elaborated above.

The basic characteristics of two face leadership of having different public behavior and personal behavior represents this.

Once an average citizen turns into a poor, illiterate and helpless ignored citizen, PITI, detailed in other chapter, it forms a powerful incentive for 2Face leader. The **people/public no longer demand the growth and welfare as their vision for future hampered by their rough and dry present with inhuman living conditions and problems, thus have no time to complain the leadership for not providing what is due to them**. Although the 2FL would pretend to be doing good to the people, they would in reality ensure that none of the GOSIP yields the intended results, goals and benefits to the people so that they continue in their miserable state. **Thus the 2FL shall compose the GOSIP without incorporating the DAVM objectives and goals**. The GOSIP would be in literary form announcing a 'high value' of 'Government resources/treasure' but **not associating the amount with 'verifiable' and 'measurable' DAVM goals on the timeline**. Thus 2FL would **announce/launch/present 'Ghost GOSIP' by presenting the 'government money/funds' allotment, normally a very big and fascinating figure' but without producing the DAVM goals/objectives/achievable/benefits on public domain and public display, thus impossible to verify if anything out of that fascinating figure of government money/funds was spent for the GOSIP and the welfare of the**

people. So the government funds/money can conveniently be used/drained by 2Face Leaders for their selfish gains.

In absence or low level of direct communication between government and citizen, media remains the only link between leadership/government and public. Direct communication impose full responsibility upon the government/GPP for whatever they 'tell, confess, announce, declare' whereas the same conveyed through media relieves government from any responsibility. The 2FL would install the media regime, which we may call as 2Face Media, MADISM, as described in other chapter. **Madism shall be kind of media which would 'structure news from what media see from Government side just forgetting that the prime responsibility media owns is to represent the citizen and not government.**

The 2Face leadership would invariably convert media also to be two face by providing incentives to be so. **Only presenting government GPP point of view, becomes an easy course of action and stands beneficial as they would need government's favor to gain various transmission, broadcasting, presentation (etc) rights which are governed by the government.**

The two face leadership, with NAAK/PITI citizen, 2Face media can therefore, easily exploit the nation's resources, however, the 'Justice system' would remain in way as it would be available to the citizen/people for presenting a case against 2FL. The 2FL would diffuse it by instituting a 'closed eye justice system' regime (these are explained in different chapters). Normally **the laws and legislations are kept incomplete, vague and it becomes necessary for the 2FL and 2Face MGG group to have ill-defined irrelevant, slow and ineffective justice system.** And developing and presenting such a system to people, uneducated and poor masses, is no problem.

And when the two face leadership leads the nation, it would provide special incentives to the MGG for becoming two face MGG by joining the 2FL.

The prerequisites to this would be

- (i) The control of MGG career progression with the GPP/HOG/MOG/OIG and based upon non-verifiable and non-measurable parameters
- (ii) The career progression not related to the 'citizen service' based 'ground facts' and 'citizen happiness/distress' parameters verifiable by the citizen
- (iii) GOSIP structure being without 'DAVM objectives and goals'
- (iv) No RAA parameters and measurements for failures, configured and notified on public domain

The control of career progression under the HOG,MOG,OIG based upon 'application of discretion' and/or based upon vague unverifiable and non-measurable parameters not linked to 'ground facts and happenings' shall cause evolution of 2FaceMGG. Further if the procedures related to career progression are not on public domain, the formation of 2FaceMGG would occur for sure.

The 2FaceMGG would have winning position with the background of a 'permanent service based', if so, as the 2Face-Leader would go after the defined period but they remains for long. In fact the 2FaceMGG, once formed, would be the main source of continuance of 2Face government, moldings the fresh set of Government people to the 2Face norms and system repeatedly. **And it would implant 2Face culture in governance forever, never ending.**

The 2Face governance would have 'Non-DAVM procedures diluting that "recognition and status is not based upon performance at the ground level and performance measurement is based upon ineffective procedures and appraisal, by instituting vague performance parameters, by diluting the accountability towards failures and the assurance that 2FL shall stand by them always to support if they become 2Face MGG. There would be great incentives for the MGG to align themselves to the 2FL which would make life of the people distressed. 2FaceMGG would have reasoning not to do good to the people if the representatives of the public, GPP do not do it, under the pretext of being in subordination/helpless and being dutiful to Government people who are the public representatives, as a part of their statutory obligations. So two face leadership and 2Face MGG would synchronize.

Corruption in leadership is easily understandable. The natural attributes of an ideal leadership are **sincerity (Honesty, devotion and transparency)** and **responsibility (Patriotism and development and security both for people and nation)**. If the people are poor and non-demanding and if adequate money and nation's resources are at the disposal of leadership, there is a strong incentive for leadership to associate their selfish benefits in the nation's money spent by them.

Being in a 2Face governance system, would be an addiction for 2FL and for their return to the position they occupy, they would not mind even to adopt unfair means and procedures. The elections would be like a 'war' if it is 2Face governance regime as the GPP would do anything to 'win' and 'get to the position of self-gains; the government position'. The unusual and unwarranted acts like 'hindrance in the polling procedure, booth capturing, dubious polling machines, violence, preventing people from casting the vote, pomp and show in elections, loud and extravagant shows and presentations, rally if exists, would demonstrate the 'strong footing' of 2Face Leaders and 2Face governance system.

And once it starts, it continues because of being unchecked and also easy victory during the election just by helping the voters financially and/or using criminal base to terrorize them. The devotion and transparency easily falls in line in follow up and the sincerity is bargained.

And if doubtful about truthful projection of 'performance', the 2FL would survive based upon the 'myth factor', making the people to honor the Person like a 'extraordinary' and 'super' person and creating such image by mocked up stories, presentation on audio/video madiak making parallel to mythological character, hiding the deficiencies and failures and presenting the one as 'the only one' outstanding super person. The image booster on madiak, if not presenting an equal number of 'failures' alongside the success, would signify the 2FL in position. Not to forget that madiak stands dutiful and responsible to present the failures of Government people invariably, as brought out in 'madiak' chapter. ****
