

Stupid on Top

Note: This is a modelling and derivations, done based upon analysis of existing facts and evolving reasoning based upon common human attributes, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system or individual in the world'. Any explanation in this 'coinciding with any working Government system or person' shall be an unintentional coincidence only.

Preface

Human have always claimed pride for being human. Argued to be special and privileged. Why special and why privileged? Because of being 'intelligent'. Ever since the evolution of 'life' on earth, the life travelled millions of years from being a creature and evolving into a 'human'. The life developed in many other forms, other than human but none of them ever classified as 'human'. And what makes human different from other forms of life viz animals, just one characteristics i.e. 'intelligence'. But there may be people possessing different 'quantum' of intelligence. Can it be analysed?

Though there are protests if the 'people' are classified in respect of 'religion, caste, race, colour and considered 'inhumane'. But can the people be segregated in terms of 'intelligence'? Why not? If human is proud of being human because of 'higher intelligence' and 'look down' at the animals on account of the same, why these themselves cannot 'classify' in respect of the same?

There are different countries on this earth, who started the process of development at the same time, but evolved differently during the same period of time. Some are prosperous, powerful whereas some others are substantially undeveloped. So what made the difference? One may argue, machines, industries etc are the reasons for their development but machines, industries are only result of the main characteristics the people of these countries possessed. Because the people of these countries behaved differently. Just the 'human behaviour' made all the difference. And why they behaved differently and 'what made the human behaviour' to be different. Just one 'characteristics'; Intelligence. Because intelligence made the people to plan, look into the future, set goals on timeline, pave ways and develop means to achieve the goals, and thus prosper.

So human behaviour is most powerful drive which can change the 'destiny' of whole human race and the most important attribute guiding the 'human behaviour' is 'intelligence' for moving ahead, progress, advancements. Obviously so as this is the parameter and the criterion to justify the status 'human' holds in entire living things. The intelligence becomes paramount over every other attribute to evolve human as the best.

Why then some of the societies, countries would flourish and get ahead of others and on the other hand some would fail and flunk. In case of a country, these are the Government people (Government), who either would happen to be intelligent or otherwise. A government is the most powerful entity in a nation and must have the 'predominant base of intelligence' to take such large number of people to ability, competency and 'success'.

Is it not highly optimistic presumption? The evolution is never uniform. Some would have gained high intelligence but would not have. Evolution is always from 'lower form' to 'higher form', therefore, few out of many would evolve to 'higher intelligence' and there would be many who would not be 'high intelligent' just 'average low intelligent'. Higher in numbers will always impart higher probability of these being reaching 'high', especially where the sole criteria of 'selecting people' is based upon the 'numbers they are supported by'. This would always allocate high probability of 'average low intelligent' person getting selected 'to lead'.

And what would happen if this happens. Where this would lead to? What would be consequences the society and the country would face which has 'Stupid on top'-SOT. What would be the end results and visible symptoms to establish the regime of SOT as it is rare that anyone would have courage to declare the one who is at 'top' as 'stupid and the assessment in this regard would only be based upon 'visible symptoms'.

So let we look for the 'symptoms and indicators' which would eventually establish that it is 'Stupid on top' SOT, if so. And also why at all, this aspect whether 'on top is stupid or not', is so important.

SOT- Stupid on Top

Abbreviations used: ALIN-Average low intelligence; GOSIP-Government scheme, idea, intent, plan, project, policy, programme; GPP-Government people and position; IGPI-Important Government public Interface; DOUEE-Government department, organization, unit, entity, establishment; DAVM-Defined Accessible Verifiable Measurable; CEAK-

Why Intelligence vital:

Ever since the thinking process started in human brain the importance of human brain implanted as the most important organ, not only controlling the body's action but influencing the whole surroundings and environment including other's lives. The activeness and correctness of human brain is measured in terms of intelligence. **Thus intelligence predominantly becomes the most important parameter and dimension which would carry the whole human race forward. The intelligence thus, must be the paramount attribute for selection of people who would be empowered with such positions and authority which would take decisions for others.** Like a doctor who would decide for the patients illness for saving their lives and engineer who would construct Highways, bridges, railways, life saving equipment etc which would eventually be put to extensive use by others. The constituents of the 'country's governance system' are most important people taking decisions for others. Therefore, Virtually in all Country's governance spheres and nations over the globe, such positions must be primarily screened based upon the 'intelligence level' which would result constituents performing professionally, diligently, responsibly and fulfilling obligations commonly and in general. The performance of an individual can be questioned based upon other human attributes however, their selection and placement, if based on Intelligence, has rare probability of being questioned.

Why Intelligence important for Government

So intelligence is sacrosanct condition for the human beings who would take decisions for others and who would do planning requiring ability to correctly assess and peep into future. It is evident that such requirement of intelligence would be more aggressive and more mandatory as the size of such decision becomes 'bigger' in terms of the quantum/magnitude of 'affecting' other's lives and existence and also the 'number of people' getting affected. And the 'biggest' such decisions are the decisions of the Government of a nation. Can there be a decision more significant than the decision of a government? Evidently not. **Therefore, intelligence must be most powerful ingredient and component in the decision of a government.**

What intelligence for Government

In the other chapter ([Excel sheet.pdf on Government Intelligence level and Government Intelligence model](#)), the characteristics of intelligence essential **for government's decisions have been brought out and explained highlighting the required attribute of intelligence as "Analytical intelligence"**. The analysis on government's decisions has also been done in separate chapter (please refer to [chapters: Government GOSIP dissection; Decision theory; and Decision maker vs Decision taker](#)) to assess the 'value of the decision' by the government in terms of a mathematical figure, that is, **a score which is the only way to measure value and worth of a decision/GOSIP**.

The [chapter 'Knowledge spheres and Governance'](#) elaborates the **'spheres, fields and domains' of knowledge which would mould the human brain to such 'intelligence domains' which are necessary for the 'government people' who must possess intelligence and ability of 'visualizing future'**.

Even though intelligence must be the most important attribute in Government's decision making, do the governance mechanism in different countries fulfil it?

Is Government Intelligent? Who cares

First of all, as brought out in Chapter 'Government and Government people are different', the **government's decisions are the decisions taken by the 'government people-GPP', driven by common human attributes of insecurity, selfish gains** and therefore every decision must be affiliated to responsible concerned government person, publicly notified with name and position, fully accountable. Just by 'not correlating' and 'not publicly confessing' the identity of responsible concerned government person along with a government decision, the government would dilute and mystify the accountability of "individual responsible 'government person'". Thus the governments would like to practice it to create illusion and confusion among citizen and to make the Government people 'irresponsible'. **Carrying no 'notified and earmarked' responsibilities would certainly slacken GPP attitude for complying to any responsibilities whatsoever** and make them irresponsible.

So the first condition of intelligent government realm becomes "bringing out publicly, openly and transparently to all" that who is 'responsible and accountable government person' notifying with each government decision.

A Government and governance system which would take and deliver the decisions and GOSIP (=Government scheme, idea, intent, plan, project, policy, programme), evidencing fully transparently and openly notifying to the people and also proving at all intermediate stages regarding fulfilment of 'objectives and goals'. This governance system would evidence the 'sincerity and accountability' of all associated Government people and the 'political party people' in a manner fully disclosed to citizen and anyone who may like to know about it considering it as it's paramount and prime responsibility, regularly and frequently. Thus **highlighting and notifying the actions on the government people for mal-intension, malpractice, incompetency and non-compliance of stipulated rules**. Such government system would be termed as **'Intelligent government system' IGS**.

The IGS shall be confident about its actions and decisions thus notifying to public and citizen invariably and notifying responsible government people and 'objectives and goals' as due. Absence of the same would signify 'irresponsibility' and 'disregard' to 'public service alignment'.

The IGS would also permit outside world to question the concerned government people regarding the appropriateness of their decisions (or no-decision when a decision was warranted) and they would reply officially, openly. This is what 'Citizen forum' would imply to and the mechanism has been elaborated in other chapter on 'Citizen Forum' to serve this objective.

Intelligence: Ignored domain in Governance

Now an important question comes up as to why such elaboration and analogy is required that the 'governance system and government' should be intelligent. It has been brought out in other chapter "Government and Government people are different" that government and government people take decisions affecting lives of millions of people at one time and have enormous amount of nations resources, treasure, money at their disposal.

"But Government people GPP are common people" driven by common human attributes like insecurity, selfish self-gains, ego, sentiments and bias, likes and dislikes and pronouncing self-decisions being 'best' even without furnishing DAVM objectives and goals.

The GPP takes decisions pertaining to future, which needs latest updated knowledge of all sphere, acumen for ability of visualization thus must possess capability of envisioning the future (not egotist forecast), and unconditionally to be exceptionally intelligent therefore. But they are 'common people' possessing 'average intelligence' or even less.

Most of the countries have political party based governance system. And any political party would not keep intelligence as the criteria for its membership as would aspire to have a large membership base. Every society has mix of high intelligent and average (low) intelligent people with more numbers of people possessing average (low) intelligence (ALIN). Thus political party would also have a broad base of people with average low Intelligence and anyone becoming a political leader, would need support of large number members and with natural contention of 'alike person' coming close, the **political leader would have high probability of being average (low) intelligent person.** It is elaborated in other chapter 'Evolution of unwanted culture' that even an intelligent person have incentive to behave like an average low intelligent person in an environment dominated by average/low intelligence people ALIN.

Thus a political leader would either be an ALIN or would prefer to behave like an ALIN even if it is high intelligent person. Therefore, the actions of political leader would conform to the aspirations and expectations and actions of ALIN, thus non-progressive or least progressive.

Ever thought; 'Why intelligence' critical in Governance

Ever thought about a situation that what will happen if a stupid person with low intelligence compared to the higher intelligence available in the environment and society or the country, gets to the top, leading the society or the country? No one thought about it considering it irrelevant and even considering it unreasonable and unimportant because there are no evidence that it was deliberated elaborately ever.

But this is most important to discuss about it. Why?

Just imagine a situation that a stupid got to the top. He/she aware of its intelligence level and realising the fact that it's intelligence level is low compared to the environment and other people in the society, **the 'stupid on top' would have to make everybody else 'a stupid' and 'low intelligence' for its survival.** Let us understand it as ROST, 'Reign of stupidity' as over a period of time, **everyone in the human race shall become low intelligent due to such efforts made by the 'stupid on top', SOT.**

However, intelligence is also implanted by nature. So it can be understood that even though the SOT might try to implant stupidity in everybody else, there would be some people gifted with high intelligence acquired by nature or due to their hard work. These high intelligent people would have only two options. Either to behave like a stupid and average/low intelligence person or leaving that society and the nation.

So public behaviour of people and **if intelligent and qualified people leaving the country and the society, would be an important parameter to assess the state of ROST. The state of ALIN would come out of public behaviour (symptoms)** of common people, shall denote non-compliance of common rules (as would be less aware of rules), reactive, emotional and sentimental (as would lack reasoning and analytical skills and knowledge), showing haste and abruptness (feel of insecurity as would lack assured consolidated visualisation of self-progression), pushing others back/criticizing others/ claiming others responsible without verifiable and validated evidence and substantiation to install self as most deserving (lack of self-confidence; lacks self-assurance regarding its success on merit), forming mob (lacks confidence to stand of its own), shouting and reacting (lacks reasoning) and attempt to overpower others otherwise.

It can be well understood that an ALIN would succeed overpowering high intelligent person by using the above characteristics and behavioural shows. And now to safeguard itself, the high intelligence person would invariably has to adopt the same behavioural show, corresponding to the behaviour of ALIN. And thus high intelligence person would have to fall in line with ALIN in behavioural shows and behaving like a low intelligence person of the society. **So if stupid gets to the top, the entire society and human race of that domain or society would turn into stupid and few who are not stupid, would be made or would opt to present a public behaviour of a stupid.**

Can there be anything worst beyond? Now it must be a regretted by everyone that why this was not discussed and analysed earlier that 'what would happen if a stupid gets to top'.

But still the worst is not discussed and disclosed yet. Let us try to understand in reference to the nation's governance system as it takes decisions influencing millions of people at one time.

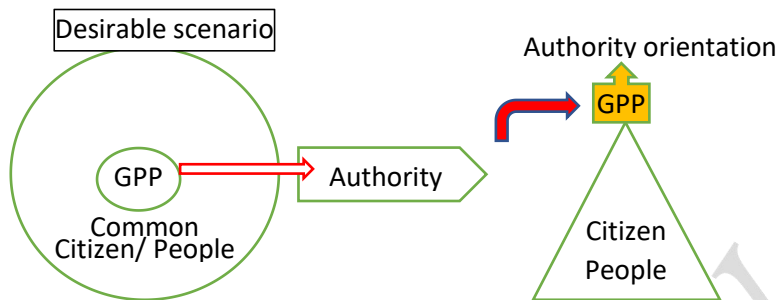
There are severe consequences (Con), many more, if there is SOT.

Con1- Authority Orientation: A SOT would, again for its survival, install the hierarchy of 'authority' in the governance system. The SOT would have to, may be artificially and fictitiously, present itself as 'one and only one' an outstanding person, irrespective of facts on the ground. Once again firstly, **SOT would make best efforts to keep the people at low CEAK level, non-aware, non-awakened, ill-knowledgeable**, so that it's made up projections of 'being outstanding and unique' are not challenged.

But the possible questioning cannot be ruled out. And if someone challenges it, the SOT would use the government's authority and GPP provided with such authority to suppress. Thus becoming into the **'authority mode' would be a compulsion for SOT and an important indication of SOT regime.** Thus SOT would deviate from 'service provider' orientation to 'authority orientation'.

So authority orientation would cause GPP/SOT to quit the 'service orientation' which was the sole objective of their existence

The 'authority orientation' by itself creates serious anomalies and aberrations. If we try to view it from governance of a nation's perspective and applying to the Government people GPP, it signifies that GPP (HOG/MOG/GPP) would treat them as superior, a 'master' and isolated from the common person. **Thus breaking the sentimental bond on which they had acquired the citizen trust to rise. So the GPP would neglect common citizen distress, troubles and hardships.** This is elaborated in the chapter of 'Master slave Governance' and may be referred to.



As explained in the chapter the gradual separation intensify into permanent separation transforming GPP into 'masterism' and disregard their 'dutifulness' towards 'service orientation'. It is also explained in the chapter of 'Master-Slave Governance' that **a master would survive only when others are slaves and therefore, now GPP would turn the common citizen to 'slaves', making them to fight for food, clothing, shelter, daily livelihood necessities** and to further show its 'masterism/authority', GPP would give the poor citizen meagre help by distributing money, food etc. in the name of empowering them but converting them to timorous timid masses who would lose their own existence and just leave them on the mercy of GPP. Also **looking at others as being slaves, the GPP would have aspire to be a 'master' for all time to come and would realize the citizen masses to be 'slaves' permanently, effecting least efforts for 'measurable-visible DAVM citizen welfare'** (Please refer to '2Face model' of a Leader)

So GPP/SOT would get to 'Masterism' ignoring common citizen distress and hardships aiming to turn them to slaves

And a GPP with characteristics of a SOT, in this form, would acquire the 'authority orientation'.

The **authority would be visible or rather made visible to the people** by virtue of deliberate actions intentionally presented to public so that they are discouraged to point out deficiencies of SOT. **The following would be inevitably visible indicating presence of SOT:**

1. No CRAG and no 'Citizen forum'. The CRAG and 'citizen forum' shall not be discussed at all. People's reporting about distress/problems without human interface, would be absent.
2. Low government transparency. the government action shall be known through the media/MADIAG and through news makers and the GPP/MOG would not directly present to the people officially (Please Refer to chapter on 'Direct communication')
3. No direct communication or Low direct communication between government and citizen. (Please Refer to chapter on 'Direct communication')
4. No presentation of public agony and problems: The GPP shall not present the cases of public distress like the cases of rape, murder, crimes, abduction, kidnapping, torture, livelihood problems, scarcity of food, potable water, shelter etc. So much so, the

[MADIAK/media](#) (please visit the chapter) would also not present the cases of people's distress on everyday account. This is detailed in subsequent elaborations.

5. The government would not present the CMOGE maps (see the chapter) of regions/unit regions of public services
6. Government would not end pact of GPP who would fail to control the reasons causing people's distress/ agony and problems and GPP would not be announced responsible even for severe distress to the people like rape, murder, abduction, causing disability, looting, robbery, frauds, people killed in riots-adulteration, etc.
7. Government units /organs of interrogation and investigating attributes would not announce publicly the details of charges/ accusation on anyone including prominent people aligned differently, before putting hands on their collar
8. Government units/organs would have big establishments, buildings, assured money/salary and comforts from government,
9. The CCTV recording of each Government space and place and IGPI with open view/review, would be missing.
10. Political party people would display their position prominently highlighting the government position, even if temporary and honorary
11. The GPP and politicians would be known by their position primarily and they would introduce and present themselves quoting 'position'
12. Government units would not display the 'rules and procedure' of dealing with official matters, applicable to GPP, publicly on public domain and outside DOUEE establishment
13. Government units would not display the details of responsibility and accountability, prominently displayed, in front of office building for GPP, at least four top Government's positions
14. Public complaints domain would be missing/or not 100% working and real time account of complaints presentation would be missing for public.
15. The time gap between occurrence of crime and punishment to the culprit would be higher than the threshold limit of justice delivery (please refer to chapter-Justice system).
16. Non-notifying publicly on public domain, the RAA associated with each GPP position.
17. Not notifying the DAVM objectives/goals of Government's decisions/GOSIP,
18. Not notifying the MUBI score of Government's decisions/GOSIP, Low (negative) MUBI score of government decisions continuously and no sincerity to assess, reveal and upgrade it.
19. Not notifying the Political party and political leaders MUBI score at least top four levels,
20. Low negative MUBI score of political party and political leaders in political party based government,

The authority orientation would be an important symptom to earmark SOT Government.

Con2- Fraudulence

As SOT would be short of requisite level of intelligence/analytical intelligence, calibre and thus sincerity towards DAVM assessment of its actions and plans, the SOT would have to cover up these with made up stories, narrations, statements, slogans, presentations without revelation of DAVM substantiation of achievements.

This would cause emergence of **Con-2 i.e. Fraudulence**:

For SOT, like authority orientation, fraudulence would be major modus operandi of SOT for survival. The fraudulence would be evidenced if:

1. The Government's notification/presentation and media presentations in praise of the government HOG/MOG/MGG are without evidence in mathematical statistics/ data, terms, absolute and relative on time line for relevant period
2. No government designated platform and government people for government announcements/presentations
3. There is variation of price of most important consumable items over the year more than 10% between maxima and minima.
4. The government awards /denominations without presenting 'analysis of achievements' and 'benefits accrued' in mathematical terms and with ground level evidences
5. Government and HOG/MOG promises /declarations are not continuously analysed and evidenced in DAVM terms verified with ground facts certified by concerned people
6. Supporting GPP with elevation, revenues even though the deterioration occurs in human safety, survivability and government public services
7. Government presenting the success stories of GPP even if one in thousands, but not the failures and deficiencies
8. Madiak/media presenting the success stories of GPP even if one in thousands, but not the failures and deficiencies
9. Madiak/media not questioning the failures of GPP, earmarking the GPP in person but presenting only statements, narrations in non-DAVM terms
10. Different public statements pertaining to same issue presented to cause illusion, confusion
11. Not notifying GPP at top two levels, as authorised to announce government actions and policies, GOSIP, and not ensuring that only they make the announcements on behalf of the government
12. Government's political party presenting HOG/MOG/GPP as supreme, outstanding and doing wonderful without validation with analytical analysis and DAVM facts
13. Not restricting announcements regarding government's action, policies & GOSIP by political party people and legislative assembly people
14. Visible prominence of 'Master's tools' ([please see the chapter](#)) in public life

Following explanations would elaborate the above points.

Fraud 1 Con3- Ambiguity and haze-No accountability

The SOT would never like to lose its position. SOT, because of inherent feel of being less intelligent and instable fortune compared to outside world, suffering feel of insecurity and possessing inherent deficiencies on this account, would 'exercise authority' to keep itself higher than those who possess higher intelligence present in the environment/ outside world. And with feel of being less intelligent but having acquired the state of "authority", the **SOT would tend to present its actions as 'grand success' even though it might be a failure, and to hide, it would make unsubstantiated, un-evidenced presentations/achievements/claims without quantifying the success/goals achieved/ benefits acquired in DAVM; mathematical terms/ mathematical figures, statistics, data, curves.**

The government GOSIP would lack the details of DAVM objectives, DAVM goals on timeline, DAVM benefits on timeline as for making DAVM goals and foreseeing DAVM benefits and notifying the same, need high intelligence.

To facilitate such presentations, SOT would not notify and establish designated Government platform and not notify authorized government people for presentations

of government-GOSIP. Instead of that the Government talk about its actions and achievable, **anybody would be permitted to speak about the same, especially those who had no role in the decision making**, like political people, political leaders, GPP having no direct role, general public etc. Anybody would talk about it but not the HOG, MOG, GPP who were directly associated in decision making

Fraud2 Con4- Made up /falsification

If this is practiced by SOT continuously, the same may be questioned by the people in the country or abroad, so SOT would use media/ madiak as the tool. The **SOT would control the media/madiak and /or own audio/ video media** to narrate that SOT is doing wonderful and outstanding without substantiation in DAVM/mathematical terms. The mathematics, obviously is subject of intelligence and is the basic tool/science for any analysis. SOT however, would avoid the mathematical analysis to **make slogan and narrations based non-DAVM thus, 'fraudulent presentations', mostly through the media/madiak.**

As it would be necessary to transform madiak/media into a domain of MUBI (Murkh, Beiman, impotent), the madiak 'madism' score would be low (negative) which would **earmark the presence of SOT.**(Please refer to madiak chapter)

Falsification would signify the difference between what the GPP should do and what GPP should have done. If there is unemployment rising and the GPP claims (or media presents) to be building up nation or the society, it signifies falsification. If the people are not having adequate resources, earning, money to afford good food and the GPP says that the people are happy, it signifies falsification. If there is flood and the GPP pretends to organize 'havan/prayers' to get the people free of the troubles, it is falsification.

So falsification is the difference between what GPP doing and what GPP should do. It must be understood very clearly that it is responsibility of the GPP to prove, with evidence to be widely notified, that whatever GPP was doing, has really helped the people, and if it is not proven, it is falsification.

GPP would certainly opt for keeping 'mum' when there are adversities being faced by the people so that he/she could not be set responsible and people just keep on struggling with such adversities directly, however, this would again be 'falsification' as GPP was responsible to 'stand' with the people to support them. There was a news that the Prime Minister of a country was helping people evacuating from flood waters, standing in 'flood waters'.

Fraud3 Con5: Government is lost; others bark: It is highlighted in the chapter of 'Government-Citizen Direct communication' and 'Chapter of Democracy' that **direct communication between Government and citizen is the 'spirit' of 'democracy' and 'Independence'** for which each 'government and 'government people' must be accountable to. And also, **Government is the entity at origin, to begin and carry on the 'Direct communication'(and not the citizen).** Therefore, 'Government (Government people HOG, MOG, GPP) can only ensure that it happens perfectly and without ambiguity, and citizen cannot be said responsible if the 'direct communication' would lack.

But the **SOT government and governance system would deliberately avoid and evade** this important 'government responsibility'. And may even set citizen responsible for lack of direct communication. The reason can simply be understood that if it exists, the outer world beyond Government and GPP, would come to know about the incapability/incompetency and low intelligence of SOT Government and GPP.

However, the government and GPP have to continuously present to the people that they are working, good or bad, (obviously GPP would not let 'bad' to be surfaced out; so only 'good') and the government would need a 'communication channel'.

Government and GPP would certainly pick madiak/media.

Therefore, for SOT, the media/madiak would be the prime platform to spread fraudulence on part of the government, and madiak would do so willingly (or unwillingly). The media/madiak has access to millions of people at one time and **SOT government would invariably exploit media/madiak to propagate the fraud-2**. SOT Government would install media/madiak as the prime source of 'government news', **SOT would not install announce and use the government's official platform for government/HOG/MOG/GPP announcements/GOSIP**. Instead SOT would provide information to the media/madiak as it would amplify issue (or nullify issues as needed) the way SOT government/GPP would like it to be, in admiration of government and GPP/HOG/MOG. As mentioned in the chapter (please refer to madiak/media chapter) madiak would also like it as it would get news without any efforts and hard work and would not mind presenting 'made up' and 'exaggerated' news in favour of the government/GPP/HOG/MOG. And also 'abolish/curtail' news which are not to favour SOT (HOG,MOG,GPP in such form). Not, only that, media/madiak, by doing so would spread fraudulence (of SOT GPP) but would install fraudulence in itself too. Madiak fraudulence is discussed in the sub-title of Madiak/media in subsequent elaborations.

In addition, others like the **Government's political party people, would come up to explain the 'Government's GOSIP' to justify, even without DAVM objectives and goals analysis.**

Fraud4 Con6- Disabling people;

Creating mental handicap Driven by the trait of fraudulence and in quest of continuing in the domain of government authority, **the most important aspect and consequences of SOT governance is that, for its survival, SOT would make everybody else 'stupid and low intelligence'**. If there are majority of intelligent people all around, they would become a preferred choice for governance and once they takeover, the SOT loses its identity, power and position. **SOT would therefore, tend to make everybody else 'a stupid' for its survival and revival.**

The analytical and visionary sciences, engineering, medical, finance, environment sciences would not be highlighted in the government decision making body and mechanism, neither madiak would lay emphasis on such traits. The madiak itself would not possess such high intelligence level to produce such presentations, which would encourage SOT to make GOSIP just slogan based, aimed to highlight an individual or group.

The **government GOSIP would lack the details of DAVM objectives, DAVM goals on timeline, DAVM benefits on timeline** as for making DAVM goals and foreseeing DAVM benefits and notifying the same, would need high intelligence.

And making such presentations, announcements, declarations in abundance, making it a routine, convert people to be passive and indifferent to think, evaluate and analyse. They would become 'inert' and 'malleable' and 'timid' people. The madiak, if in the form of 'true representative of the people', would bring out the deficiencies of GOSIP, HOG/MOG/GPP statements, declarations to protect the people from becoming 'fearful, confused, unsecured', but if madiak/media would practice MUBI-dity, Murkh/stupid Selfish media, these traits would be converting people to 'mental slavery' like a slow poison. In such a state people would associate their existence with the existence of SOT, thus losing their identity. They would present themselves as a 'follower' of somebody higher (SOT) or member of some group/political party as they would lack strong 'recognizable base' of their own calibre, qualities, eminence, qualification, intelligence. The SOT therefore, would create mentally disabled masses.

The people thus becoming mentally disabled, incapable to analyse, unable to talk logically and with reasoning would be criticizing others to prove that they themselves are correct, claiming themselves stain free as the mistake they have committed is justified because it was committed earlier also, picking someone as 'master' and feel great in becoming its 'slave'.

And the SOT would pronounce itself as the 'slave' and 'people' as 'master' to hide its intentions and actions.

Downcast Education: It is well known and established that intelligence corresponds to education. So, SOT would first structure the education system with little or no screening based upon intelligence. The education system will be structured by SOT in 'run through' form where progression shall not be based upon the stringent screening to test the intelligence level but screening would be a mere formality with easy and/or unobstructed progression.

The education shall restrict exposure to 'best intelligence based happenings in the world', actions/achievements presenting outstanding calibre in the fields of analytical sciences, the fields of developments where the world is moving to etc. This would be done to contain their intelligence which would ultimately 'result mental disability'.

The education focussed on stories, mythology, narrations, memorizing person based personal facts and memorizing past events without analysis, non-mathematics base, non-visionary sciences based would be promoted by SOT as the bench mark, so that people are just able to access 'Average Low intelligent' attributes and feel happy with it.

Throw penny to extend charity:

Another way of disabling people is 'extending meagre help as charity' EHAC- The SOT would mentally disable the people as derived above. But this is likely to become known gradually and would become a point of criticism against SOT. Also the people becoming desperate of not 'able to come up', shall start reacting and agitating. The SOT would have to gain their attention and praise and break their mindset from becoming agitated against SOT. The SOT would extend a help which is monetary, insufficient, temporary, unscheduled to the people like a charity. Being monetary, it would yield immediate appreciation, being insufficient would ensure that no 'upliftment' occurs in their lives, and temporary & unscheduled presents it as a mercy showered by SOT upon the people. This

would dump and crumble any attempts being made by people to struggle out of miserable state, as no such opportunities made available by SOT, and look forward for another round of 'charity' like a beggar does.

The SOT would not forget to extend this 'charity' under its name (or allied names) and present it under a scheme using 'glamourized and fabricated' name with the motive of people looking upon SOT for further help, and thus becoming its slave.

Fraud5 Con7- Presenting the higher intelligence in subordination

After all any SOT cannot ignore the higher intelligence level of outside world compared to SOT owned sphere, indefinitely, even after embracing 'authority' and assuming 'fraudulence'. It is because of the simple reason that SOT might stop mental evolution and progression within its owned realm and the sphere under its influence but cannot control the 'advancements and upward transformations' occurring in outside world which sooner or later would surface out inspite of exercising 'authority' and inspite of using 'stupid and selfish madiak'. And then SOT would have to recognize openly that the 'SOT domain' needs expertise of 'higher intelligent people' from 'outside world'. But at the same time SOT would ensure that these 'intelligent people' 'do not do' and 'do not speak' against the 'SOT Sphere' people. So what could be possible? Presenting another fraud by SOT!

Simple, just hire them temporarily, keeping remuneration and performance evaluation under control of SOT directly. These **'high intelligence people' now would be driven by 'self interests' and for their continuance of 'temporary assignment' further, temporarily, they would comply to 'SOT' 'point of view'. This would present three important dimensions;**

- (i) The high intelligent people would be driven by 'self-interests' compromising in principles and ethics. This would obviously not happen if SOT would not initiate and promote such depletion in the behaviour of 'high intelligent people' **implanting insecurity.**
- (ii) The high intelligent people would work temporarily, thus may 'disappear' after the period ends, thus evading responsibility. **SOT has excuse not to have assessed their outcome because of 'it's known' incompetence.**
- (iii) And there is no restriction in **selecting the 'lowest intelligent' person from the lot of 'high intelligent people'**. Facing apprehensions of getting replaced by 'more competent' person, he/she would comply to the 'view point' of SOT.

Thus **SOT would 'fictitiously' present to the world that the 'decision making' is using 'high intelligence domain' but getting his/her own decisions implemented.** This would happen inevitably, if the payments of remuneration; continuance of assignment would be in the control of SOT.

The only way out is; specified DAVM objectives openly presented by SOT; notifying the standards and norms publicly and payments of remuneration is assured through independent unit not under the control of SOT, against those DAVM works.

Fraud 6 Con8- Highlight one; leave the rest

Inspite of whatever are the constraints and hurdles, few people would always come up overcoming all obstruction and perform by virtue of their hard work and natural calibre. These would acclaim higher goals because of their personal efforts, perseverance and

calibre and achieve status of eminence. The SOT would not have rendered any contribution, pre-notified for their success. The contributions made by the 'government and GPP' enabling the persons for exemplary achievements would not be notified all through the process of its preparations and would recognize the 'achievements' only when he/she has performed and become well-known to entire nation and/or the world. **The SOT would 'hug' the occasion and amplify the accomplishments by 'awarding' and 'associating' the achiever with the nation, "as nation would correspond to the Government and the SOT".** And that would be the 'end', just to forget that there are many others who would perform exceptional if "Government" help those, under well notified program, defining DAVM goals for Government, notify the goals and making the concerned GPP accountable notified on public domain".

Fraud7 Con9- Use of Master's tools: The SOT, in quest to disable the people mentally, would use the 'master's tools' ([please visit chapter-'Games of Masterism in Governance'- 'master's tools/tricks'](#)). The only truth in this universe is 'Time', sacrosanct, inviolable and every entity including each person have to move along the 'TIME' and that is 'success'. Only incapable people would not be able to move with time. And if vision, thinking process of the people is impaired, they would not be able to progress with time, thus would be helpless and wretched looking for other's help. The SOT would do so. **SOT would tend to stop their vision for future, progression and advancements by 'reversing them, their attitudes to the past', believing them that the myths/mythology of the past is ultimate to be prayed for, using religion, mythology, divinity, invalidated beliefs, stories, past practices, culture as tools to make the people to believe these as ultimate aims in the life. These are known attributes but used by SOT as 'Master's tools' to stop 'mental progression' of the people; with time'.**

The SOT would apply the games/tricks misusing religion, region, caste, race, culture, language, social practices, customs, mythology, names, characters in a manner that it would cause the people to believe that the 'past was best' and since it is gone already, there is no use to pursue any goals further, in the future.

The SOT would present past happenings, mythology, stories, characters as the ultimate and would link those happenings with 'divinity' to generate a belief that 'best has already gone' with the past and since no further best is going to come up, the people have the 'worthy' job of 'uttering those stories' loudly and in 'masses' and 'praying' those characters of the past mythology. And thus live in the past and fall behind 'in time' from those who are 'moving with the time', realizing that 'TIME WOULD NEVER COME BACK AND FALLING BEHIND IN TIME, WOULD BE THE LOSS FOREVER, SOT would stop the 'progression of the brain' by using 'attributes in the form of 'Master's tools'.

It is explained in chapter (['Games of Masterism in Governance'- 'master's tools/tricks'](#)) that the SOT, getting into the form of 'Masterism' would like to keep the people entrapped in 'miseries and distresses so that they remain occupied in resolving 'basic livelihood sustainability' problems and have no time to look at the 'actions of SOT'. **The SOT would have deliberate aim that 'crimes-rape murder looting etc 'dearth' of public services, social disparities, social evils, adulteration, scarcity of food, low quality eatables, social disputes, disintegration; never ends and would keep hidden its supportive and making up efforts.**

Fraud 8 Con10: Become a MUBI-appear as noble

Government are the people with absolute control on the nation's resources including nation's treasure. But these resources are lawfully and ethically to be used for the people/citizen. And a GPP in service orientation would always do so. However, the SOT (HOG, MOG, GPP in such form) has insecurity as elaborated above and does know that once not in 'government position', it would be 'extensive and un-recoupable' loss in the life. Like a dreadful dream, if it happens. **This creates a fear of falling 'heaven to mud' HTM fall (to exhibit the relative status).**

And the SOT is at the position of 'possessing control over enormous nation's resources and treasure' and 'extensive powers' to consume and spend. The fear of HTM and having 'someone else enormous fortunes' in hand would obviously cause 'hunch' of 'grabbing' it for self, thus earning selfish 'self-gains'.

Selfish gains: The attitude and intention may occur in any individual under such situation and will occur in SOT too. **And for doing so, the first thing SOT would do is to install itself as a 'saint' so that people do not even think about SOTs state of possessing 'selfish gains' attitude.** And as explained under madiak/media exploitation by SOT, madiak/media would be the course to create this hype. The toxic destructive role of madiak/media, even to cause 'mental disability' to the people, has been discussed in [Con20](#), which would, by virtue of 'haze, incomplete, implied' presentations, might place and present SOT as 'selfless person', quoting slogans, narrations, stories about SOT but without validation and DAVM accomplishments, thus not presenting the SOT as 'validated intelligent person' but making fuss with stories, slogans, narrations, poetry and such gimmicks.

The noble HOG, MOG, GPP and noble madiak/media on its behalf, would always present DAVM GOSIP with DAVM goals, achievable on time line, DAVM goals/benefits achieved in past which must be pronounced from 'Government's recognized platform' and must be 'by GPP at top four positions'. This would be the first representation of noble HOG, MOG, GPP not driven by 'selfish gains' and noble media.

If not happening and complied, the SOT would evidently exist in GPP even though the image of 'saint' might be published to people.

The SOT because of inability of making 'intelligence based' DAVM based, GOSIP schemes, proposals, plans; SOT would render to make 'fascinating and glorifying' but vague schemes, plans which would leave the people 'mesmerized' and 'captivated'. **Schemes and plans if announced with a very high value, millions and billions, but without disclosing the DAVM end results and benefits/beneficiaries, would yield the same, 'Mesmerized and astonished' people but not knowing 'what they would gain'.**

Thus if it happens, the SOT would evidently exist in GPP even though the image of 'saint' might be published to people.

The other representation of **HOG, MOG, GPP not driven by 'selfish gains', would be that evaluation of people's/citizen distress' shall be done for safety, security, livelihood means availability placed on public domain for each unit-region and GPP punished for failures, exhibited and notified publicly.**

If it is absent, the SOT in GPP is evident even though the image of 'saint' might be published to people.

Fraud 9 Con11: Exhibiting incompetency flagrant: Someone getting bankrupt and the auction of assets might have been seen in the movies or in real life. But it is always associated with 'failure' on part of the 'asset owner', not to have performed with ability and competently. It is always related to 'falling short of resources' and 'support'. However, in case of Government, the 'falling short of resources' and 'support' is conjectural and imaginary. Why?

Can there be any doubt to anyone that the Government is the most powerful entity in a country? Not obviously! So a 'Government' should not be helpless, anyway. **So in case of Government and GPP, only reason for any sale of assets would correspond to 'incompetence and unsuitability' of GPP; signifying SOT.**

In the chapter 'Why a Government', it is elaborated that the Government must provide affordable but high quality services regarding education, health, energy, infrastructure, essential food items, transport to justify its existence and to form a 'benchmark' for non-government units to compete with. (please refer to 'Foremost responsibilities of Government') For the non-government providers in the form of business units/companies, the government must have at least four 'government establishments' providing products and services **at notified, validated minimum cost, to provide 'competition' to non-government entities**. If this does not exist, the GPP would be attached to selfish-gains through the non-government entities as brought out in chapter 'Vicious spheres of un-democracy' & 'Amiss routes on Governance'. Deletion of Government unit, properly managed by competent GPP, shall signify 'eliminating the basic benchmark' and support non-government units to offer unreasonable terms and conditions and unreasonable cost of services.

However, SOT would not provide the services due to lack of vision, planning, acumen and resulting over everything, being in 'Authority mode driven by Masterism' and creating slaves.

Although, as mentioned above, every 'sale of assets' signifies the 'incompetence and unsuitability'. However, **'incompetence and unsuitability' can be earmarked if the parameters and measurements are 'completely and verifiably' defined and if it is not, again the SOT is evident.** The most important indicator and symptom would be 'not setting accountability for failures, including sale of Government assets and GPP not sacked for their failures. **The 'incompetency and unsuitability' will rise and lead to 'more authority and more masterism', consequently citizen more suppressed.**

The government people have control over enormous resources and 'government powers' which are needed by the non-government entities. They, non-government business domains, would like to acquire the nation's resources for their benefits and would have proposals of association with GPP and government in any form, associates, partnership etc. Government has much more powers and anything which would generate **such inclination of joining with non-government sharing the 'Nation's resources' with them, would therefore, be only 'selfish self-interests' of GPP.** If sincere and competent, Government/GPP would itself do what jointly these intend to do. **Partnering with non-government and sharing nation's resources would therefore, imply incompetency on part of GPP, but enormously benefitting GPP as sharing anything, money, property etc with partner would be legal, ethical and unchallengeable. So transferring benefits**

from 'Nation's resources' to (self) GPP, unethically' but making it legal and unchallengeable. So GPP benefitted by becoming incompetent and also partnering to share nation's resources(ethically under 'Citizen') with 'non-government' entities, thus using government powers unethically .

Fraud 10 Con12- Accepting incompetency; not rejecting

As above, the SOT would invariably lead to the GPP in 'authority mode' and moving away from 'service orientation'. There are hierarchy in the Government organization and let we define these as different levels say L1, L2, L3.... where L1 is highest level and L2 under L1 and so on. The different levels obviously, are created to disseminate the services equally to wide base of people. And thus L3 performance would be supervised by L2 and likewise for other levels. **As explained in F6, F9, the GPP is getting benefitted by exhibiting and practicing 'incompetence'**. Thus incompetence would not be a 'taboo' under SOT. And also SOT would ensure that everyone is 'mentally disabled' and 'low intelligence'. To avoid this to be pointed out by anyone/someone, **SOT would implant an environment for 'not aspiring to acquire high intelligence' and 'everyone accepting low intelligence as prevailing attribute'**. Thus 'low performance level and incompetency' would become acceptable in GPP too.

The SOT sphere of people thus, would be low intelligence and incompetent people.

Thus as elaborated earlier also, **the SOT would cause universalization of stupidity and/or Mubidity from Government to the common people.** Truly so as otherwise the 'high intelligence domain' shall come up and present a challenge to SOT.

And **acceptance of stupidity, inaction, and incompetency-SIIN would be the only option with SOT and shall be visible in the form of undefined and low Responsibility and Accountability-RAA assigned to Government people and positions.** (please refer to the chapter on RAA)

Unbest in Government: Still those few, who are intelligent, would create a place of recognition however, if the Government and governance system would place them along with low intelligence domain and deprive them due recognition and higher place, the intelligent people would keep away from government sphere. This would create a **low intelligence domain LID, in government sphere and this is what SOT would desire to be.** So SOT would install the processes and rules which would ensure that the '**unbest (not the best)**' people in terms of intelligence, without analytical and visionary education and abilities base, dominates in government sphere. It would also reinstate that **SOT would ensure everybody else to be a stupid and would confirm this to happen in government sphere first.**

To realize the aim of spreading stupidity, the education system of SOT Government would focus on the flimsy articles, stories, stories on people, mythology, religion, talking on theoretical events etc.

and **not on** best in the world in engineering, medical sciences, space sciences, environment sciences, mathematical sciences, machines, construction and structures, mass transit systems, best transportation systems-road, rail and air, computer technology, research and inventions etc. The **SOT education system will talk about stories much more than practical happenings.** It would lack practical aspects with application thus hampering brain development, restricting intelligence upgradations, containing enhancement of productivity. Slogans, poems, narrations, stories, myths, events,

histories would be stressed in educational system created by SOT. (please refer to the chapter on CEAK/AAK and Average citizen).

Naming anything as 'Best': Often you might come across statements using exaggerated hyper expressions like 'Best, Number one, World class, unmatched, unique' etc without any mathematical supportive derivation and/or mathematical score and/or qualitative analysis but 'bubbled up' like a slogan, phrase or literary word. Use of such expressions without mathematical analysis and substantiation, without associating DAVM parameters, would thus be 'act of deliberate fooling'. The hypothetical and theoretical expressions like 'bringing heaven on the earth, the God is with us, God witnessing, God showering blessings, success will come one day etc which cannot be verified, cannot be measured and remains only emotions creator, are the acts of illusion. Without establishing and notifying the parameters to assess status of "Number-1 or the best or world class or the one or international fame or unique" etc, **the use of these terms would remain 'statements of a MUBI' who either is 'stupid' not to understand the 'gravity' of these words or is 'selfishly' attaching such status as fake presentation.**

Fraud11 Con13: Treating nation's resources as personal:

In the chapter '.....' it is explained that the GPP with relatively low intelligence (SOT) compared to the outside world, would lack to perform to the required level of eminence, not producing such results which the GPP itself can present with DAVM evidence and validation confidently. And if the people acquire such understanding, it would be detrimental to GPP's existence. **With lack of calibre and competence, the SOT would have the only choice as 'self-publicity', non-DAVM, slogan, narration, story based. Ethically the self-publicity, i.e. publicity of a person, must be using its personal resources. But when Government resources, government money, government people, government powers are at disposal, it would obviously be used by the SOT for self publicity; though unscrupulous. The self-publicity will be using government's resources in non-DAVM form. And the orientation would be 'projection of person or persons' and not the 'verifiable and measurable actions', because actions would need DAVM elaborations, which SOT is deficient of?**

This has been explained in chapter 'Vanity exploiting Nation's money' VENAM which may be referred to. Ideally if good results of 'government actions' have reached the people, any publicity is unwarranted as people already know about it. **Publicity, that too, of a person or selected lot, by name, photo, elaborations, person's stories, person's sayings, if being done, the prominent reason, as derived, would be 'deficiency of presentable and appreciable' achieved verifiable and measurable results.**

And it has been explained above and as follows, that **madiak/media malfunction, not functioning as 'true representative of citizen' but acquiring MADISM, becomes the most destructive result.**

Fictional GOSIP: Another outcome of F11 shall be the presentation of 'fictional GOSIP'. The SOT would use nation's resources and treasure to float such GOSIP which might not correspond to the 'correct venue and correct direction' which would have produced the 'most beneficial' and 'most worthy' results to the people. This would be the **spending of (i)enormous amount of 'nation's treasure' and (ii)'hazy & non DAVM' GOSIP' would signify 'diversion of nation's money' to unknown unclear purpose and people. The**

GOSIP shall be without 'DAVM goals on timeline' and against 'resources spent', without certification of GOSIP being 'essential' and without presenting and not notifying 'benefits in DAVM' parameters. **The GOSIP would be structured for 'personal selfish gains' unless DAVM objectives, goals on timeline, DAVM benefits on timeline, spending against benefits are detailed publicly from government platform by top four GPP (HOG, MOG, GPP1,2..).**

And SOT would have no calibre and competence to structure GOSIP in this manner with explicit DAVM objectives and goals.

And non-DAVM, not responsibly notified, vague, non-transparent GOSIP would be an incentive both for the GPP and also for the 'business domain' not to talk and present DAVM goals /achievable, time bound. And if not absolutely transparent and complete, the motive of GOSIP would invariably lead to 'selfish self gains'.

Therefore, the SOT would just announce the size of 'government spending' in 'millions/billions' in GOSIP, but no DAVM objectives, DAVM goals, DAVM aimed benefits on time line, shall be notified.

Fraud 12 (Con14): Fly high-n-high; but ON Ground: symbolize everything as it would take away from facts

You must have come across the poetry mentioning 'fly high to touch the sun', 'run like a deer, roar like a lion etc. However, there is no one who can fly high to touch the sun or run like a deer or roar like a lion etc. So fact and reality are just opposite to what someone mentioned, rather an 'exaggerate and inflated' act or super-person, which unfortunately happens to be 'untrue'. Here **untrue would signify any act, work or performance expressed in words but 'cannot be verified, validated and evidenced with visible verifiable and measurable parameters.** Let us call such expression as 'untrue unverifiable but made to believe' (UMTOB). UMTOB would be an act of symbolizing some hypothetical characteristics establishing correlation with 'best and supreme' but 'unverifiable and invalidated' in reality.

If it is said for an existing normal person, this would be an act of 'deliberate viciousness' and 'attempt to make fun' ridiculing the reality by comparing it with something 'just opposite', 'something superfluous' in words.

SOT by virtue of being stature of incompetency and inconsistency, would lack the praiseworthy DAVM realities and would have to present its actions as UMTOB, exaggerated unverifiable expressions. Not only this, SOT would have to suppress the 'contrasting' facts by providing a cover of 'overstated' prodigal unrealistic phrase/expression.

You may wonder as what it has to do here. Ok. If a 'poor person' is called a 'king' in narrations, a girl victim of rape as 'brave girl' making poetry or story, women victim of torture and assault called the 'pride of nation' or mother/daughter of nation, media pronouncing 'nation is looking upon you', 'country desires so', 'nation says so' 'nation is asking' 'what nation wants' 'Motherland wants' etc would be just few examples of UMTOB. A leader pronouncing from a local stage/platform that whatever he/she says is 'nation's voice', 'nation would get awakened', 'nation would learn' are more UMTOB.

SOT would, in a bid to sustain its existence, symbolize himself/herself with the identity of the nation and repeated and wide spread pronouncements/presentations of official position and name/photo together and simultaneously shall be a ready reckoner. The highest probability of such actions may be by HOG, MOG as these positions

can easily be 'correlated' to the nation and nation's resources can be spent easily. **This would be an action to symbolize an individual as Government, repeatedly pronouncing name and position, thus branding a Government position to an individual. It would be unethical as a Government (and Government Position) would always be of higher stature than any individual.** Let we call it IBAN (Individual branded as Nation)

May be many people would not consider it as an 'undesirable' act. But there are many serious consequences of IBAN. **Bringing up with hangover of being 'best and ultimate' and 'equal to NATION'; would cause the SOT/GPP to get to 'severe authority mode', first considering himself/herself 'supreme' and then considering the one who does not accept it, as the 'enemy'.** Use of Government authority and Government agencies/units by SOT against these 'disbelievers' will happen obviously. The SOT will misuse of government treasure and government people for its projection presenting him/her equivalence to 'Nation' and this has been elaborated in 'Vanity exploiting Nation's assets and money-VENAM' ([please refer to VENAM](#))

Fraud13- Con15: DOR-Delivery of Right:

The governments structure 'rules', 'regulations' and even the 'Constitution' of a nation. And the most promising word in the constitution document of the nation would always be 'Rights of the citizen'. Not only a 'government' formed with people voted by the people, whatever way or whatsoever be the value of that election procedure ([please refer to chapter 'Value of Election' & 'Democracy assurance Union DAU'](#)), but even the monarch would talk about "Rights of the people" as it would pave an easy way to gain publicity. This may be to highlight the concern of the 'Government' towards the people as one reason. However, another reason may be to 'mesmerize and fascinate' the citizen with an 'impression' that they (citizen) are the boss and 'Government and Government people' serving them. And there is no doubt that the 'words' of providing 'rights' would definitely mesmerize the people. But is it sufficient to 'produce a set of words' termed as 'rules' and 'laws' keeping the laws 'incomplete' and 'unproductive'? ([Please refer to 'Laws and Rules completeness chapter](#)).

Getting back to the subject, the 'rights shall be extended' to people by making laws in the form of 'set of words'. But where are the 'rights' and how people would get it? Are the 'rights' being sold on a shop that the people would go and buy it. Are 'rights' grown on a tree that a citizen would go and 'pluck' it? Not really. **So where the 'rights are'?**

As Government proposes to provide 'rights' to people, signifies that the laws are with the Government (and thus government people). **So for 'rights' being available to the people, only GPP stands in-between.** So there is high probability of making such proposals and laws by GPP, for 'rights', **that it is good in 'words and pronouncements' to fascinate the people but 'just not make the rights available' to the people in the form of 'stipulated gains'.**

The 'rights' are the powers which people becomes empowered to. As the most important objective, it should provide 'verifiable and measurable' gains to the people. And there must be a visible channel for verification of the 'Rights' being provided and validation from the people, with comprehensive data and 'not interviews of picked up people'. **The methodology and procedures of verification/validation must be in the 'document/proposal of 'Rights'.**

The first thing which must be clearly understood is that if 'laws' are made for making a 'Right' available to people; it signifies that the same was not available to the people previously. Now when it was not available earlier, how now it would be made available to the people? So first step is 'Government defining' methodology as to how that 'right' would be made available. **This would contain the GPP and the DOUEE which would be made accountable by name and government position and the route/channel through which 'Rights' going to be made available.**

Say, there is law regarding 'Right to good Health' for the citizen. This would imply that every citizen has access to 'best health services' which are totally affordable by average citizen. The 'services' should be available in easily accessible manner and the reliability both for 'accessibility/reachability' and 'assured quality' should be absolute. So the 'rights' are convertible to 'assured gains' through physically visible assets, the hospitals' and 'best equipment and doctors'. Now, the citizen themselves would not build the hospitals and would not create the equipment and doctors' and all these must be 'made available' by the Government to the citizens. So **Government has to deliver the 'rights' to the citizen and 'rights' by itself would not become 'at hand' to them. The Government would have to define the 'physically existing means' which would realize 'the rights' being available to people 'as predefined gains'. And finally, Government would have to define the GPP responsible for 'delivering the rights' to the citizen, with defined RAA and accountability for any 'failure'. It is the most important factor as just this one occurrence of 'failure on part of GPP would nullify the whole 'assurance and commitment' of the Government for providing 'Rights'.**

So, first it should be understood that Government/GPP have to deliver the 'Rights' to the citizen or otherwise it's a 'gimmick'. Government/ GPP would deliver the 'rights' by defining the 'objectives and procedures', 'physically existing verifiable means/ DOUEE' and notifying 'predefined accountability of GPP by position' for DELIVERING RIGHTS, and if these are missing in the 'proposal of providing any 'right', the proposal and GOSIP would be a 'fraud'

One may not wonder if these are found missing in the 'document of Rights' and not 'comprehensively' notified, may be deliberately by GPP, making the Government and GPP proposal 'fake' and 'deceitful.

Fraud 14- Con15

Extreme Fraudulence; SOT not presenting the DAVM objectives, DAVM Goals on time line in his/her statements, announcements, public presentations

While making presentations, interactions the HOG, MOG, GPP must feel duty bound to substantiate his/her words, statements, declarations with DAVM objectives and DAVM goals on timeline. As elaborated above, the GPP should ideally be in 'Service mode' and if so, GPP would invariably present DAVM facts with analysis and data for complete transparency. However, if an SOT, it would be in 'authority orientation' and with low intelligence pursuits, SOT would rather make presentations without DAVM objectives and goals, non-verifiable and measurable for accomplishments. SOT announcement, interactions, presentations (AIP) shall be in the form of slogans, narration, story, poetic, literary, emotions, dialogues. The GOSIP shall be presented with mesmerizing high value in million-billions without DAVM achievable at each quarter of the year, just to fascinate the people and madiak and eliminating the possible 'tracing back'.

This would be a deliberate act by SOT and prominent symptom.

Con16-Worthless Government Health Services:

For performing human to the best, the state of health evidently is most important. If an individual is unhealthy ill or sick, its brain and organs would not be able to perform causing disability to self and the society, the social masses. The **most significant fact which would favour SOT is, that an unhealthy person would be dependent on others, thus low confidence, submissive and non-reacting**. The first preference of sick person would inevitably be towards its own condition and would do anything to get rid of illness. The sick person would be just looking at itself, low confidence, dependent on others and non-reacting.

The **SOT would certainly prefer to have such people**. Firstly because of being in authority mode driven by Masterism attribute, **SOT would require to create slaves, the people in helpless state. Secondly, as these would depend upon the government therefore, would not go against government, being physically and mentally repressed**. This would be achieved by SOT by realizing a state where people, citizen do not get highly reliable medical treatment /health services within their reach, both financially and/or not being easily reachable. The **government health services/ hospitals normally affordable financially by average citizen, would be made hopeless and worthless** that the citizen don't trust its reliability; and non-government health services made unregulated by government, **transforming to non-affordable and beyond reach of average citizen financially** (Please refer to 'Average citizen model' and 'Government foremost responsibility model'). The SOT would create a human race which would be virtually at the mercy of SOT/government for health services. And **SOT would configure worthless government health services and expensive unregulated non-government health services** which would create an unending cycle of misery for the people that they would be occupied in treating their illness or illness of family members.

Con 17- Serving versus ruling:

This would be an important parameter to measure SOT attribute. The government people would have reached their positions with the **commitment of rendering 'absolute service' to people in 'selfless manner'**. However, as explained in 'Government and Government people are different' model, they are common people with no 'exceptional intelligence' and thus would have high probability of facing hardships in resolving severe and oversized issues. The **true intelligent government person would transparently bring up all its actions in front of the people, on public domain, and by constituting the 'Citizen forum' (please refer to chapter on 'citizen forum'), obtain advice and guidance from outside environment, discuss openly and transparently before concluding with a decision**. Even if there are shortcomings in the decision, it would be known for future monitoring and corrections. However, **SOT would avoid the transparency and open discussions as it would reveal SOT's deficient acumen and hampered foresight**.

As mentioned and elaborated earlier, the decision making index of decisions by SOT would be negative/ low (please refer to 'Value of decision/GOSIP' and 'decision maker versus decision taker' model). The decisions and GOSIP would be without earmarking DAVM objectives and DAVM goals on timeline and **SOT decisions would be in narrative form, slogan, literary, emotional, sensational avoiding and ignoring**

mathematical analysis and elaborations. If the government decisions are without transparency and without open discussions by the GPP/HOG/MOG and without DAVM goals/objectives presented on public domain, **the decisions would be illusionary and to be 'authoritative' and 'imposing'.** The **SOT therefore, would just leave the service orientation, getting into the form of a 'ruler& monarch'.** As the decisions would be without transparency and without DAVM goals confessed to the people, the people would have fairly good chances to react and protest. The **SOT would use government authority and government people to justify its 'unjustified' approach, getting further into 'masterism'.**

Obviously, in the process, SOT would delegate high unjustified powers to the GPP at all levels and especially those who would interface with the people/citizen. Unjustified here signifies allocating 'powers higher than the intelligence and genuinity calibre' of the person. And to get the GPP into authority mode, like SOT, **the SOT would bring every GPP into authority mode which would warrant that GPP possess lower intelligence level.** Thus **they would never be selected as the best person in 'absolute verifiable and measurable' manner.** (please refer to 'Government Intelligence model'). The GPP selection would be just the other way, the best would be discouraged/discarded. Or the ways, rules, norms would be installed that it would be hard and difficult for the 'best people' to get to GPP positions and 'inferior education and intelligence' would find easier to get to GPP. **The education and intelligence level of GPP would be kept low as it is necessary to get them to 'authority mode' which is required by SOT.** And this would result that whole governance system would convert to 'authority mode' with 'responsibilities and accountabilities'-RAA vague and loose ended. (Please refer to 'Why Government must be Sincere' & 'Responsibility and Accountability').

Low intelligence and low level of RAA in government units and in GPP, undefined responsibility and accountability for actions on time base; absence of "fully working/accessible & fully transparent complaints addressing system" pertaining to working of GPP and government units, would present the signs of 'departing from service orientation'.

And the GPP as SOT would now be in the form of a 'ruler' leaving aside the 'service orientation' which was the basic purpose of its existence.

And it has been explained that **'if not providing service sincerely' the other objective of being in Government is 'fulfilling selfish self-gains'.** That's what SOT would be finally.

Con18- Gap between GPP and citizen: SOT view Governance from its side only viz Authority

The SOT would create the governance system represented by GPP in 'authority mode' as modelled above. **The 'authority mode' would create 'hangover' in the 'psychic' of GPP that they are higher and superior to the common citizen.** This would instantaneously nullify the fundamental right of citizen that "happy contented citizen are the cause and reason for the existence of a government and 'government people'". Now the SOT GPP would not mind to keep citizen 'unhappy and grieved' and when GPP would not evidently and visibly act presenting actions which are fully self-evidenced, verifiable

and measurable, in the interest of citizen, and do not present every information available on public domain, the 'gap' between government and citizen would increase. (please refer to chapters on 'Independence Meaningfulness' and 'public domain').

Once the gap between government and citizen would exist for a period of time, citizen would stop reacting, busy and occupied to resolve miseries/problems of their lives, which the GPP should have cared for, otherwise. **And when citizen would not react, the SOT GPP would turn autocrat, monarch just looking for fulfilment of their interests.** And when this change in attitude continues for a time, **the GPP would get into the habit of seeing citizen grieved and distressed. Their change of attitude would make them to cause 'agony, troubles' to the citizen doing just opposite to what they were meant for.** (Please refer to 'MS governance' chapter and 'Why Government must be sincere')

And this would evidently happen if a SOT exists creating 'wide separation' between what GPP is dutiful to provide to the people and what actually people realizes getting from them.

And SOT would only talk about what he/she had done, may be insignificant and falsified without DAVM goals, and would not talk about what it failed to do, just ignoring whatever important and essential it was for the people. Just one sided viewing by SOT.(Please refer to 'This side that side TSTS model')

The government- citizen separation would be evidenced with:

1. No/Low direct communication between Government and Citizen (refer to chapter of 'Direct Communication')
2. Responsibilities and duties of each GPP not publicly notified and not on public domain
3. Responsibilities and duties of GPP not in DAVM terms with goals/ achievable on timeline
4. The government people with government authority intruding citizen without public notice/ notification
5. Continuing negative/ low CEAK level/ index of citizen for more than four years
6. No CRAG enforced (please refer to the chapter on CRAG)
7. Incomplete laws and Justice system indifferent for laws to be complete (please refer to 'laws and rules' chapter)
8. Closed eye justice delivery happening (please refer to 'Justice System' chapter)
9. Media/Madiak not presenting all cases of citizen distress, rape, murder, causing disability, kidnapping, subdued living conditions etc. unit region wise.
10. The media/madiak not analysing the GOSIP and GPP decisions if possess any deficiency (please refer to chapter on 'media /madiak')
11. No accredited government platform and GPP for government announcements and others media/madiak, political people/OIG announce details of government actions and GOSIP

Con19 -SOT would portray MUBI:

SOT would create domain of fools.

SOT would be well aware of the higher intelligence level in the outside sphere however, would not permit important government decisions to be taken by these people because it would bring out its inadequacy and incapability wherever and to whatever extent applicable. The knowingness of not being the best, although placed at the position which would correspond to the best, would invariably bring in the feel of insecurity to SOT. Also SOT at top, would fear for the possibility of not returning to the top placement again the next time, which would also develop feel of insecurity. As explained in other chapter the feeling of insecurity results abrupt and self-centred behaviour. (The shakiness in government decisions however, should not be considered justified/acceptable on account of insecurity).

This would lead to the authority orientation as brought out earlier and SOT would move away from the 'citizen service' orientation (departing its fundamental commitment), as otherwise SOT would have to function treating citizen as 'the master'.

The **low intelligence known and evidenced together with the posture of authority, would aggravate the reason for assuring more and more financial strength** both because of sustaining self in 'fluid environment', uncertain of permanent stability, and also getting uncertain of regaining the glamour of 'top' again. This would induct the 'beimani' (corrupt and dishonest), looking for and ensuring self-gains in the government's spending and once the authority orientation and intent of self-gains get implanted, the **SOT would turn the every other member unsecured under SOT's prevailing authority and would create line up of people, GPP who would work to 'please' him/her. And turning and compelling the others under him /her, to behave incapable and subordination.**

Thus, with authority mode and fraudulent behaviour, **SOT would invariably, to ensure its strength and continuance, acquire the 'outlook' of a MUBI, visible or not, SOT making two face presentation.** Even if the SOT does not exhibit MUBISM in its behaviour, but the behaviour of those working with him, would portray true presentation of SOTs MUBI state. (please refer to '2Face leader' chapter)

Con20-SOT would configure much higher MUBI(Murkh Beiman Impotent) madiak/media

The importance of media/madiak is well established and discussed in the chapters on 'madiak/media- sincerity, accountability, selfish and stupid, presentations etc', which may be referred to. The madiak has the advantage of being read, viewed and listened by millions of people at one time. The government's affiliation is also discussed in the chapter of madiak/media. It is elaborated that **government would tend to 'turn madiak as its mouth-piece' whereas ideally media must be 'true representatives of the citizen'**. It is also brought out that **madiak/media must possess much higher intelligence level than the government/GPP** so that madiak/media can dissect, analyse and evaluate the government GOSIP for being perfect, good to the people and bring out deficiencies if any. **In this manner it would be 'true representative of the people/citizen TROP.**

However, SOT would not present ideal and perfect GOSIP because of attaining 'Mubism' as explained above and attaining authority orientation and attitude of accomplishing self-gains from government's spending/GOSIP, government assets, people and machinery.

So if madiak/media is 'true representative of people/citizen' the TROP madiak would be looked at as enemy by SOT.

So SOT would use government position, authority to bring madiak/media to the state of 'madism'(please refer to the chapter on madiak/media), talking mainly good about the SOT government/ GOSIP, **and only good, grossly**, without presenting any analysis and evaluation based upon data & statistics, without presenting verifiable and measurable facts/benefits. SOT would have sure inclination to configure media/madiak into 'madism' state/ mode where madiak would speak all good about SOT government /GPP and their actions, irrespective of worthiness assessed objectively, palpably and presented. Once **this would happen/ occur, the madiak would get dominated by selfish presentations and presenters, low intelligent**, let these termed as "**LISPP- Low intelligent selfish presentations and Presenter**" who would present debates without predefined objectives and concluding without notifying crisp conclusion, news like slogan-narration-story form; run through news and presentations- deliberately fast not to be understood; News aimed at publicity; and multi images on video screen so that one cannot concentrate, advertisement superseding /overlapping the news etc., news run through and few words, few lines presentation etc. and these are few examples of LISPP. In written/printed media, complete page advertisement, News narrative, slogan like, without statistics/data etc, aimed at

publicity, would be few more LISPP. **The madiak/media in this form is SLIME-Selfish Low intelligent/Stupid Media/madiak.** Madiak would not present the best occurrences and engineering, research, science based happenings as this would enhance CEAK of the people which SOT would not want to happen.(please refer to chapter on 'madiak/media')

The madiak fraudulence would be evidenced if:

1. The media/madiak does not evidence in their presentations that what media is presenting, GPP/HOG/MOG said the same
2. Does not present the official document released by government /GPP alongwith the government's GOSIP/news
3. Presents the government announcements '**as great sensation**' which are not announced from official government platforms and /or not by the authorised government and nominated person, from top four level.
4. Adding made up sensation by calling the GPP and/or the actions of GPP as 'Great or greatest, First class, not before, Number one, godly, what nation wanted etc, an UMTOB.
5. Showing bias towards government as above but grudge against those who are not aligned to government/GPP
6. Making fun/mockery of those who are not aligned to the GPP in government/government
7. Announcing governments GOSIP without presenting DAVM goals, objectives, goals on timeline. Especially announcing the value in million-billion but no end DAVM objectives and Goals on time line
8. Not announcing goals achieved in DAVM terms in ongoing GOSIP every month, previously announced goals, if achieved or not achieved with resources spent
9. Not presenting deficiencies in Government GOSIP or otherwise certifying that 'there are no deficiency'
10. Not presenting the analysis and years long statistics of every HOG, MOG, OIG, GPP regarding achieved truthfulness of their statements, announcements, declarations, every time, whenever, they make an announcement, statement.
11. Any presentations in the form of LISPP
12. No detailed coverage of citizen /people distress and problems, covering less than 90% of total time span of the broadcast/ printed space in print media and advertisements going beyond 10%. SOT would permit media/madiak to focus on commercials as it would eat up the time and space on which otherwise, citizen /people would have first right and claim, and media would willingly accept it as it would make the madiak/media people richer.

The madiak exhibiting above symptoms in the presentations, would signify the presence of a 'high MUBI' 'SLIME' madiak. Although madiak would realize for deviating from its correct form of being 'TROP', however, would still continue in the state of 'selfish and stupid' madiak, SLIME, because this would fulfil 'selfish gains' of the people behind.

And now the madiak becomes the most 'destructive weapon' of SOT.

Madiak/Media as the most destructive weapon of SOT

SOT, realizing such powers owned by the media, would necessarily ensure that media/madiak does not function as 'true representative of people' TROP. The HOG/MOG/GPP of the nation, ideally, ethically, ensure that the media must function as

'true representative of people'. However, **SOT, with having attained 'authority orientation' and having inclination of disabling people as MDP, MDP society or MDP masses, would not permit the madiak/media to function in that manner as TROP.**

If SOT would permit media/madiak to function as TROP, the first thing media would do, is to criticise SOT for its 'authority orientation' and all its actions to keep people MDP, disintegrated, harsh and reactive and SOT would not be able to resist such massive force of protest and criticism against itself. So **SOT would invariably, anyway or whatever way, using any tactic or any force, make media/madiak not to function as TROP.** And madiak if not function as TROP, once compromised with its principles and ethics, it would be a 'puppet' in the hands of the SOT. Obviously the madiak in this form unprincipled and unethical, would just have the prominent role of praising SOT. **The madiak/media would exhibit the symptoms mentioned above of MUBI and SLIME media. And also would signify this state of madiak/media being 'puppet' with more symptoms:**

1. Praising/ appreciating government people GPP, HOG, MOG without presenting DAVM achievements
2. Praising/ appreciating government GOSIP without DAVM analysis and DAVM goals
3. Criticising and making fun anybody who act against HOG, MOG, Government, Government's Political party
4. Symbolising a Government or an GPP, HOG, MOG etc, with the term nation
5. No analysis, statistics, data presented regularly for the failure of announcements by HOG, MOG
6. No analysis, statistics, data presented regularly for the failure of the HOG, MOG government and government people and government GOSIP
7. Criticising and/or not permitting to speak overpowering debates by anchors in madiak presentations by shouting, diluting focus etc

The SOT would, by permitting uncontrolled time and space for commercials advertisement, higher than 10%, sponsoring even news and basic data, information, by business people, advertisements even in regular transmission/ programs along with news and data, information, let media/madiak people to prosper out of way and in turn, would levy them that they render all praise of SOT, MOG-HOG in such behaviour, and criticise/make fun of those who are opposing SOT. This would be insincere stupid madiak at negative MUBI index, setting aside and ignoring its most fundamental duty of becoming 'true representative of the people' and not representative of Government/GPP.

As explained in madiak/media chapter, the madiak in this form is 'MADISM' state. Now though media/madiak might decide to switch over to 'Madism' character/model, but transmitting and projecting SOT (or HOG, MOG, GPP in such character) in news, they have limitation to speak and present the exaggerated version and 'made up' version of SOT (HOG, MOG, GPP in such form) actions. And continuing this practice over a period of time, more than 6months, by madiak, would signify that the madiak is in extreme MUBI state, working under extreme stupidity and selfishness or under extreme compulsions of defying its role of TROP.

Showing in news and group discussions and debates, media may face hardships to be one sided however, advertisements and commercials are free of such compulsions especially if the government has not notified widely and openly published code of madiak/media presentations including sponsored and advertisements.

So, Madiak/media would just present whatever they are supplied by SOT and then SOT would just ensure that “no comprehensive code of media /madiak presentations covering every type of presentations, is made and placed on public domain and made public”. And then SOT would use the media/madiak to transmit, communicate and convey whatever it would like, maybe unrealistic, made up and exaggerated, maybe hypothetical and oversized and media would present it as it is, as an advertisement, sponsored stuff, ‘paid for’ items, under the excuse of making presentation for which madiak/media is not responsible. SOT would use madiak/media as a weapon to oversize its ‘identity and image’ and ‘cut down’ those who are against SOT.

As described previously, the madiak/media in the state of SLIME ‘selfish low intelligent’, making such LISP presentations, when continues for some period of time, would acquire the state of ‘stupidity and Mubidity’ permanently as it would, in this manner, be making money without much of hardwork. And **now MUBI SLIME madiak would be a weapon of SOT to craft ‘people as ‘Low intelligent, passive, indifferent, agitating, not trusting others, unsecured, low confidence, Low CEAK’ by implanting slavery and subordination in their minds by oversized and over numbered presentations for ‘praising SOT, projecting SOT as special, projecting SOT as unique. SLIME madiak would not bring out ‘normal and natural deficiencies SOT possess’, would not notify goals achieved in DAVM, would not notify the extent of accomplishments of SOT’s statements/announcements and GOSIP with DAVM facts and criticize/make fun who happens to be not-aligned to SOT.**

Madiak/ media would now be the ‘representative and face’ of SOT and SOT would exploit all nation’s resources and assets for (i) its selfish gains and self-projections and (ii) demeaning those who are not supporting its made up and storyline fluid actions and publicity.

This would be the worst face of mediak/media as it represents sold out and lost-identity and operating for acclaiming selfish insincere goals on one part and ruining the people’s independence by implanting slavery and subordination. And SOT would use this form of Madiak as weapon as mentioned above

Con21:

SOT : becoming immune to intelligence

The SOT, if implement ‘Intelligence’ and ‘Analytical Intelligence based qualification’ as the criteria for GPP selection and GPP’s performance, it would have to look upon its own self and owned ‘group of GPP’. Which obviously would make SOT (HOG, MOG, OIG, GPP in SOT form) uncomfortable and answerable, first to their own existence and then to their actions. So SOT would create an environment immune to ‘intelligence’ especially ‘analytical intelligence’ where NO discussions, presentations, exhibitions shall be made evidencing ample existence of such intelligence in ‘Government sphere’. As explained in the chapter herein, the SOT would invariably be turned into ‘authority mode’ and thus would present exhibits and expressions and action to ‘symbolize’ authority with intelligence and deriving an equation where; $\text{authority} = \text{intelligence}$ or $\text{authority} > \text{intelligence}$ so that nobody should question to the ‘authority holder’ if he/she is intelligent also. **Or nobody should make the ‘authority holder’ to present ‘evidence’ that his/her actions’ are based upon intelligence; detailed DAVM analysis; this side-that side analysis; profit loss analysis.**

The madiak/media would be acting to support SOT by making their presentations with 'NO-CEAK upliftment' and 'talking/presenting' stories, narrations of the 'Authority holders' only, in MADISM/ SLIME state. This is already explained above.

Con 22: SOT causing mental disability:

SOT would have to make everybody else 'A stupid' for its survival and in quest of remaining powerful it would make all others 'stupid and low intelligence' and this is nothing but making the people disabled, mentally DIM. **The DIM can be caused by paralysing the thinking function of the brain**, the mind and since brain has to keep functioning for other actions of the body, seeing, walking, speaking etc, it would not be paralysing the brain completely (or medically), **but it would be paralysing 'rational and the logic' based thinking**. Thus the people would give away analysis, evaluation, and standardization. Most importantly, paralysing logic/rational based thinking, would lead to **that people would be driven by sentiments and by the 'words of someone else' and driven by the directions given by others**. They would have only one perception of everything, their owned perception, and they would just lose ability and intention to view the things from other's side. Thus TSTS would have no place ([please refer to This side- that side analysis model](#)). The people would assemble in herds over the directions given by others and shout, cry, make noise, manhandle others, kill others, damage property, based upon sentimental eruption. They would kill or hurt someone with whom they did not quarrel or clashed before. They would damage the property of others with whom they did not have any enmity, and that too, under someone's directions and instigations. **So become 'mentally slave'. SOT would surely have an inclination to turn people 'mentally slave'.**

This would just represent mental disability and SOT would nurture 'mentally disabled people' MDP. SOT would do the following:

1. As **education** is the most potent means of making people intelligent, think logically and rationally, analyse the situation, analyse people/GPP and their actions/ speech. The SOT would make the education system with deliberate intention, that it does not enhance the intelligence level of the people. Of course SOT would like to severely damage the quality of education system and may even opt for eliminating the education system, but elimination cannot be exercised as it would reveal such intention of SOT to the whole world and face harsh criticism. **So quality of affordable education system would be destroyed by SOT** by (i) making schools shabby, dirty buildings, with low sanitation, inadequate continuous electric supply, old damaged furniture, uncleaned unhygienic floor, environment. For fraudulent presentation, a **few percentage of schools would be made 'good and like the best' to mark these as the basis of 'high publicity' for the 'false presentation of facts'**. The good education would directly correspond to 'higher cost' payable by people, so not many can afford.
2. **Appointing low intelligent people as teachers** who would be authoritative by virtue of their 'low intelligence level' and not caring and responsible.
3. **Keeping the students 'scared' and 'unsecured' by unprotected environment and authoritative people managing the education** and education system, so that the students remain confused, perplexed unsafe and do not cherish the freedom and support which is necessary for focusing on enhancing their intelligence ([Please refer to chapter 'Why a government' and 'Education system'](#)).

Using Tools/tricks of Masterism:

It is brought out in other chapter ([please refer to master's tools](#)) that MS governance, a replica of SOT government and SOT governance, would use many tools to make the people, low intelligent, sentimental, reactive, in addition to affecting low intelligence

based education system. And these are (a) disintegrating the society by implanting the sentiments pertaining to schism, alliance, biasing, religion, caste, region and other disparities and divisions by propagating a message that specific religion or caste or region or group of people are supreme better than others or a specific religion or caste or region or group of people are not good. The **above line of thoughts, mischievous one, would ensure that the society is dominated by people whose behaviour is hatred based and not love based.** Even a message of love for someone or something, would transpire hatred for some others. The above would ensure that the **people are low intelligent, behave like stupid, without analytical skills, acting on sentiments, act on other's directions and spread sentiments and perceptions, without analysing and evaluating based upon data, figures, statistics etc.**

4. **As the sentiments, perceptions, messages, directions would travel through the media/ madiak, the television, radio, public announcements, newspaper, magazine, computer channels, mobile phone channels, the SOT would have to use media/madiak for making the people 'low intelligent' MDP thus, madiak/media acting as media for disabling people.**

Con23: No direct communication:

It is brought out in the (please refer to chapter on Direct Communication Government-Citizen) that **direct communication between government and citizen, upward and downward, is most important means for realizing the government and government people being in "service mode" and low direct communication level brings government and government people into anti-citizen/anti-service mode.**

SOT would have high preference for low level of direct communication, inherently realizing its self-low intelligence compared to outside environment, SOT would not have designated and notified government platform and environment. And HOG/MOG would show no respect to it by firstly, (a) not making each GOSIP announcement from government platform secondly (b) showing severe disregard to government procedures by giving statements in public regarding government actions and GOSIP thirdly (c) by making announcements and declarations without objectives and goals achievable and (d) making announcements, declarations in non-DAVM terms in the form of narration, story, poem, dialogues, sentimental statements etc. without ownership and accountability specified.

The SOT would also avoid that the laws are compiled and presented on a public domain and available in each sub-region easily accessible to common men. SOT would not notify rules pertaining to each government unit DOUEE, publicity, openly and freely accessible for information and knowledge of citizen.

Regarding upward communication SOT would either block the channels or if could not do so because of international image etc., would make the upward communication ineffective, undefined and non-accountable. The absence of CRAG and similar means of public grievances registration, not making complaints registration without human interface free as mandatory and/or not assured validation of complaint registration without human interface, not regular and consistent, real time updation of complaints on public domain, not notifying to the public officially, presence of political leaders PL etc would signify SOT deliberate intention of obstructing upward communication.

The complaints disposal and services delivery of government unit DOUEE and government people GPP would not be capped with time limits and action for not complying rules, procedures and not complying to time limits by GPP would not be notified to people/public. (please refer to chapter on Direct Communication Government-Citizen)

And by way of granting exclusive dispensation to GPP for not instituting RAA norms, SOT would spread the SOT attitude and authority orientation downward in the entire government machinery.(please refer to Responsibility and accountability/RAA chapter)

Thus SOT would create clear cut discrimination between GPP and common citizen, clearly bringing out GPP higher and privileged category of special people than common citizen, SOT would change the service-mindset/attitude of GPP to the mindset/attitude of a master. And this would amplify SOT aspirations of presenting itself as 'one and only one' and for that, SP would synonym itself with identity of the nation. After this happens SOT would urge to takeover the identity of the nation. Obviously it would happen because nation is non-living; non-speaking; non-moving and also not reacting as it is passive and symbolic. So there would be no real and challenging threat to the claim of SOT's such unreasonable identity presenting as synonym of the nation. This would be a highly selfish presentation as ideally 'CITIZEN' are the representation of a nation.

There are nation's resources, treasure at SOT disposal which would be exploited by SOT to present it's name, figure, identity at any; or rather every place where a common person would look at to know about the nation, news, government units publicity GOSIP, madiak/ media presentations by government and DOUEE etc. And this would install unethical and selfish self-gains derive in the human behaviour of SOT which would (please refer to chapter on 'Nation's Resources') supersede and eliminate the sincere, genuine, fair, honest impartial form of public leader and the government system.

So SOT would lead to transforming the government system and GPP into authority mode thus creating discrimination between GPP and citizen that GPP are much superior to citizen, down casting citizen as inferior and powerless entity.

However the SOT cannot lose the support of citizens especially in systems where elections for public servants government people takes place, the SOT would present that government being in subordination of the people in words, advertisement, narrations, slogans, poems, stories etc., however would not present DAVM parameters and DAVM measurements of responsibilities and accountabilities of government DOUEE and government people GPP publicly notified and published. The SOT would also not present DAVM objectives, goals and achievable on time line for GOSIP even though claiming to be best for the people in narration, slogan, like story monger.

Con24: SOT making aimless justice system

SOT would make the citizen low intelligent, low CEAK, with low capability level and limited opportunities to progress, thus inciting tendency in the people to grab over the share of others. (Please refer to chapter- 'Justice system- closed eye vs open eye') and fight and collide amongst themselves.

The Government, as happen all over, institute a system like what has been named as 'justice system' in deliberations here. To demonstrate that it cares and is concerned, the Government would present this system to settle the citizen conflicts.

However, SOT would not aim to end such disintegration and conflict amongst people. The SOT/ GPP would like it to happen deliberately which will be evidenced by

- (i)Grossly inadequate monitoring and preventive measures; ignoring prevention and mainly 'complaint based actions' or 'post occurrence show up'
- (ii) Either 'Prevention' is 'not assigned to any GPP's direct responsibility' or 'No published and notified Responsibility and Accountability of concerned GPP'; based on "count of occurrences" defined
- (iii) the prevention and controlling regulating system, mainly based upon complaints from the people and not based upon openly notified government assigned RAA of GPP

SOT would have to present the Justice system but not like that it functions well. The decisions from this system would be abnormally delayed. One of the reasons for delayed decisions would be stated as 'Too many cases' and Justice system not able to deal these in time. These 'too many cases' itself would expose the failure of Government to prevent and Sot also might 'flaring up' wherever possible, to keep such conflicts going on.

The Justice system would be structured as 'inefficient' (delayed decisions) system and continuing this inefficiency over a period of time, would create a perception that the 'decisions are to be taken' from Justice system- JS; and not that 'decisions are to be delivered by JS as assigned responsibility'. Once this understanding is permitted to prevail for some period, there will be an urge and efforts made by the people to extract decisions from JS by 'hook or crook' and soon **'bargains' would start occurring for 'taking decisions from' JS.**

The SOT term this as 'Justice'. Thus SOT would not define 'Justice' and present every decision from JS as 'delivery of justice', evidently irrational as 'Justice itself' has not been defined'. ([Please refer to chapter- 'Justice system...](#)).

The SOT would invariably implant 'closed eye justice system' as it is possible to delay the justice or give any decision under the name of Justice and thus use JS to deliver decisions which SOT wants under the cover of 'justice delivery'.

To earn good name, in between, SOT would present 'fast delivery' of a decision from JS but ensure at the same time "not to universalize" such practice as it would make the people free of 'troubles' which have been 'crafted' by SOT by designing 'non-accountable' Government system.

Con25: Worst is Best- Relatively

The SOT, most probable, would lack in making a performance which would, by itself, recognized as the best based upon verifiable and measurable pre notified targets, avoid presenting DAVM goals and achievements, regularly on time line. The SOT however, if has full control over the data, statistics and figures, can easily suppress these shortcomings by making analysis whatever way it wants and presenting statistics whatever looks good. So SOT would have control over the presentation of statistics and data. And to avoid it to be questioned by anyone, **it would not notify the procedures of making assessments, evaluation, calculations, formula, equations and shall simply notify the final figure without furnishing details.**

The other action plan would be to become 'best' relatively. It's very easy rather the easiest course. Pick the one which is/who is inferior and present yourself as better relatively. The SOT would thus make rumpus of everyone who would be 'less in such attribute' and would never permit 'highlighting' of the superior and the better. This would be an action of fraudulence as it would be done, firstly recognizing by SOT that he/she is far below the best but don't want to be known/disclosed and secondly deliberately cover up the self-owned shortcomings by presenting, that some others are inferior to SOT, more prominently.

It leads to detrimental consequences that SOT would not make efforts to improve and correct its course, possibly never, and acquire attribute to present others as 'stupid, incapable, inefficient, corrupt...', even falsely, because it is the way SOT can survive. And it would make SOT more 'stupid and incapable'.

If the SOT is at a position that it can influence madiak/media, the Media presentations containing the items mentioned below would imply the 'presentations of the SOT':

- (i) Statistics regarding performance, productivity, achieved objectives and goals shall be 'single figure' announced without elaborating the procedure, methodology, calculations
- (ii) Madiak would not elaborate and bring out the failures of SOT and its plans, schemes, announcements, declarations; regularly and comprehensively,
- (iii) Madiak/media making presentations criticizing other people on top making intentional efforts to prove others as 'useless, worthless and crooked'
- (iv) Making presentations as in (iii) even without presenting DAVM evidences and explanations, thus equivalent of making 'allegations' irresponsibly.
- (v) The value of GOSIP announced as 'one figure', very high value to mesmerize people but no DAVM objectives and goals presented

Con26: Why worry; Exhibit 'Bias is sacrosanct'

The **SOT, by virtue of its 'self-evaluation' of not being best, would have to engulf a group of people to 'blindly' outcry their 'faith' in SOT.** If the projections of these 'blind followers' are only made by SOT, it would look like that whole 'lot of people' is with SOT. And in turn the SOT would also have to exhibit its support to these 'lot of people' directly or 'indirectly'. If this is not done, this 'lot of people' would gradually slip away from SOT grip.

Looking it from the 'Governance' point of view, HOG, MOG, GPP and the whole government must be 'evidently impartial' to all the people irrespective of religion, region, caste, race, complexion etc as non-compliance by GPP would be unethical and insincere. But in case of **SOT, showing bias would be a compulsion and shall do so, upfront.**

SOT might place some reasoning to protect its bias but the biasing stands undesirable and undue. Once again, having influence over the madiak/media, the following presentations would promote such bias:

- (i) Presentation of something or anything being 'good' about the 'lot of people', showing made up stories
- (ii) Presentations of past stories/mythology of the religion, region, caste, race etc attempting to influence opinion of people that they are 'supreme'.
- (iii) Presentations of past stories of the people lived in the past from the same religion, region, caste, race etc bringing up these as 'outstanding performer'

- (iv) Not presenting or inadequately presenting, the actions by SOT or these 'lot of people' against others
- (v) Not presenting or inadequately presenting the 'authority and masterism' orientation of SOT, GPP
