

Note: This is a modelling and derivations, done based upon analysis of existing facts and evolving reasoning based upon common human attributes, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system or individual in the world'. Any explanation in this 'coinciding with any working Government system or person' shall be an unintentional coincidence only.

## Patriotism- Real vs Drama

- **Incompetency and stupidity in governance would lead to 'Authority' and 'Selfish' orientation' of GPP**
- **Presentation of 'Patriot and traitor' by GPP would be 'selective' without precise, notified parameters and notified evaluation**
- **The most significant act of GPP would be to evaluate, measure, verify and notify its own 'patriotic or Traitor assessment'. The publicly notified assessment of 'patriotism' or 'traitor' of GPP must be notified for top positions**
- **Is 'Citizen notified as most meaningful constituent/representation of Nation'? And GPP to evidence in DAVM terms, its (GPP's) direct commitment for fulfilling citizen wellbeing.**
- **Defining Justice from WAL side and delivering Justice in threshold period to citizen would be 'most important consideration' for 'Patriotism' of GPP**
- **SOT in a nation would be a confirmed existence of 'anti-nation mindset' in Governance, adopting course of 'authority' and 'fraudulence'**
- **GPP proclamation without DAVM verified/verifiable evidence should be classified as a lie, and an anti-nation act**
- **GPP proclamation 'Not announced previously from Government's platform' shall be fraudulence and 'anti-nation' act**
- **Non-Existence or Low level of 'Direct Government-citizen communication' is anti-nation act by Government and GPP**
- **Presentation of GPP personified, with name and photo, spending Nation's resources VENAM, is anti-nation as it would implant 'selfish self-gains' in Governance**

Patriotism and anti-nation would be the most sensitive issue in any nation and would remain the cause of major controversy. The people, some will be tagged as 'patriot' and some others would be termed as 'anti nation'-traitor'. As anyone bearing the charges of 'anti nation' will obviously be treated as 'enemy', it would face the all-round disgust, hatred from others. But from whom? Are those who would spit hatred and disgust are the 'Patriots'?

From here we get back to where we started from; 'patriot' versus 'anti nation'. So a patriotism and anti-nationalism must be based upon firm, notified transparent basis. It is most important to recognize that such basis must be most well-defined, transparent with measurable parameters in case of acclamation of 'patriot' as once it is through, the person would invariably try to name others, who are not liked by it, as anti-nation or traitor. So this would spread hatred, disparity which may be incorrect also. So **the most important principle is that 'patriot' and 'patriotism' must be acclaimed based upon precise and firm parameters, which are 100% transparent and known to people widely notified and regularly evaluated. This would be 'Patrioteer evaluation'-PEV.** But those who would have discretion to take decisions, would avoid having explicit rules and procedures as it would make them to testify their own selves first, against these procedures and rules, and thus, take away their discretion and powers to acclaim their own selves as 'patriot' arbitrarily. However, the same person would certainly create rules and procedures which are ambiguous and undefined to acclaim anyone else as 'anti-national'. **This would be a plot**

**that after acclaiming self as 'patriot', no one would challenge it because this 'self-acclaimed patriot' would have right to declare another person as 'anti-national'.**

**Therefore, in a nation with ICE, MOG, OIG, MGG the evidence of 'patriotism' must start from the top** and after evidencing adequately about their 'patriotism', ICE; then HOG; then MOG etc with evidence of securing adequate score, high positive, the ICE, HOG, MOG, OIG, MGG would not be entitled to call themselves as 'patriot' and anyone else as 'traitor'. The becoming of patriotic or traitor is not a sudden happening that one day someone patriotic would become anti-nation the next day and again patriotic the third day. It directly relates to the personal character, social life and persons ideology. And these attributes appear in the behaviour of a person. And character and ideology based behaviour should be consistent and unaltered, **thus behaviour over a substantial period of time, last five to six years, should be required to be 'graphed' and 'measured' consistently.** So this becomes the first requirement for ICE, HOG, MOG, OIG, MGG (GPP) gaining candidature of patriotism.

As explained in other chapter, the nation has two constituents, land which is passive and 'citizen' which is active and vibrant. Therefore, defining patriotism for land is undefined and symbolic. Neither a person would have capability to alter the size of land of a nation unless the Government ignores it or supports it.

**The most meaningful criteria for 'patriotism' therefore, would be the behaviour of GPP to the common citizen.** And what would be the measurement of sincerity of the GPP towards citizen and hence towards nation, and hence for becoming of a patriot. The most important criteria would be 'delivery of justice' to the citizen. the justice will be important to them by empowering them to find a place anywhere in the world at par with the status and employment of the people of that country would have and disempowerment can only be provided to the people by granting them high education of highest standards of the world which is affordable by almost every citizen of the nation thus expenditure of a family should be within 5% of the earning and responsibility of ensuring this should be with the government. The government not only should own it but evidence it on reality basis every 6 months. Not doing it shall signify anti citizen and thus anti-nation.

The justice to citizen shall be what is described in HOF model, 'Head of the family' model and implying the behaviour of GPP as HOF. Government would share citizen griefs, distress and provide care without any prejudice and bias. This would be evident if the citizen gets a very fast justice delivery for anything where government or GPP is the other party. The justice system would be liable under laws to explain why such decisions took more than a few days not in months, and also why the justice system did not punish the GPP, if found guilty, by termination from the government position. Treating citizen as nation, the governance must comply. Or non-compliance should be anti-national government system.

If compliance to above norms, HOF model, is exercised by Government with bias, that is applicable to some group and some others are ignored, shall be therefore, a gross representation of anti-nation behaviour. It has been elaborated in SOT 'Stupid on Top' model that if a stupid happens to be on the top, there are multiple and sequential untoward consequences which would eminently occur, unstoppable, as the **SOT shall adopt mindset which would cause severe and permanent deterioration of good governance values. Leading to adoption of the 'damaging course of authority and fraudulence' by SOT.** Thus, extreme selfish behaviour and actions with urge to make common citizen helpless and distressed. There would be an attempt and urge in SOT to make the people living on SOT's mercy and compassion and SOT would not mind converting the nation to the "country of beggars-COB". By realising COB in a nation, SOT would ensure that SOT's authority, exaction, bias and fraudulence just go unchallenged as the people are on its mercy for basic

livelihood like food shelter, money in hand. So **having SOT in a nation would be certain existence of anti-nation Governance and anti-nation mindset propagating down to every GPP.**

It is utmost necessary that as explained in chapter 'Government and Government people are different', it should be notified that no measures of VENAM and no signs of "fame game" would be tolerable and if it happens so, the GPP shall have to pay the expenses and face the charges of 'misuse of nations money and resources'. Using government money, status powers, position for selfish self-gains by a GPP (HOG, MOG, OIG, MGG) and by PL would be unquestionable becoming of anti-nation of the GPP.

For the government people any word spoken which is **not substantiated with verified or verifiable evidence, thus classified as a lie, would be anti-nation act.** As such unverified statements shall be issued by GPP from non-government platform, anything which is **not announced from 'Government official platform' or 'has not been announced previously from Government's platform' shall be anti-nation.**

It would be anti-nation for many reasons. The first reason would be that the intention behind such words, statements shall be 'fraudulence' and 'cheating' with the 'active constituent of the nation viz 'the citizen'. Secondly it will be an insult to the government position GPP holds, by the GPP and thirdly it would be act of MUBI cheating the nation viz 'the citizen'. Similarly an act of GPP unlawful and unruly shall stand anti-nation based upon the above reasoning. As thumb rule, anything which is not substantiated and supported by visible and self-verified facts or facts verifiable by common person facts, data, evidence on the spot, shall be a lie for the GPP, HOG, MOG, OIG MGG. **And telling a lie in this form would be extreme anti-nation as it would be deliberate and intentional action, highly irresponsible.**

It is brought out in chapter ".....Responsibilities of Government" that **every happening in a country is the outcome of 'good work' or 'bad work' of the 'government people'** The 'good work' would not be a matter of discussions as brought out in the chapter..... as with all discretion, powers and 'nations resources' under control, any government must perform to the best for the nation including citizen. If the GPP fails it is anti-nation obviously. So the 'bad work' of HOG, MOG, OIG, MGG i.e. an action which failed to yield good results to 'nation' and 'citizen' and an action without measurable and verifiable achievements (DAVM) shall become "anti nation" act, ANAC. The GPP's fundamental condition of occupying the 'Government position' would be 'exhibiting and certifying' publicly from 'Government platform' that their actions were necessary for "good of the nation" and thus "good for the land and the citizen". This has two important dimensions. The first is 'regular direct communication' from 'Government's platform' by HOG, MOG, OIG, MGG with the people of the nation. The characteristics of such communication have been brought out in the chapter on "Direct communication between Government and citizen" and "Citizen forum". It is mentioned therein that government is under obligation towards the 'nation' to have 'continuous direct communication' of high positive value, with the people. **If 'continuous direct communication' is absent, the GPP would not be displaying its fair intentions of taking 'just & unbiased' decisions and such actions would disclose GPPs action of fulfilling selfish self-interest which GPP intend to hide from the citizen and the nation, thus 'awful exhibition of anti-nation'.**

The GPP viz HOG, MOG,OIG, MGG, even if not communicating from government's accredited platform however, **would always be making address to the people at various non-government platforms** to keep a clout of influence over them. If the GPP is not carrying obligations of direct communication from government platform but making public addresses from non-government platform, it would just be 'discarding accountability' and

'shedding off' responsibility as the GPP would remain accountable for each word it would speak from Government platform but not if it speaks out from Non-Government platform. So **each word spoken from non-government platform and not having spoken from government accredited platform, would be 'blatant demonstration of fraudulence' on part of HOG, MOG, OIG, MGG, thus anti-nation.** Whilst the public rallies etc may be considered as an act of democracy, it would be 'undemocratic' and 'anti nation' if the same address is not made by HOG, MOG, OIG, MGG from government platform GPP has intense responsibility to honour the government position it holds. Without honouring the status of Government platform, the HOG, MOG, OIG, MGG would be publicly and informally disclosing a 'government secret' which would be again 'anti-nation'. So direct address to people without honouring the 'government official platform', shall be 'fraudulent act' obviously.

An argument may be raised by 'argument mongers' that when 'citizen' is nation, how does it matter if HOG, MOG, OIG, MGG communicates with citizen from 'government' or 'non-government' platform. But the stupidity of this argument shall be inbuilt in the 'argument' itself as to why HOG, MOG, OIG, MGG opted to assume the 'government position' if he/she was to 'dishonour' the 'status and existence' of 'Government position'. Without assuming the 'government position' also, it could have used the 'non-government' platform. The derivation is **obvious that HOG, MOG, OIG, MGG wanted to make use of the 'Nation's resources' for 'exaggeration' and 'made up' self-presentation, which would imply 'misuse of Nation's resources' and misuse of 'Government position' for selfish self-gains; anti-nation and corrupt act.**

And quality of GPP's address is another important aspect, the contents. The contents would exhibit HOG,MOG,OIG,MGG intentions, how good or how bad, commitment and if the communication is complete i.e. worth of communication. In the chapter of 'DAVM' and Government's responsibilities' an understanding has been made that DAVM communication has been essential absolutely to present truthfulness of communication and making it purposeful and non-DAVM communication is of no use, worthless. Non-DAVM communication would be incomplete vague and made with the motive of 'hiding most important information', evidence and substantiation, thus fraudulent motives. HOG,MOG,OIG,MGG if a SOT, would make deliberate non-DAVM communication. Thus DAVM content would certify the truthfulness, confidence, competency and fairness to the objectives of communication. The direct communication in DAVM form, from government to citizen therefore, confirm HOG,MOG,OIG,MGG intentions to be fair to citizen and thus to the nation. And if HOG,MOG,OIG,MGG do not practice and deploy direct communication, DAVM and from 'Government accredited platform' the same would bear a frame of fraudulence and presentation of dubious self-character by the HOG,MOG,OIG,MGG making them unlike of Government's constituent and 'ant-national'.

In a government system with ICE,GOS, GOE as explained in Chapter....., the position of ICE should be active and commanding with assigned responsibilities of questioning the 'government's constituents' i.e. 'GPP'. The ICE should have function of supervising the GPP-HOG,MOG,OIG,MGG actions otherwise the ICE will be a worthless position. For exercising vigil by ICE and feedback, the investigating system and statistics cum evaluation system should be under ICE. For independent-ness of justice system and avoiding its misuse, the justice system should be under ICE. These aspects have been covered in the chapter of "Independent Constitutional Entity". There must be a monitor and monitoring mechanism for the actions of GPP with regular evaluation on behalf of the "Nation". And it is ICE. In any governance system, if the position of ICE don't exist or made honorary and symbolic without direct RAA and without functions to exercise vigil as above



defined under the laws and procedures, it would be an extreme example where "Nation" itself is "anti-nation". This is a situation when the government itself would start from 'anti-nation' attributes. So ICE I must be an active and powerful position with earmarked responsibilities of monitoring and counselling the government. For monitoring; ICE would have a system as detailed in chapter of "Independent Constitutional Entity" under its control. In chapter "Government and Government people are different", it is brought out that 'government people' are not 'the government' and embodies daily functions of a government with a motive of "sincere service of the nation", "citizen and physical entity"; in selfless manner. If the GPP do not bear motive of 'sincere service in selfless manner'- SSS to the nation, their behaviour and actions will be driven by attitude of "selfish self-gains" as these are the only two reasons which would motivate and aspire any person to step into a Government and assuming "Government position". Therefore, there would always be high possibilities of a GPP- HOG,MOG,OIG,MGG becoming driven by "selfish self-gains" attitude and this has been explained in chapter "Government and Government people are different" thus the GPP behaviour needs both 'deep monitoring' and 'regulations' which can be exercised by a person who is outside the Government but authorized by laws to 'monitor and regulate' and caution the GPP for any attitude of 'insincerity to the nation' and non-selfless, which is selfish behaviour. And such position is ICE as detailed in chapter of "Independent Constitutional Entity".

Thus a governance system without an effective position empowered with control over the government organs; which can be otherwise misused by GPP to fulfil their selfish goals, to suppress those who are against GPP, making the people wretched, helpless, disabled with low education and low CEAK, conspire with business domain to exploit 'nations resources' for 'selfish self-gains' as explained in 'Spheres of undemocracy', thus ICE must be having control over such government organs. If in any governance system if ICE does not exist or made ineffective, passive or controlled by government by tabooing its expression, voice and actions' or made ineffective and ostensive by not providing control over 'investigation units, justice system and performance statistics notifying for GPP and government or 'nation' as a whole, the nation and its laws, rules, constitution would itself be anti-nation. If a 'government' or 'government people' make the ICE ineffective and passive and does not extend 'monitoring and commenting' functions on government actions, with selected control on government organs as above, the GPP would obviously be driven by "selfish self-gains" and would be therefore, "anti-nation".

The patriotism for a GPP would be 'true service which can only be realized with selflessness. With selflessness, the history is full of such examples that even ordinary people, when assumed the soul of selflessness, got so high that people made them God. And the opposite is urge of fulfilling 'selfish self-gains', urge of authority and money wealth. When governed by this attitude, a person would look after its own interest only and once in this mode, the accumulated power and wealth would turn him/ her into authority mode and it is explained in the chapter 'Master-Slave Governance' that the 'incense of authority' which is masterism results making others as 'slaves'. The power of money and wealth is universal with directly claimed ownership thus would be all preferred choice for a person to own acclaim and accumulate. A GPP would be paid by the government for his/ her services whereas he/she would take decisions regarding spending of 'nations resources' amounting to multifold and thousands-millions times higher than what it gets from the government. In chapter 'Vicious circle of un-democracy', the money back loop is explained as to how GPP would gain incentives to go for 'selfish gains' from government spending through 'money back loop'.

A GPP thus have all incentives to be in selfish mode and his/her patriotism shall be a test that he/she does not act selfish and thus act in selfless manner and remains absolutely

untouched from any possible self-gains from government spending. Therefore, patriotism would call for making DAVM GOSIP (Government scheme, intent, plan, proposal, project) i.e. with publicity notified DAVM objectives and achievable on timeline and permits transparent verification of achieved goals widely notified with facts. Producing a GOSIP with Non-DAVM objectives and goals, would be direct derivation of accomplishing selfish self-gains by the GPP. Non DAVM GOSIP is the foremost incentive for a GPP to show its selfish and corrupt behaviour. And this would be opposite of 'patriotism', thus a 'traitor'.

The other important foul play the GOP would adopt is 'hiding the intents' of Government spending and government earnings, fraudulently from the people so that the people would never come to know about the total inflow of money and total outflow of money into and from the government's treasure with whatever balance, government would have. Many countries present the inflow and outflow as above in a statement of accounts called the budget or the money balance sheet MBS. Thus as explained above, if the DAVM GOSIP with DAVM goals on timeline are not the basis of this MBS/ budget, the act of producing such a statement would stand non-patriotic. The argument mongers would certainly plead that when only a proposal of spending has been produced by the GPP and spending has not been done, how the GPP would stand to be a traitor. The one who argues, should go through the "chapter on Corruption" wherein it is explained that corruption is an intention (and the action comes later) and corruption starts right from where it is intended to. So Non-DVM GOSIP is MBS /budget would be an act of 'corruption', thus an act of a 'traitor'.

Any unit in a financial statement would, to whatever extent possible, highlight the 'earnings' and available 'treasure' money and hide the "liabilities" which shall only bring out the quantum of 'earnings' but not the "worth and value" of earnings and money wealth in hand. The details of liabilities are kept hidden because it would 'offset' the 'earnings and treasure' and thus "devalue the treasure and money in hand" nullifying the projections of the Government. The presentation of 'Liabilities' only would ascertain sincerity of the presentation and sincerity of the presenter. If the liabilities are missing and hidden, then the presentation itself becomes a 'mode of fraudulence and insincerity'. Such actions with inbuilt fraudulence and depriving the citizens of the nation from knowing the truth, shall be opposite of 'patriotism'. And the 'presenter' GPP would be a 'traitor' thus.

In the chapter "stupid on top", the attributes of a SOT have been analysed and it is evident that the attributes like fraudulence, disabling people, disintegrating people, authoritative (masterism) Governance, turning others into slaves, leaving 'service mode', and working on realizing 'selfish self-gains' are 'anti citizen and anti-nation' attributes. This brings out important analogy that SOT would always be anti-nation and anti-patriotic. There is no space for any argument as the attributes SOT would adopt, as per analogy in SOT model, even if GPP projects himself/herself not having adopted few of such attributes, the remaining other attributes would be enough to prove that he/she is anti-nation. So much so, even adoption of one attribute viz 'masterism', is would develop intense desire to turn the citizen to slaves and to implement this the GPP would begin with 'disabling the people'. Making them weak by providing 'good education and health services' at non-affordable cost and simultaneously deteriorating/ eliminating the 'government services' at par with good quality of education and health services. The SOT would make the citizen worthless by eliminating their sources of earnings, piling up unemployment and using masters games to disintegrate the people and citizen, the SOT as explained in SOT model would apply exaggerated publicity, made up and oversized, by turning media/madiak into a 'stupid mediak'. All these symptoms are obvious when a 'stupid is on top' and all these symptoms are the result of anti-nation attributes. Therefore, a SOT would invariably be 'anti-national' a 'traitor' working for acclaiming 'selfish self-gains' even if this 'intention' is hidden. This is a 'derivation' made and

to 'bring out' such 'anti-nation' actions and attributes of GPP visible to everyone and known even if these are kept hidden by GPP.

### **Making threat to self; Sentimental drama**

The GPP (HOG,MOG,OIG,MGG) would always term someone as 'traitor' and one easy way would be that some enemy is created without providing strong evidence in the form of video evidence or made up evidence are produced. The easiest course of action would be that some other nation is presented as enemy of the country and threat to self-country is stressed by GPP. If another country is enemy, obviously it would have attacked the home-nation and if it has happened, the other country becomes well-known and established enemy even without HOG,MOG,OIG,MGG making any declarations. However, the GPP would not like to come to that situation as if happens so, the GPP will have to prove its worth by fighting and making advancements which would be verified by the whole world for being true or false, and it would be very tough for a 'story monger' to prove worth against hardships of life.

And if the other nation has not attacked even though the HOG,MOG,OIG,MGG of home nation would have instigated by issuing statements, declarations against the other country for having 'inclination' to trouble the home-nation or having intention to attack on the 'home-nation', it would be obvious that the 'other nation' had no inclination of creating any rift. The GPP would thus made stories, firstly without any base or secondly by flaring up insignificant issues, if any. However, the GPP would not present any verifiable evidence to support its statements of 'being under threat by other nation' such as video recordings, statements of the HOG,MOG,OIG of the other nation, video of tension at the nation's border, substantiating statements with presentation of maps etc proving the truthfulness of the 'statements and declarations' of HOG,MOG,OIG,MGG. Without any such substantiation the 'statements and declarations' of HOG,MOG,OIG,MGG would obviously be 'made up false stories'.

Even if the case is that 'other nation' is causing a threat, the presentations of HOG,MOG,OIG,MGG without providing evidence as above, would stand to be 'act of traitor' and 'cheating nation and citizen' because HOG,MOG,OIG,MGG would be 'duty bound' to present the evidences to the 'citizen' and the 'whole world'. The HOG,MOG,OIG,MGG would also be 'duty bound' to present such situation with evidence to the whole world from 'accredited Government platform' in the form of 'open public statement' or in case of failure in doing so, the HOG,MOG,OIG,MGG would be becoming 'disloyal' to the nation and country. And the GPP's act would stand to be a 'drama' a 'flimflam'.
