Note: This is a modelling, done based upon analysis of existing facts and evolving reasoning, as to how the 'Government' and 'Constituents of Governance' are likely to behave and function 'influenced by normal human attributes' under different 'probable conditions' and does not imply projection or criticism of 'any particular government system, religious system or an individual in the world'. Any explanation in this 'coinciding with any working Government system or religious system or a person' shall be an unintentional coincidence only.

Derivations of and from 'Religious mindset'

In the tools of masterism, it is brought out that in distorted governance, the GPP would resort to many tools implanted as 'prevalent practices' not only to distract the forward vision of the people but also to cripple them with disparities, disintegration, selfish thinking, insecurity and no concrete path to progress on their ideas. Even if the people may get enriched with the knowledge of what is better in the world and may develop a vision for acclaiming the same, the GPP wood ensure not to provide a concrete path to them to reach those goals. The GPP would isolate few loved ones who would be provided such support to pave a path to reach their goals. For others, the goals would remain unaccomplished and would remain in dreams. Such GPP would make slogans and phrases to highlight that dreaming is must and better so that the people don't get frustrated when not getting close to their goals. The GPP would keep another dream ready for the people so that they don't come out of dreaming. Slogan based announcements like strong house for everyone by......, Making smart city by, happy life for everyone by year....., pure water by, Everyones dream fulfilled by Etc. The GPP would never lay any DAVM parameters to define smart city or happy life or strong house or pure water etc and the people would also never ask them to define these.` Firstly being scared, secondly no such platform provided by GPP and absence of the same, they/people will perceive these undefined terms as per their own knowledge, caliber, potential and requirements. However, the most prevalent and undefined term to be used by GPP to control the people is the religion. The expression that the religion is undefined, would look to be strange almost to everyone of us but it indeed is.

Religion is no physical entity existing and visible which can be touched and grabbed. It is only a belief and a mindset. If a person is in a Religion-1, he/ she could have been in Religion-2 otherwise and his/ her look, human behavior, physical formation would have remained same. So religion is not a physical entity which can change physical self of a person. Even today the people changes religion which does not change their physical self. Religion is in the mind, in the brain a belief and mindset and most surprisingly, it is based upon perceptions and no relation with the facts like human identity, profession status etc. A person can create visuals in his/her mind which would not exist in a 3D reality. It is a mind set and onward we call it REMS (Religious mindset) instead of religion and avoid and avert any controversy which may crop up on the use of the term religion.

REMS is a mindset and driven by the beliefs mainly inherited, thus unverified by an individual. Why it should be inherited? Because it must have an origin in the past, from the history. Otherwise each individual will identify itself with its own standalone religion starting from its birth (rather after gaining adequate level of knowledge thus substantially older) and finishing at its death. Would it qualify to be called a religion? No! But why?

The religion is a common belief amongst more than one person, a group of people, and continues even after they are no more. Therefore, it has to have roots in the past, history, and continues through changeover from one person to another without arguments analysis, reasoning, logic, evaluation and changeover is just adoption by others. After all, if something has roots in the past people, their behavior, attitude, actions and past happenings. So it is of no use to analyze, argue,

dissect of past happenings and past people's behavior and then decide. So, REMS transfer it unconditional, just from one brain to other as a mindset.

Now REMS is based upon beliefs and beliefs would relate to past happenings and past people. The normal cause of development and obvious changes with time would suggest the enhancement of intelligence, brain power, analytical attributes, increasing time and life productivity and efficiency, increasing power spheres with passage of time. The meaning thereby that human of the present age being more intelligent, more analytical, bearing more power spheres compared to those in the past, the REMS would drag the mindsets and thinking to the past by glorifying the people and actions of the past which would ultimately end by classifying the people of the past as "superhuman" and their actions as "unique one time act" or "super act".

And now superhuman of the past, in a bid to glorify and uplift their existence as 'superhuman' would have to be equipped with mysterious powers, magical and unbelievable normally, not expected anyone in the present frame of time to be possessing. So the REMS would develop belief that the people in the present are deficient and people of the past were 'worthy' and 'pray-able' being superhuman.

The REMS would therefore, think against the normal evolution occurring with the time and the time is moving forward, but REMS would look backward. Can these 'superhuman' of the past be classified as God? Of course REMS would believe so and would spread it. It would be to convince others that REMS belief and approach is correct. Once driven by a belief that some those who lived in the past were superhuman, the REMS would relate them to the God.

Now REMS would have apprehensions that the evolution of history may present people of the past as much lower in knowledge, resources and lower state of livelihood commonly, therefore, the belief that the past people were 'superhuman' must be spread as fast as possible to have more REMS around. But the perception regarding 'people of past' being 'superhuman' would never get substantiated by REMS as it would stand to be the reverse to what time is producing and what actually is evidenced before eyes. REMS would have a job to get something acceptable which they can produce in the tales and myths but cannot relate to the normal course of evolution. The REMS will have only one choice, that is to keep the people low CEAK, low at knowledge and therefore low at education, cutting off people from analysis, research, happenings all over (aligned to time and in direction of evolution) and if the people would start looking forward, the sole purpose of REMS to make people to look backward, would get lost. REMS would have to install hypothetical (unsubstantiated) actions and happenings as real one. And to achieve the same, it would have to spread its belief aggressively by organizing assemblies, conferences, get together, concerts, workshops to implant the hypothetical unsubstantiated and unevidenced versions (with no DAVM substantiation) with hypnotizing lyrics poems, songs, into the brains of people. The REMS shall have to look different to draw attention of all towards him/her therefore, would dress different looking attires and would make the face different and peculiar and strange by putting colours, dots-linesvertical-horizontal, head covers, beads, chains etc. Once people start believing that such tales and happenings are real, they would just start looking back, getting out of the normal stream of time which flows forward. For such people who would start living in their imaginations believing that either they are there in the past or the "superheroes of the past" (SHOP) have come to them.

But why the people would need these 'superheroes' of the past to come in their lives? why they need some 'superhero' existing or non-existing, come to their lives? Why they cannot confidently move their lives forward themselves?

These questions are very important from the perspective of the potent, capable and progressive society of people because these characteristics of a society takes the people along the stream of the time, moving in the direction of time (moving forward). So what factors would cause people to look backward to the past and 'heroes of the past'? Let we try to workout. Firstly, we talk about the inherited factors and then we talk about the created factors.

Every creature is born and exist with a natural programme of insecurity in the brain. This program is implanted by nature so that the creature becomes concerned about its insecurity and then develops means to protect itself. This program is a way of self-realization that every creature has threat to life and it has to safeguard its life and existence. This has two effects. One, the creature would consciously feel (depends upon the state of activeness of brain) that it is incomplete, short of something and second it's life is precious and to be saved. Both these factors become very important in case of REMS when get applied to human and its existence. Both these factors in case of mankind, becomes the first and important base for REMS to implant necessity of superhuman in the brains of the people so that people further feel insecured. The next stage of this will be that people would get scared of some unusual, untoward coming into their lives and to overcome this insecurity, they would need some external power to protect them. Since they are scared of some hypothetical happening, which has not happened yet, they would believe some hypothetical entity to come and help them.

This natural derivation goes big way to depreciate the self-confidence of people. On the contrary the people would pose to be possessing more self-confidence because of the belief of external help which stands hypothetical and unassured and invisible. For example, if someone is jumping across a ditch of one meter, he/she may do so with the belief that 'superhuman' are there to help them. However, if the same person is jumping across a ditch of 10 meter wide, it would surely fall in the ditch and break bones and no 'superhuman' would come to take him across the ditch. Whatever would be the extent of belief, if someone presents that standing in front of moving train is possible with someone protecting him/her, it would stand baseless as the person would die for sure. REMS, knowing very well that no one can protect under such visible, evidenced and dreadful dangers, would talk about the invisible presumed dangers, unexpected and unreal dangers which are nonexistent today but may come up in future. And once a person starts believing that, for sure, some hurdle would obviously come in way in future as the life is like that and every person would start believing in such imaginary words of REMS to be true. The claim of enhancement of self-confidence becomes a gossip thus. a person just expecting some untoward happening to come up and further with hypothesis that some supernatural entity shall be there to safeguard him/her, no way would enhance self-confidence of anyone and such claim would remain a myth only. As above, no one would jump across ditch of 10 meter wide or stand in front of train that he/she would be saved. Why? Because evidently everyone knows that there is no superhuman assigned this job.

REMS would therefore have to structure stories that someone was in trouble sometime, long back and when he was in trouble 'supernatural divine help' arrived and his/her worries vanished. Again there would not be ground realities to support it.

An important question comes up. If there is an entity who can overcome all worries of the mankind and at the same time believes that the entity is eager to help the mankind then why don't the supernatural entity removes all worries and reasons to cause troubles once and forever so that the whole human race is happy, cheerful and progressive. In most natural and meaningful analogy and derivation, the supernatural entity would do so if eager and willing to help mankind. So either there is no such entity/'superhuman' or it is not always willing to help. Both ways it leads to uncertainty of miracles and 'suddenly visible' help.

The REMS will have to present the evidences which belongs to the current phase of time and there will be some people coming up with narrations of some experiences where they got saved by miracle. Obviously, such narrations will have basic flaws of visible substantiation, evidences and the narration will only be in the form of stories, myth. But here we are not talking about individuals and to prove its rightness or wrongfulness. We should be more concerned about the base where such stories would get a ground to grow and spread. This aspect is very important and has harmful serious consequences to whole human race. A brain which would believe in stories without asking for substantiation would evidence the following characteristics:

- 1. Low knowledge level
- 2. Low intelligence level. Unable to reason out
- 3. Engulfed in desperation always carrying apprehensions of insecurity
- 4. Bowing down to surrender for help

If the above characteristics are looked at, it will correspond to a person with low CEAK, low education, poor with suffering, poor health and lastly with a slavery mindset. And the worst to happen is that REMS require these kind of people to propagate its mindset into others. Does it mean that REMS possess these characteristics and is low knowledge, low intelligence poor and Bowing down. Yes or no, we will talk about this later.

REMS is low intelligent, believes in fictions, does not believe in evidence and substantiation, believes the in past heroes as 'superheroes' defining them legend, therefore, lives in the past and thus it would have strong objective and urge to stop progression of common people as this would create a hurdle to make people retrogressive, to look backward and therefore REMS would make intense efforts, if in governance, to depreciate education by depreciating quality and affordability, depreciate the health services again by depreciating quality and affordability because continuous bad health is a potent means to make people desperate and would tend believing in 'superheroes' to come and help them.

At this stage the chapter on SOT "Stupid on top" can be referred to as the derivations of REMS just correspond to SOT and REMS would behave like a SOT.

Talking to the common people, as REMS, they would just believe in the stories, existence of the superheroes of the past as they are desperate poor people having only dreams of getting some dreams fulfilled.

Earlier it was referred to that if 'superheroes of the past' SHOP, can be named as "God". May be if 'superheroes' are worshipped and honored regularly for centuries and more and more REMS become oriented to such superheroes. There are two possibilities now. (1) the presentation of superheroes is different not in the form of a life and creature on the earth and (2) it is in the form of a human or some other existing form of life.

The superhero in a form of life nonexistent on this earth would have the first reaction of 'who it is?' from the people, the possible acceptor and therefore, depending upon someone's imagination and acceptance, some may accept the presentation and others may not get convinced. Further the figure of an alien would scare the people therefore, the image of superheroes of the past will always resemble to the human which would have been widely accepted and prayed. The picture of a human will be universally accepted and would have possible travel down into centuries, accepted and honored. These superheroes of the past would be adopted by human brain without any fear or sign of disbelief and therefore, would continue.

We just leave aside the argument if SHOP existed sometime and/or SHOP performed all those acts which are in tales or stories made up by some people and spread at this stage. At this stage, the model of REMS is that it is a group of people who are trying to spread REMS further all around.

And leaving all those questions aside, let we analyze as to what for, the SHOP would have come to existence for, if it was there. Obviously to do welfare of the people. And if superhuman to come for the welfare of the people, there were obviously grave and serious oppressions these people were facing. The people would be wretched, oppressed and the situation would have been so terrible compelling SHOP to arrive. Now the people would be distressed because of their destiny or because of oppression by some other person. SHOP would not appear if the people sufferings are because of destiny as destiny is something which is written to his/ her life and to be endured. So, SHOP would not appear for such cases unless it is equipped with divine powers to rectify the destiny, someone's bad luck. But no discrimination and SHOP would have to ratify destiny of all the people. The second possibility is that SHOP appears to end the oppression of some persons causing trouble to others but it is just an action of a normal human. Therefore, the reasons for appearance of SHOP would stand as (1) which is, saving the people from bad luck rectifying or blessing for abolishment of bad luck and (2) to end the oppression if there is any.

But the question comes up why the SHOP would come up to abolish bad luck of people and the oppression. The answer as universally known and is that the SHOP loves the people and is keen to see them happy and because it has supernatural powers to do the formidable task of reversing the bad luck and bad time, it becomes dutiful for SHOP to come. But if SHOP has the powers to reverse the bad luck and to make people happy why SHOP would not use the powers to make people happy by setting them free of bad luck forever. There is no doubt that if SHOP does so, every human will be SHOP's pupil. They will just pray the SHOP in return to its blessings. But why SHOP does not do it?

So, two possibilities come up. (1) either SHOP does not possess powers which would mean that SHOP does not exist or (2) his/her powers do not entitle to abolish the bad luck. Both the above reasons contradict to the assumption of SHOP being a superhuman and supernatural power. There may be a possibility that SHOP would abolish bad luck of only few and not all and criteria for selecting those few by SHOP will just be any guesswork. There will be hypothesis, theories reasonings to explain such partiality by SHOP but nothing supersedes the best explanation that if SHOP removes bad luck for everyone, it will be a win-win situation as people will be happy and SHOP will be honoured by them. So, do we believe that SHOP does not have powers to abolish the bad luck seems and this seems to be so.

A person is born as a child and grows to a kid and then young person becomes older and an old person. This is how time flows. The person was very happy when a kid, free of responsibilities and gradually gains tension and unhappiness as grows further to a young person, then to get to old age. This is how the time flows. Time! What is time? obviously not a clock on the wall that once the clock stops, the time would also stop. Obviously not so. Then what time is? As described above, the person, rather every person grows with time or changes with time. Why time changes?

The REMS would plead to extreme extent that the superheroes presence was the best happening and best time ever. May be true. Not to be disputed. REMS would claim that when superhero existed, every person was happy by his/her presence or by his/her actions. And REMS would also claim that SHOP came to existence for the welfare of the people. No argument up till now. But the question which comes up is why SHOP did not stop the time so that every person would have become happy forever, unending and everlasting. Many theories would also exist that time changes to different phases viz from the time of SHOP which was the most pleasing time, and changes to bad

and to the worst making the people distressed. Why the SHOP did not stop the time? If SHOP had stopped time, no one would ever have become distressed. So why SHOP did not stop the time? There may be two reasons (1) SHOP did not have powers to stop the time when SHOP existed in the past or (2) the SHOP did not want people to be happy. Surprisingly both go against the claims of REMS. Thus, possibility cannot be overruled that REMS has created stories and myth to impress the people that he (they) is the one who knows about the SHOP. So, is the time more powerful than any of the superheroes of the past? The normal derivation of facts suggests this.

So, time stands more powerful and time is decay; loss of energy and loss of 'present existence' of every entity in the world. Time moves and passes continuously and keep on changing any present frame of life. The physical existence of every creature decays with time and nobody can stop it including SHOP even though REMS may have stories for anything, but those remain stories only. So time is moving as 'universal truth'. Let we call this direction as 'forward'. So REMS efforts to take people to the past is an attempt to move the people 'backward' stop their forward rhythm with time. If people would look forward and move forward in the direction of time which is changing the 'life and lives'. The direction of time is advancement, development, evolution and emergence of new. And REMS would have to reverse it. The REMS therefore, would announce notify the bad signs of development, progression but would not abstain the life with modern amenities and would not move away to desolation. REMS would keep availing the advantages of progression and development. The REMS would keep preaching to others regarding such bad signs but would not restrain to use such developments themselves as these are very useful. The developments, discoveries need to be looked at delinked from SHOP and the REMS mindset to assess its absolute values.

The SHOP is well wisher of the people and has all the powers as would appear in the stories of REMS. SHOP is merciful, gentle, rendering blessings and is not afraid of any entity. the SHOP is powerful with divine powers to protect the people just by his/ her gesture of Divinity and compassion. The shop thus supposed to be empty handed and since has all the powers to curb the bad and give away happiness dropped from his /her hands, the SHOP must be empty handed. There is no purpose of keeping the hands full of anything which would signify that SHOP is in danger and wants to protect itself or is afraid of someone. Thus there is no place for having weapons in the hands of SHOP and if REMS presents SHOP in such presentation of having weapons in hand, it contradicts the belief that SHOP is powerful and not afraid of any entity or person. If REMS make such presentation, it is evidently to scare the people moving their brains towards subordination. Other argument that there are bad people and SHOP must protect itself from them simply falls back upon REMS as they are telling lies, believing in untrue. Why REMS would present SHOP in this manner? Yes to terrify and scare the people. Although REMS would contradict their own argument and claim that SHOP is most powerful and has no reason to be afraid of any other entity so that carrying the weapons would be required. So, the only objective of conceiving SHOP in this form is the 'bow down' the people to scare and slave like behaviour. Thus, REMS would induce or try best to induce and implant slavery, subordination, submission in the personality of each person.

And when common man would acquire these attributes and this mindset of subordination, the REMS would establish themselves as master, claiming to be the representative of SHOP and gradually as SHOP is missing physically, REMS would mark up themselves conveniently as the messenger of SHOP and become decision making person to dictate the terms, norms, guidelines to be applicable to common man and relates these to the existence of human being to make each and every person to comply.

The REMS now pretending to be representative of SHOP would have to create its different identity so that they are noticeable and identifiable as different person. They would wear different dress, would change their facial look by having long hairs, moustaches, beards etc and would add something which to give them different identity and also scare the people at the same time. REMS may use different colors on face, lines, dots in the form of unusual depiction giving their face a strange look making people puzzled, mystified and together with the impression of REMS conveyed that they are the transmitter of the stories and actions of SHOP, they would be able to place themselves as master and make people to believe that overlooking their words, directions, guidelines would cause curse and bad omen. Thus the REMS would tend to acquire the position of 'God' 'superheroes of the past' and tend to impress upon their selves being the representation of 'super humans/ superheroes of the past'. At the same time REMS would know themselves and their reality that they don't have direct or indirect affiliation with the 'past superheroes' and their actions narrated in stories and myths. They would mystify the people by extensively speaking as speech flow of continuous words make people mesmerized and it takes them away from the surroundings and engulf them in the matter being talked about. Once the listeners get mesmerized they just get into a state of subordination providing orator at the place of privilege and the place of a master. The loudness would also add to the mesmerized state of people especially if the people and listeners are of low intelligence level and there are no restrictions for going loud.

The most prominent concept of the relation between a person and the 'God' is the concept of the 'soul', something belonging to each individual (or each creature on the earth). As it belongs to each individual individually, it would be separate for each person or creature. However, there is nothing like 'soul' is visible. The REMS would identify this entity having direct connection with the 'God', the supreme power. From the past history and ancient beliefs, let we analyze how the concept of soul would have come to existence. From ancient world we can understand that the people did not believe in death therefore, there was a tendency to preserve the body after death as it was believed that a time will come that something would happen and they all would become alive. Even today, largely the dead bodies are not destroyed and kept in the present form. This would just imply that the soul either does not exist or if it does, it remains with the body after death. If proceed further with this logic, there is no difference between the states as to when the person was living and when it ceased to be leaving. If soul was with body in both states, there is no difference in these two states. But these are different without any doubt.

A person who is active with all its bodily functions and working body parts, the same person is 'passive' without any bodily functions and with no body part working.

There is one possibility which is being invoked by many REMS. That is that soul is with body when a person is living and the person dies when the soul leaves. Let we proceed with this. Firstly the question comes up if soul is inside the body or is some entity outside the body which controls the body and keep it functioning. The concept is popular but if it is applied to the body as such, the applicability does not seem to be a straight forward analogy. As we know, the body is a set of organs functioning in a closed cycle where the body parts are functioning for a particular output to the outside world and then have limitations or boundaries set for any such actions. Say if someone walking, it would step out the leg within certain limits. If we conceive that the soul has decided these limits, it would become difficult to apply the same explanation to the state of running. So bodily functions are of different parts do not seem to be directly controlled by 'soul'. The other concept is that 'soul' is an energy which is attached to every tissue of the body which also need to be explained against the fact that even after a person dies some organs keep functioning for some time and all organs do not stop working simultaneously. So whether soul has left the body or still inside,

becomes unexplainable however, considering the body being just equivalent to a machine with many parts performing when all parts are working in synchronized manner and not working when this synchronized working collapses and like a machine, the body comes to stand still. There have been cases which substantiate this. Cases where the person dies and after getting pulses or artificial respiration etc, the heart beats started and the body regained life. The concept of 'soul' goes beyond death because if the soul ceases with the body, there is no soul virtually. So those who would go with the concept of 'soul' would definitely plead for its being eternal and unending. Though it becomes difficult to answer many questions. Like if population is increasing, where the new souls are coming from? The common REMS analogy is that God is creating new souls, therefore, those souls which did not exist earlier. This itself goes against the theory suggesting the existence of 'soul'. And then existence after death, the journey of soul after the death and then its transformation into another body would remain difficult to be substantiated with real definable and explainable rational and reasoning.

However, just a matter of belief. If one believes in something beyond reasoning, there is nothing one can think about. Coming to the history, people believed in 'soul' and in the life after death and therefore, preserved the bodies. That was a time when the people were not aware of the cause of death, a disease or stopping of heart or virus infection etc and therefore, conceived that whatever they were seeing, a person dying, was not the end forever and was a temporary mishap which would get undone someday and the person would get up. They did not comprehend that the person in front of them not breathing, would never recover. Their belief that 'life never dies but comes back' someday would have been at the origin of the existence of 'God' or the 'supernatural power. A person in front of them may be a king, had exited from their lives but they all wanted the king to be back with them due to affection or subordination etc and therefore, believed that some other 'superpower' would help them and the king would regain life. And the 'superpowers' would have come to existence as a strong perception of someone who can reverse even after one die. The soul would be preserved by 'super power' and replanted to the body again. Therefore, the soul got linked with the God that the soul lies with the God and God can return it to the body. And 'soul' and 'God' forms a complimentary pair in the sense that if anyone believes in one, it would have to believe in the other invariably. And when both 'God' and 'soul' are invisible, these can be implanted as a belief only, so no reasoning and no argument regarding questioning about the existence.

But there are few unanswered questions:

(1)Where from the additional soul comes for increasing population (2) Are all souls in all creatures equal in formation, functions, configuration, strength (3) if it is argued that some other creatures may be getting lost in lieu of increasing number of human-souls, this will imply that all souls are equal capability wise, energy level wise, same in formation, equal in controlling functions. This however, is just unreasonable to believe that the soul in a human is equivalent to the soul of an ant or mosquito as these insects have much less requirement of controlling functions and what happens when hundreds and thousands of insects die when spray or gas is released to kill them.

The most prevalent reasoning with the existence of soul is that it is imperishable and it is born again. But does the human 'soul' only goes into new body or soul of any creature would enter into the human body. The REMS might explain it someway but failing to it, they would only leave it to the 'God' claiming that only God knows. But there would be no confirmed explanation that if a person is dying and its soul getting released, there is no direct correlation with its new place where it would go. REMS would talk about it making stories but not able to get hold of the soul and would not know what next destination of the soul is?

What could a soul be? Believing that it controls the bodily functions, it must be an origin of certain energy which is getting transmitted into different organs, tissues, to make them to perform as different organs perform and operate in different manner. The soul would be a source of many programmes which would be directed to the organs to make them to perform and there is only one organ in the body which can generate programmes. When a baby grows, its brain keeps on developing programmes continuously like walking, speaking, cycling etc and these programmes get stored in the brain for whole of life. Can the active part of the brain be presumed as the 'soul' with all the programmes, as it houses the programmes associated with bodily functions. If so, when the human sleeps, the active brain goes down and if it is soul, the human may get close to death while sleeping. But it is not. Can soul be classified as the programmes in the body and not the 'hard and solid' part of it. The argument goes down as if soul is 'programmes' it would not travel from one human to another and if 'soul' is programmes, it would end with the death of a person.

So if the soul is not getting 'defined' and 'identified', how is it to consider human body as a machine having programmes in built and with energy inputs it performs in a desired manner. And when anything goes wrong with any part the body (and the machine) it collapses. Proceeding with this ideology, there are again many questions to be answered. First is that if a machine how it grows from a baby to grown up adult. But if it is 'soul versus machine', it is neither claimed to be function of 'soul'. It is a bodily function and programme for adding up tissues is inbuilt. It happens not only for human but for every creature. Is it an act of God or if it the act of soul? If we move ahead with presumption that it is so, different creatures have different pattern of growth and the soul should be different for different creatures. But those who talk about soul would not agree to it as it would become their job to describe different type of souls. Which they cannot do. The REMS cannot do because they are not intelligent and analytical to prove their storied with defined and visible evidence. The REMS would therefore, manage with the stories, lyrics, music and myths which neither needs sequential analysis bringing out visible facts and making people just flow with the stream made by them. Only one thing required. The peoples, listeners desperation which would make them to go with anyone who can show them dreams of wellness.

And if in governance, the REMS would certainly keep the people desperate. Or the other way GPP would make the people desperate and then depute REMS to provide dreams, stories, poems, lyrics, myths, narrating that some superhero would come to make them happy and the people would keep waiting. May be the GPP would get itself installed as the very superhero, the people are waiting for.

Coming back to soul, if physical development is the work of soul, the soul would be differently structured in different creatures which would go against the theory of soul as then soul would also be superior and inferior. but as said 'soul is soul' no change no variety and nothing can change it. And further the growth occurs in many more entities. For example trees also grow in the same manner as the human body grows but REMS do not associate soul with the trees. No REMS associate the superheroes, stories, poems, lyrics with the superheroes of the trees. Why? Because human have feelings, sentiments, and with this, human can fall into subordination. But trees do not have the sentiments and therefore, cannot fall into subordination. Also, after getting into subordination, the human work for REMS, doing their publicity by putting up a particular attire, talk about the REMS placing them as the master. They work for REMS to spread sphere of influence and also share resources for REMS growth and prosperity. And in subordination, people would come up together raising voice to support the REMS whenever REMS is in trouble. And REMS need their support as having people at your back, is a strength and REMS would live with it.

Again coming back to the soul, the growth, physical changes in body, evidently not linked to the soul. What purpose the soul rest in the body for? As above, trees do not have soul but grows. Now death

can be attributed to two reasons REMS says it is departure of soul from body and other explanation is that body is a machine and collapses when any vital part stops functioning but what forms of entity or the energy the soul is not established

Now we look into another possibility. We have energy waves all around. In the age of computers, wifi mobile phone waves, radio, TV waves etc. And these waves are energy waves and these are invisible. Can soul be waves, invisible but transmitting energy. There are few questions which would have to be addressed. Firstly, the light waves shall be kept separate not considered, because as per 'quantum theory' the light is made of tiny particles and this theory is supported by many happenings like generation of electric current in a solar cell etc. Also peculiar characteristics like light travels only in straight path would contradict the way 'soul' is conceptualize which can move anywhere. So, we consider other waves. There are few things which are evident. Firstly, these waves are released from some source and these are released freely in the space. These can be made directional by using suitable equipment but normally travelling free all around. These are not confined, trapped in a body. Therefore, soul cannot be made up of these waves. These waves have fixed characteristics and works for a particular equipment always. If soul is the wave, it would first be outside the body, free in space and working for one body always. After death, it would not start working for some other body. This contradicts the age old basic belief that the soul is in the body of a person and when it leaves the human dies. And also, if there is a soul it must correspond to a body and should exist in the body itself. Therefore, soul formation as a wave does not seem to be relevant.

What soul is, interestingly, has not tried to be explained by REMS except uttering hypothetical stories, poems, songs etc.

But as claimed, soul is the connection of a human with God, so if soul cannot be defined how we defined the God. REMS may sing songs, make stories, but the presentation of God remains hazy and incomplete. As the myths explains, God keeps track of every person's actions through the soul and register its deeds and misdeeds. But there are many instances in which the same action by human may have contradictory causes. For example, a person may kill other person due to envy, looting, jealousy in which case, for an act of killing someone, the person remains accountable as it would be considered as a misdeed. However, in another scenario a person may kill the other one where he has been attacked and it becomes necessary for the person to kill the attacker to save itself. The same act of killing the other person, does not stand here as a misdeed and the person in principle does not remain accountable.

So the same act is a bad act In one case but not so in the other. Therefore, the circumstances becomes important here. Now circumstances are the happenings, outside the body and soul would not be able to pick the data being inside. The same act, but 'when it is bad' and 'when it is not bad' must be decided and no one knows if it is 'bad' or 'not bad' in a particular case without any error and not even the least error.

So where is that data based upon which a person can be declared to be guilty or not guilty. There is only one place and that is 'brain' of the person. In the brain of the attacker, it would be registered that he wanted to kill the other person and in the brain of other person, it would be registered that it is innocent and killed the attacker to safeguard itself. As mentioned earlier also, human is born with some programmes written in its brain. As it grows up, the programmes get enhanced with data but the results of these basic programmes keep on guiding the brain. One programme which has been mentioned earlier is the feel of insecurity. Other programme which evidently exist in human brain is judging its own actions, thoughts and inclinations. If we know that not every person is doing murder, rape and other crimes, it is because of the prominence of this programme in the brain. If the

real world is largely peaceful, cohesive and responsive, it is because of the prominence of the fact that self-assessment and judgement about someone's own actions, keep he/she guiding about the actions one has to indulge into. However, this can be taken on temporarily by other short term actions like actions emerging from anger, aggression, violence which are the result of prime programme of insecurity and may look as if the programme of self-assessment has disappeared or lost. But it is not so. Under any circumstances including anger, violence also, the programme keeps running in the background and always the subject person would be well aware of its actions being correct or incorrect. The definition of correctness may make their self-assessment subjective, but when the brain is at rest and absolute away from emotional drifts it would confess to its own self regarding the correctness of its actions or otherwise. Largely, it will be true to human. However, a particular environment continuously a human is exposed to, may apparently change the outlook or mindset of the person. For example if a person is exposed to the working and norms of a particular religion say REMS1 it would tend to believe that norms of REMS1 are supreme and after getting into the mindset of superiority, the person would start considering the norms of other religion REMS2 as incorrect. Interestingly, the person neither would have reasons to establish the REMS1 norms to be supreme nor have logic for establishing the REMS2 norms as inferior and incorrect.

This will happen because the person has just perceptions, unvalidated and unsubstantiated. Therefore, if a person is declaring something as 'best' or the 'worst' without DAVM facts, the person has its programme of self-assessment taken over by emotions and unestablished beliefs. But even then, the person would not remain in the fray of criticizing REMS2 all the time, and when not doing it, its brain is settled, unattached, it would obviously be equidistant from REMS1 and REMS2 and then its brain would exercise self-assessment about what it did. If it was not so the person aligned to REMS1 would not talk to people of REMS2, would not meet the people of the REMS2. However, a person born in the strong environment of REMS-1 would get extreme exposure of REMS-1 norms and may form such perceptions of REMS2 being incorrect because of its underdeveloped brain with restricted and limited exposure and inputs from the environment and its self-assessment attribute would turn into becoming rigid, obstinate and the person may relate its existence with the religion REMS1. In that case its self-assessment attribute can be made active by asking to correlate its norms and actions with DAVM facts and he/she would fail as its whole mind set is driven by perceptions. If it would be exposed to the strong environment of REMS2, it would realize the goodness of REMS2 and also unacceptable terms of REMS1.

However, coming back to the discussions that human has inbuilt programme of self-assessment of its actions in its brain, even if a person in general, has done irregular, it would have feel of regret irrespective of REMS may claim that divine superpower God is maintaining account of 'goods and bads' done by a person, the data regarding this would be available in the brain only. Whether God picks up from there or not, is irrelevant because such facts at rest in the brain is the reality. So this part of the brain preserving such data when overtakes, the passive functions of brain, like sleeping or at solace away from live happenings, the person would assess and realize its actions being 'good or bad' or 'how much good' or 'how much bad'.

The human brain capacity may happen to be insufficient to maintain data of whole life and each day. It is so. It is like RAM that fresh data and experiences come in and those which are old goes out. Use of term 'old' may not be correct but the floating data we may call it, which is the one not having touched and retrieved by conscious brain for quite some time. The brain would store old data even of childhood which the person keeps on remembering and recollecting in between. Say for example, after the trip one may remember the places which were visited, for long, as these keep on coming to the conscious brain in between. But one would not remember the vehicle number or phone number

of the driver or the guide as the brain would not have retrieved these details for long after the visit. So when the unusual happening being referred to, these will stay in brain as person would often remember it recollecting it, talking to someone and 'bad deeds' by a person are unusual and uncommon and thus stays in brain. This is an explanation to the myth by REMS that some person seen by someone in dreams or while unconscious that he was keeping a register with details of deeds and misdeeds by the person. In fact, if we apply REMS logic, as narrated in myths and by REMS, there is no need for any super-naturals to maintain details of good deeds as the quantum/size of bad deeds decides about the soul. And misdeeds would stay in the brain as explained above.

There are hundreds and thousands of actions anyone would perform in life and it would be just impossible even to define each activity as good or bad or how much good or how much bad. As this is the potential field for REMS to intrude into everybody's life with intents to define 'good or bad'. Being just impossible to define each activity with weightage of correctness and incorrectness, REMS would use their own term of reference to define anything as 'bad' or anything as 'good'. Their narrations in the form of decisions by REMS are also subjective to the knowledge and genuinity of intentions of different REMS and as such different REMS will have varied assessment-interpretations regarding 'good' or 'bad' and even claim of an REMS for some action as bad, might be termed as acceptable by the other REMS. The varying social practices of different societies exhibit this variation as the practices considered as bad by one society are being accepted and practiced by the other society liberally. And REMS of each society supports the practices followed by the society and therefore, REMS opinion and assertion regarding good or bad are not absolute and true. And then further the proclamation of 'good and bad' corresponds to the prevailing circumstances also as mentioned earlier and only the self undergoing those circumstances knows well if the action was bad or an act emerging out of certain compulsions and thus not recognizable as bad. There are various examples. In certain countries, in the past, there was a norm that after death of a person, the wife was burnt alive with the dead body which was supported by the REMS at that time but in the present it is unlawful.

Therefore, REMS opinion, point of view is not absolute and truth and even may go against humanity. When it is so, the interpretation of myths, stories of the past by REMS cannot be considered as universal and true. REMS stressing their point of views on the people for compliance, is not at all desirable and if REMS succeeds, the people would become incapable of making their self judgement regarding their actions and the society will turn into a crippled and incapable society.

Quickly referring back to Government and Governance, the insincere GPP, who does not want the society and the nation to progress at par with others and does not want the people to become empowered with real knowledge, rational thinking and analytics attributes, would certainly use REMS as the means to make the people and the society low self-reliant, low intelligent and low self-confident and thus the people would turn into slavery mode which insincere GPP would always prefer to happen. Thus prominence of REMS in society would directly corelate to the insincerity of GPP.

Coming back to defining 'good or bad', it must be understood that REMS is no one to specify the 'good and bad' in a manner that it is stressed to be followed by everyone. However, if REMS and GPP wants that the opinion of REMS should become mandatory, it would introduce two dimensions (1) the existence of supernaturals REMS may term as God and other (2) the REMS would scare the people that he/she knows the God well, agents, and whatever they say, are the wishes of the God and anyone not listening to REMS would face the 'curse' of the God.

Therefore, the supernaturals, God, would become the term of reference by REMS. The first action by REMS would be to make the people to comply to certain norms, procedures, which REMS would bring up as the desire of the God and thus to be followed. And the norms, procedures, would be based upon old mythology, claiming the same to be the words of supernatural and mandatory for compliance. The narrations, lyrics, poems, songs, speech, concert, music would be made by REMS to surround the people to influence their brain and mindset as the 'human senses' of a person feeds to brain and over stating of anything, if occupy the brain much in terms of time, the brain start acting the same way. When one is driving, the brain is thinking about driving, but it is for a short period. But if it is driving is long term, the person would start praying the act of driving as the means supporting him/her for driving. For example, if driving is long term, imparting substantial occupancy of brain, the person would start praying the vehicle and getting scared about its wellness almost as it would do in the case of his/her near and dear the loved ones.

So long term exposure of 'senses' (thus brain) to anything like myths, supernatural in songs, music concert, rhythms, pulls the brain activeness towards the same. It goes a long way to make people scared of supernaturals, scared of REMS, scared of anything done by them against what REMS says presuming to be against the supernatural and people would become apprehensive, timid and 'slave like'. And for long exposures to the activities making supernaturals happy as presented by REMS, would be an act explicitly visible to others showcasing the persons surrender to supernatural. And it will be prayers. Now prayer can be done by an individual in solace but it would not benefit the REMS. How REMS would turn it into an arena of social coronation, adoption of the prayers and REMS presentations of mythology, past stories as the course of life for all the people to widen the grip of REMS on people. The prayers in 'solace' by individuals would not help REMS to widen its grip and clutches but if REMS makes and establish and identify the place where the people should come and offer prayers, it will be mandatory for the people to visit the place to offer prayers. And now the prayers of each one are visible to all others and the philosophy, ideology of REMS would spread very fast. But why the people would visit the place? REMS would have the answer by installing the supernatural in some form in that place or the house. The form in which REMS would install the supernatural, shall vary in shape, size, color, appearance, presentation, stature etc. as the supernatural's details are not identifiable even by REMS with visible substantiation, as REMS has also neither seen nor met the supernatural. Therefore, the physical correctness, accuracy and presentation depiction cannot be determined by REMS and the only way is just to install a belief that; it is supernatural and to be worshipped. And REMS even without doing anything would become more and more recognized, powerful as more and more people would visit such place.

What would be the reasons for belief in superpower? REMS would stress and people would start believing that the objectives which would come true with such belief are the assured welfare, protection from bad time and bad omen. The belief that the supernatural would just keep a watch that nothing 'bad happens' to the person and its dear ones. As explained earlier, the time is most powerful and supreme and beyond the control of supernatural and thus good times and bad times are beyond the control of supernatural. As mentioned earlier the 'bad time' occur due to destiny which would not be alterable even by supernatural. The term destiny itself is elusive and aberrated. If it is said that something was his/her destiny, it would have been known or laid down somewhere and should have been known to the concerned person or its close ones or written somewhere which could be referenced later to ascertain that whatever happened was the destiny and was to happen. However, no one knows about what is going to happen next not laid down or written anywhere. So how it can be referred to as destiny. And destiny implies that the happening was predefined, preprogrammed in the life and therefore, it was to happen. But as explained above, any happening before it happens and comes in life, is not known previously and also not evidenced to be pre-

written somewhere. Therefore, the term 'destiny' is elusive and unclear. Mainly the term destiny is used to dissolve the serious review by a person about its actions and visualization and to relieve its own self from the guilt of failure. And for a review of own actions, one must have reasonably intelligent brain. Therefore, the use of destiny shall be prevailing in people who are not educated, analytical and intelligent

Of course, the above explanation will not apply to the eventualities arising out of the natural disasters which happens without previous understanding of the mishappening and consequences just fall upon the people to be faced.

Obviously the actions and visualization with analysis can enable to assess the 'good or bad' effects of own actions and largely can overrule the term 'destiny'. though it is agreed that sudden happenings do happen. Therefore, the supernatural cannot be associated with good and advanced management and/or curtailment of destiny and only those who do not possess the attributes of analysis and intelligence would resort to the term destiny and to bypass the accountability of self-actions.

So, the term destiny applies to natural disasters and its resultant bad results as it is not under the control of supernatural. Though, with the hope that some power (supernatural power) will prevent the mishappening of natural disasters, human conceive the 'supernatural' but whether it really helps? Because the natural disasters keep on occurring in spite of all the prayers being offered to supernatural. on the other hand, many disasters, other than earthquake, would be avoidable or manageable with timely application of acumen knowledge and intelligence. However, REMS having two options that either these to be identified as avoidable and apply human analytical knowledge for prevention or promote these as the anger of supernatural (for anything) and make the people to worship. And REMS has already presented itself as the 'supernatural's envoy'. So REMS will adopt the later.

So, the term destiny is not associated to supernatural as neither they create it nor visibly help in managing it.

However, the term will be commonly used by incapable GPP and promoting the placement of supernatural in common people's lives mentioning that the supernatural would safeguard people from the bad consequences of destiny and the supernatural only can save them. The incapable GPP will disown the consequences of its bad actions and throw upon the destiny for which GPP is responsible.

So what we discussed is that the time is most powerful, continuously changing everything in the world and is not controllable by the supernatural also. This is inevitable and the absolute truth.

We also concluded above that any bad happening with anyone cannot be said as destiny once it has already happened. It can be termed as destiny only before its occurrence, which never happens. So the use of expression like destiny is vague, undefined, irrelevant and used by those who are not intelligent and analytical. Use especially by GPP will be fraudulence and overlooking its own accountabilities.

Coming back to REMS, the REMS would install such expressions like destiny to scare the people to stress that there is some undesirable which is bound to happen in future without assigning any analysis reasoning and substantiation. Making the people scared about 'bad future' is the easiest as future is unknown and any person with basic programme of insecurity in brain, would easily get scared. The REMS would now be able to project worshipping the supernatural would set the bad future right

Its again to recollect that as reasoned above in the discussions, the bad future is bad time and time is not controllable by supernatural.

But if the people adopt this conclusion, the REMS identity will diffuse. It will be necessary for REMS to highlight that if people would not pray to the supernatural, the supernatural in turns would punish the people by putting them in troubles. So REMS would convert the supernatural from the image of a friend, well-wisher, impartial Guardian; a positive image; to the image of an entity carrying hatred (for selected) and/or love (for selected), selfish, worrying about it's interest, and carrying anger to punish the people. And this is a 'negative image'. There is no doubt that a supernatural, if it is there, would be the one caring and helping the people but the REMS for fortifying its existence and authority, would hypothetically turn the supernatural into aggression and anger and retaliation. REMS would further aggravate its point of view by associating harmful equipment weapons, magic and superpowers, to punish people etc and convert the supernatural into a negative and selfish entity to fulfil its own selfish aspirations fulfilled. it will be a universal derivation that a supernatural having unlimited powers should not be a subversive role because (1) it does not need to suppress or oppress the people as its function is welfare (2) it does not need any weapons with it as its existence and its mystic powers would be used to prevent any possible attack or threat if any. To justify weapons with supernatural, the REMS will have to create set of entity highly negative suppressive causing harassment and distress and to justify the weapons with supernatural, these will be stated to be equally powerful compared to supernatural. REMS would contradict their own belief about supernatural and curtail their status by conceiving wickeds powerful at par with supernatural and to accept such lame and contradictory presentation, the REMS will only look for a base of low intelligent people. With weapons adorning supernatural and also weapons with anti-supernatural, REMS will have to make stories of their fight, consequences and so on. The stories, myth will have to conclude the supernatural as winner obviously to impress upon the people to bow their heads to supernatural or else, REMS would proclaim, people would face untoward consequences. The REMS would tend to turn the whole human masses into a slave mindset living under apprehensions that supernatural may become unhappy and further advising people about procdures to be followed to make the supernatural happy.

And REMS has now changed the character of supernatural. Supernatural do not remain compassionate, merciful, impartial for everyone and REMS would turn it into an entity just opposite. And REMS would play on the ground that only he can make the supernatural happy and thus people should worship them. And there will be no dimensionally identifiable supernatural supported by DAVM substantiation and such unsubstantiated supernatural shall be made live by REMS through stories, songs, concerts and for making an unidentified invisible entity real, the concept to be implanted into brains as beliefs.

And for all this to happen and come true, REMS would conceive a low intelligent, low educated and low analytical mass of people or else the people would not believe to the stories, songs, myths evaluating those on analytical grounds. REMS though may try to keep the people low intelligent by defining the education differently from what is evolving out of the progression of time, viz education based upon latest concepts, hypothesis, theorems, derivations. REMS would advocate education which has no linkage with the 'progression of time' but would link to what was in the past, the opposite of 'progression of time'. The people will have to be the one looking backward if they are not permitted to look forward towards time progression. It may not be a wonder that REMS would make people to look backward, adopt education of past, livelihood of past, but would adopt the modern and progressive ideology for their own self, family and near and dears.

We have talked about the scare of 'bad future' and this would occur in people as normal happening and brought out that it is non addressable and non-repairable even by supernatural. We know that every happening in a particular set of circumstances has a probability of occurrence which can be estimated with mathematical analysis. However, mathematics is a modern science and REMS has no inclination of such analysis to be adopted by people.

REMS therefore, would link such occurrences with other omens or bad-omens, date, place one belongs to or other timings, direction, planet, person's body parts, look etc. All these factors and parameters will differ largely so that common person is not able to correlate happenings with all such varying parameters and REMS is able to define any happening to be result of any combination of these parameters as above. Different REMS will have different interpretations of correlation of these parameters. There is a probability of any happening under certain circumstances and particular set of above parameters may therefore, correspond to a particular happening and by virtue of experiencing such correlation between happening and set of parameters, it would be easy to work out certain predictions and REMS would use such tactic not only to influence the people but also establishing themselves as the foreteller and thus possessing an extraordinary link with the supernatural.

However, it will be an analysis, rather mathematical analysis based upon the derivations of 'probability' to understand 'probability' one simple example may be quoted that in a closed box having same number of black balls and white balls if the balls are picked one by one, both black and white balls will have equal probability of 50% for being picked up. Now changing some parameter, like having bigger white balls than black, the probability of white balls getting picked will increase. Similarly if black balls are placed close to the reach of the hand, the probability of getting black balls picked up will be higher than the white balls getting picked up. REMS shall just present such parameters in terms of planet, place, time, direction, posture etc and come up as a foreteller. Again to keep some such tactics hidden REMS will again require a base of low intelligent people. It should be noted that insincere GPP would also keep such intention in mind and coalition of REMS and GPP would always signify insincere GPP.

To understand more clearly how analysis of facts and happening help in digging out the hidden realities another example is deliberated. A middle-aged person goes to the 'foreteller' and expresses that he needs his help. The status is learnt by foreteller that he is in business, married, having children (or no child). From the look, the foreteller will just pick if is shaky or straightforward hesitant to discuss or discussing freely, wearing gold/diamond etc. Now the person has come alone without family members, so coming for 'personal matter'. Without wife means either he has some extra-marital matter or something related to wife (or children). If related to wife, the foreteller will need details of 'wife' which 'husband' may not be having. If related to children, the guy would have come with wife. So, he has come for his personal matter. If straight forward, it will be for business or loss or prospective business proposal or if shaky, it is 'extramarital'. This will be more probable if the person is not having child, or if wife sick, or if children are away. The foreteller will just hint out that 'if someone looks more attractive to him' and rest the person will tell under the understanding that 'foreteller has seen everything' without telling. This is how the brain of a person is captured, just by using 'common sense'.

The REMS having inclination of entrapping the people in fictions, hypothesis, stories, would now have to measure the extent to which people have gone down with the beliefs installed by them and have stopped looking forward and started looking backward. A simple measurement will be to assess their incapability to analyze and think. The simple example is, if it is day and the person is told that it is night and the person agrees, he or she is 100% incapable to evaluate and analyze. Therefore,

if the person is told about some person being 'supernatural' and if it is supernatural is standing in front, the person is 0% incapable. But now if something else stone or a particle or some other object is said to be 'supernatural', the extent to which the person would believe, would indicate the level of his/ her incapability and extent of its brain being passive, non-analytical, non-thinking. Also the REMS would put unsubstantiated restrictions and the extent of compliance by people without questioning the justification, would again present their passive and non-analytical brain to REMS. The REMS may present cleanliness as a requirement for REMS actions, worship etc, and the parameters of cleanliness may be specified as cleaning body wash, bath etc. The most dirty things would be the stool and urine and there is no time when stool and urine are not in the body. And therefore, a person would never be fit for worship, prayers, in this respect. Even REMS would never be fit for REMS acts in this respect. But if people do not question and just comply to REMS, they have passive and inactive brain, which REMS ultimately would desire to happen. If the brain is still not fully passive, the REMS would influence it by presenting others who are complying to them, making exaggerated and hyper presentations by high noise, rhythms, synchronized hypnotizing actions, loud music etc, to make the active brain; inactive for viewing anything outside the sphere of what REMS says.

Now there are three entities the supernatural, most powerful; REMS the representative of supernatural and the people. And REMS viewpoint is that the supernatural to be worshipped as it would make the supernatural happy and the happiness would correspond to the welfare of individual. But when the supernatural stated so. The REMS may present some literature as the statement of the supernatural, but no one would have ever seen supernatural telling it. The REMS would certainly refer to the past that supernatural said it in the past, no one can visit past to verify.

REMS would suggest the people to worship the supernatural through REMS claiming that they are the representatives of the supernatural and their actions and methodologies can only create link between the people and the supernatural. The acceptance of this would only depend upon one attribute. The level of insecurity a person possesses. As individual, this will correspond to the low educated and poor masses who are already short of caliber and potential to create their space and worth. Lacks confidence to earn respect and recognition in the society. Some categories facing uncertainties in life, those who are ill or those who are in business where there is possible large variation of earnings at different times or business where uncertainty can lead to big losses, would also have inclination towards the act of worshipping say WOR. However, the REMS would be able to influence each individual to worship the supernatural by creating a belief that supernatural is the Godfather, the one who created them. If such belief is implanted in the brain of people, the act of worshipping will also get implanted simultaneously. As an object will always be thankful to the creator as if it was not done by the creator, the existence of object would not have occurred. Human have brain which has capacity to produce programmes and generating beliefs is also a programme. But there are hundreds and thousands of other creatures, other forms of life and they have very limited potential of developing programmes in their brains. They live in their specified sphere and vanish. They do not have programmes of rational, logic, correct and incorrect. And they spend whole life just dealing with their survival. They do not need to pray or go to a place asking for their welfare as their sphere of living is well defined. They have to harm others for their survival and they have well defined predators and enemies. And there is no one to save them from these predators and enemies. They do not have any social status as there is no society and they all live as an individual. The predators and enemies are always more powerful than them and there is no supernatural to save them or to make them equally powerful at least. They live short life which is certain to be short and therefore, do not incline to worship any supernatural. They have little brain and whatever body parts they have arms, legs, jaws neck, everything is designed to sustain their survival, till the life ends. Their physical identity is linked to their race and no supernatural can convert a frog into a bull or small fish to a whale. So these creatures are governed by well set rules of living and as nothing is going to change it. They have not developed programme to worship supernatural as there are no REMS either. So, they are born, live and die and do not need a religion or REMS.

In case of human, we have a brain which has capacity to generate the programmes, takes feedback from the environment using senses, makes programmes and execute. Human brain has a programme of aspirations which always look for changing life for better livelihood and when the betterment is not realized the human brain look for its support. As the programme of aspirations is in the brain and when the results are not conforming to what was desired by the brain, the human brain look for a support inside the brain only, in the form of a belief, and a programme that supernatural is there to help. Thus, the REMS comes into existence. However, the most interesting fact here is that human brain would conceive supernatural with aspirations of changing life for betterment; better livelihood; better rise and growth, the REMS would now suggest that the human should not believe in such view point and notion.

It may be astonishing but REMS knows very well that if human brain will start moving forward, aligned with the progression of time, the REMS ideology will die that is, the ideology of making the people to look backward. It is a compulsion for REMS to make people to look backward and go to the past as explained in previous section, as the supernatural are in myths, stories and tales and it is not possible to extract the supernatural from tales and myths and present to the people today.

If REMS would not present a belief that supernatural created human brain and human body, it will be almost impossible for REMS to explain as to how human brain and body came to existence. REMS has no option except to correlate existence of human life as creation of supernatural, for which it will be necessary to take the people to the past, create myths, tales due to inability of creating and reproducing the supernatural in current phase of life.

It should be well understood that the past, wherever is mentioned and referred to, is the unforeseen past which is quite long back in time and no written and photographic or drawn record of that time and evidence is available placed on the timeline. This is unreachable past. The past which is foreseeable and evidenced with text, written and drawn, photographic evidence, is the 'reachable past' which is not referred to here. Therefore, REMS would relate the human body and thinking as the creation of supernatural as an attempt to put human under moral obligations to respect and pray the supernatural since stated to be the creator.

Now, the question which comes up is 'if supernatural created the human body and brain', why supernatural designed a brain with capability to develop programmes. The supernatural would have created a brain only with one programme of 'worshipping the supernatural' and that is it. Why the supernatural would provide senses eyes, ears, mouth etc which would collect details and data from environment and keep changing the programmes in the brain? Why the parts like hands, arms, legs etc provided and rather human body could have been created by supernatural like a 'paperweight' without eyes, ears, arms, legs and active brain and the human would have remained stationary at one place, would have lived there for whole life, just praying and worshipping the supernatural and die. Why supernatural provided all these senses and organs to move and constructed brain to redevelop programmes, which all the way causing biggest obstructions in the endeavor of REMS for universalizing worshipping and prayers by the people? So the REMS hypothesis becomes utterly contradictory and for acceptance of such contradictions as evidenced earlier also, the REMS would tend to ensure that human masses are low intelligent and possess low knowledge base, having impaired reasoning and blurred vision for planning and progression.

As mentioned earlier, GPP driven by REMS hypothesis, would tend to make the common people low intelligent and low educated 'in the educational spheres which are evolving from the progression of time'. So, the human body and brain do not seem to be created by supernatural who are in tales, myths and for whom REMS wants to install the mindset of prayers and worshipping and for whom its happiness or unhappiness can be related to the prayers and worship by the human.
